### HC asks govt not to arrest, harass Shanta

BDNEWS, Dhaka

The High Court (HC) yesterday asked the government not to arrest or harass Advocate Shahin Sultana Shanta in any case in 48 hours of the court order upon a writ petition

Shanta was tortured and injured by police during opposition's March 12 programme to lay a siege to the Election Commission (EC) office.

A division bench comprising Justice Awlad Ali and Justice Zinat Ara gave the order after Shanta filed the petition seeking compensation for police attack on her and submission of investigation report on the incident to the High Court.

The hearing on the writ petition will be held today.

On March 22, two separate cases were filed with the Chief Metropolitan Magistrate's Court (CMM), Dhaka, against Shanta and

Amid a swirl of conflicting versions of the events late Sunday, the US military said Iraqi special forces raided a meeting hall in northeast Baghdad being used by an insurgent cell and killed 16 people and detained 18 others.

Accounts of the evening raid in Baghdad varied. Aides to the Shia

cleric Muqtada al-Sadr and Iraqi police both said it took place at a mosque, with police claiming 22 bystanders died and al-Sadr's aides saying 18 innocent men were killed.

The Americans said Iraqi special forces backed by US troops killed 16 insurgents in a raid on a community meeting hall after gunmen opened fire on approaching troops. Iraqi television showed images

of blood stained corpses inside a Shia prayer hall with most of the dead appearing to be elderly. Their identity cards proclaimed them to be members of prominent Shia politica

# Kamal blasts govt for politicisation of administration

Convenor of Jatiya Oikya Mancha Dr Kamal Hossain accused the government of violating the constitution through indiscriminate politicisation of administration.

At a meeting on Independence Day organised by the city Bikalpa Dhara Bangladesh (BDB) at the Jatiya Press Club auditorium yesterday, Dr Kamal, also one of the architects of Bangladesh Constitution, said the government has politicised different state institutions including the Public Service Commission (PSC) for its gains.

The martyrs sacrificed their lives for establishing a non-communal, poverty free and democratic country, but even 35 years after the

liberation their dream has not been realised, Dr Kamal, also the president of Gono Forum, said.

Those who are in the power at present have destroyed the law and order in the country, undermining the dreams of liberation, he added.

Regarding the issue of militancy Dr Kamal said the BNP-Jamaat coalition government should apologise to the journalists for accusing them of circulating falsehood instead of taking timely measures to check the Islamist militancy. Accusing the BNP-Jamaat

## Thaksin's frantic offer for nat'l govt rejected

Opponents of Thailand's embattled Prime Minister Thaksin Shinawatra yesterday rejected his offer to form a national unity government if he wins troubled elections next weekend.

Their decision came as political tensions soared, with a one-kilo (two-pound) box of explosives found outside the Democrat Party headquarters and a new warning from election officials that Sunday's polls may not produce a parliament. Democrat leader Abhisit Vejjajiva

said Thaksin's offer to rivals to join his government did not address their demands for constitutional reforms and for an independent investigation into claims of corruption and abuse of power by the "Thaksin's offer does not

respond to the demands of the Thai. public and the political parties. Abhisit said.

the Thai people more confused

about the situation in order to buy time for his political career," he said.

Abhisit said the three opposition parties would stick to their boycott of Sunday's election, and would stand by their appeal for Thaksin to resign so the nation's highly influential king could appoint an interim govern-

### Hamas ready for int'l ME peace push

Incoming Palestinian prime minister Ismail Haniya pledged yesterday his Hamas government would spare no effort in striving for peace in the Middle East as MPs prepared to approve his cabinet line-up.

Haniya, whose Islamist movement has been behind dozens of suicide attacks during a five-year uprising, insisted the Palestinian people had the right to continue their "struggle" for independence but stressed his desire to enter negotiations with the international community to end the conflict with Israel.

And he also urged the United States, which considers Hamas a terrorist organisation, to alter its stance towards the Palestinians while rejecting threats by Washington and Brussels to slash SEE PAGE 15 COL 7
