Equip youths to remove poverty

Prof Yunus distributes Grameen Bank higher education loan in Tangail

Prof Mohammad Yunus has said the young generation has to take the responsibility to remove poverty and illiteracy from society. For that, they should be properly equipped with knowledge and expertise.

He was speaking as chief guest at a function organised to distribute Grameen Bank higher education loan to 12 students of Government Saadat College at Karatia in Tangail on Saturday.

Prof. Yunus, Managing Director of Grameed Bank (GB) said many poor talents in the country are forced to stop education only for want of money. Soft loans can help build their career as well as change the society. Education loans on easy terms can

also be introduced by other banks and financing institutions, he said.

their needs Repayment of the loans bearing 5 per cent interest rate will start after completion of their academic period. The interest will be waived if they can repay the loan before end of their academic period, according to GB sources here.

1,000 homeless in **Bogra tornado**

About 1,000 tornado-hit people of three villages in Dhunat upazila are passing their days in great misery under the open sky for the last three

Dhunat Upazila Project Implementation Officer (PIO) Azher Ali Mondol said 140 families were rendered homeless in the devastating tornado that lashed the villages Friday evening

Houses of 110 families were totally destroyed at Madhabdanga village while 13 families lost all their belongings at Banderbari village and another 17 families lost their houses


at Bhutbari village, he said. Bogra Deputy Commissioner (DC) Abdul Mannan said the administration distributed Tk 70,000 as house building grant among the tornado victims of Madhabdanga,

Bhutbari and Bhanderbari villages. He said the government also distributed 30 kilogram (kg) of rice to each

tornado-hit family Maize on over 506 acres of land, paddy on 250 acres of land and vegetable on 10 acres of land were

totally damaged in the three villages. Laily Begum, a tornado victim, said her two-room house was totally destroyed. She is now living with her children under the open sky. Describing the severity of tornado, she said her house was flown away

like a paper. While visiting Bhutbari and Madabdanga villages this correspondent found that the houses were raged to the ground completely. There were only heaps of ruble everywhere in the two villages

Govt out to shirk reforms fearing polls defeat: AL

The government is reluctant to reform the caretaker system and the Election Commission as it knows it will not retain power if the next general election is held in a free and fair manner, said Awami League (AL) central leader and former minister Talukdar Abdul Khalegue MP.

"So, they have adopted a dilly-dally tactics and looking for pleas to thwart Awami League's demand for reforms", he told a public meeting at Shyamnagar KB High School ground yesterday, organised by the local AL

He reiterated that there will be no election without reforms

Khaleque claimed that Islamist militant organisations Jamaatul Mujahideen, Bangladesh (JMB) and Jagrata Muslim Janata Bangladesh (JMJB) are creations of Jamaat-e-Islami, a partner in the ruling coalition.

When newspapers reported violence and killings by militants earlier Jamaat leaders denied their existence, saying they were creation of the media.

Now they are trying to befool the

people by saying that the party has no ink with militants. Khalegue said.

"Analysis of their (Jamaat leaders) statements made at different times will prove everything", he said.

The militants were let loose to blast bombs and create anarchy in the country as part of a conspiracy to blame the opposition and fish in troubled waters, the former minister

"Those who try to divide the society using religion are real enemies of the country", he added.

Khaleque also came down heavily on the government for its alleged failure to ensure power and fertiliser to farmers during the peak season of

IRRI-Boro cultivation. "In Kansat, 14 people were killed just for demanding uninterrupted power supply. This is unthinkable in a civilised society".

The ruling parties want to perpetuate power by utilising party cadres and law enforcers, he alleged and called upon the people to unite and intensify the agitation to topple the 'failed government'.
