\$93.6m fighters turn \$117.9m

Opposition smells a rat in discrepant claims of price; Hafiz Uddin unsure now about his earlier written statement in parliament

The 16 fighter planes, first claimed to have been purchased for \$93.6 million from China, are now revealed to be costlier by \$24.3 million, kicking up controversy over the defence purchase.

The air force headquarters in a report placed to the parliamentary standing committee on defence ministry yesterday said the fighters have been priced at \$117.9 million, a figure substantially higher from what had been claimed in February in parliament.

Water Resources Minister Hafiz Uddin Ahmed, who is also in charge of the defence ministry in parliamentary affairs, on February

22 informed the Jatiya Sangsad that the government in the fiscal year 2004-05 had signed an agreement with China to procure 16 fighter planes at a cost of \$93.6 million.

He said this in a written reply to a lawmaker's question.

Referring to the discrepancy in the prices, Hafiz Uddin last night told The Daily Star, "I can't remember exactly what I said in parliament. The ministries concerned usually prepare the answers we place in parliament. And sometimes we are too busy to verify

The minister however said he will confirm what he had actually said about the purchase after examining the official documents.

The air force chief who placed the report to the parliamentary body said the negotiations concerning the procurement were confined to the governments of Bangladesh and China

But the main opposition Awami League (AL) lawmaker claimed that a third party must have been involved in the process and pocketed a huge commission from the

"I am sure a third party was between the two sides and took commission from the procurement," AL lawmaker Col (retired) Shawkat Ali told reporters after the

20 journos hurt in cop attack at Ctg stadium

Cricket took a back seat on the opening day of the second Test between Bangladesh and Australia as police swung into an uncalled for action against the on-duty journalists, injuring at least 20 media-men of different national dailies and satellite televisions at the Chittagong Divisional Stadium yesterday.

Of the injured, Anurup Titu of Dainik Purbokon was admitted with a serious head injury to the Royal Hospital and underwent a surgery after CT scan in the afternoon. His condition was learned to be critical.

Two more journalists, Ruhul Amin Rana of Jai Jai Din and Rabi Shankar of Ajker Kagoj were also wounded and were taken to the hospital for treatment.

Trouble brewed in the morning when in an unprecedented incident in international cricket the

start of play was delayed by ten minutes due to a sit-in protest by on-duty journalists in the middle of the ground for merciless beating of fellow photojournalist Shamsul Haq Tanku of Bengali daily Prothom Alo.

However, that incident at the entrance of the stadium in the morning was only the tip of the

Scenes of pandemonium envel-oped the field of play during the lunch break as the police led by DC (Port) Ali Akbar set themselves upon journalists, who were demanding unconditional apology from Sergeant Anwar -- the man in uniform responsible for beating up Tanku in the morning.

The assault for a second time started as Akbar suddenly punched veteran photojournalist Jahirul Haque on his face and kicked him continually. As Jahirul fell down on the ground, the cops became more

AL sends names of 5 representatives

BNP to respond soon

The Awami League-led 14-party opposition combine yesterday sent a letter to the BNP secretary general, naming its five representatives and asking him to form the proposed 10-member committee to discuss electoral reforms.

Receiving the letter at 7:05pm. BNP Secretary General and LGRD and Cooperatives Minister Abdul Mannan Bhuiyan thanked the Awami League (AL) for its quick response. "We will respond as soon as possible after reading the letter and discussing it with the party chief and other leaders," he said.

The five AL Presidium members nominated for the 10-member committee are Tofail Ahmed, Abdul Jalil MP, Suranjit Sengupta MP, Sheikh Fazlul Karim Selim MP and Kazi Zafrullah MP.

The AL in its letter said it agrees with Bhuiyan that the content of the dialogue should be limited to

the opposition's reform proposals for a free and neutral parliamentary election. And it is for that reason that "we have urged to form the committee with members from the AL and the BNP on behalf of the 14-party and four-party respectively so that fundamentalist forces...which have created pro-found crisis for the democracy and existence of the state cannot create any complexity in the discussion,

"We are committed to the 14-party for the content and decision of the discussion. Similarly you should not have any problem to take responsibility of the discussion on behalf of the four-party," the letter signed by AL Acting General Secretary Obaidul Quader reads. "We hope that you will not include any name in the committee that may hamper the dialogue,




