Make 427 MPs pay their unpaid phone bills

HC directs BTTB to take action against them as per law

STAFF CORRESPONDENT

The High Court (HC) yesterday directed Bangladesh Telegraph and Telephone Board (BTTB) to realise within six months arrear telephone bills totalling around Tk 6 crore from 427 members of the fifth and the seventh parliaments

If the MPs fail to pay the arrears, the authorities should take action against them as per law. However high and mighty they may be, no one is above the law of the land, the HC said in its verdict.

Many of these MPs owe the BTTB more than Tk 1 lakh each in arrear bills and many others a few thousand taka each

Lawmakers of the seventh

parliament left arrears totalling Tk 3.09 crore and those of the fifth Tk 3.75 crore until March 2001.

The HC verdict came as a result of a May 2001 writ petition filed by Bangladesh Legal Aid Services Trust (Blast).

Soon after the petition, the HC had issued a rule on the BTTB and other related authorities to show cause as to why they should not be directed to take proper steps to recover arrear telephone bills from the MPs in accordance with law.

Th court had also directed the authorities to certify and submit a list of the defaulting members of the fifth and seventh parliaments mentioning the year-wise dues from each within four weeks of the date of

These directives followed lengthy hearings.

The HC yesterday gave its verdict along with an eight-point observation.

These observations are: Bandladesh is a sovereign democratic republic and governed by the government of laws and not of men.

The people of Bangladesh are the owners of the state, and all functionaries and members of all services must serve their cause and only in their interest

The law is not a respecter of persons, it does not discriminate between the ordinary citizens and functionaries of the state, however high and mighty they may be.

The privileges of the functionaries of the state are allowed not because they occupy exalted and high positions but allowed so that they can perform their functions better in the interests of the people.

Provision of district ministers illegal

HC issues rule

The High Court (HC) yesterday declared the government's provision of ministers in-charge of districts illegal and unconstitutional.

The verdict came following long sessions of hearing over the last year of the rule of a writ petition filed on May 17, 2003 by Anwar Hossain Moniu, lawmaker and chairman of a Jativa Party faction

The writ challenged the constitutional validity of the government notification dated November 12. 2001 that empowered ministers and others with charges of different work and law and order.

The Cabinet Division issued the gazette notification appointing 62 cabinet ministers, advisers to ministries, chief whip, state ministers, whips and deputy ministers to discharge additional responsibilities and charges in 62 districts to look after overall development and law and order situation. On May 18, 2003, an HC division

bench of Justice Abdur Rashid and Justice Siddigur Rahman Miah served a notice on the government asking it to explain why delegating ministers, state ministers, deputy ministers, chief whip and whips districts to take care of development charge of 62 districts would not be

declared illegal. The court gave the government two weeks' time to

An HC division bench comprising Justice ABM Khairul Huq and Justice ATM Fazle Kabir delivered the verdict yesterday, declaring the government provision illegal. During the hearing of the case.

Another walkout from Business Advisory Committee as BNP refuses discussions on 'burning' issues

Awami League (AL) yesterday walked out of the House protesting the Speaker's refusal to include the names of the people killed in police firing during the Kansat movement in an obituary reference adopted at the beginning of the session.

The main opposition staged another stormy walkout 50 minutes ago from the Business Advisory

business and session duration. protesting the ruling BNP's refusal to hold any discussion on what it said were several burning issues in the session.

The treasury bench chief whip blasted the AL for the walkouts. which he termed damaging to the parliamentary democracy.

At the Bac meeting, with Speaker Jamiruddin Sircar in the chair, the AL demanded to set the duration of Committee (Bac) meeting on setting current session at 15 workdays. But

Mahmud for price hike of diesel, kerosene too

Asks RMG plants to use gas-fired, not diesel-run, power generators

Energy Adviser Mahmudur Rahman yesterday categorically said the government must raise the prices of all petroleum products, including diesel and kerosene, or subsidise them by direct budget allocations, if it wants to redress the liquidity crisis of Bangladesh Petroleum Corporation (BPC).

On another occasion, at a roundtable on 'Trade with European Union: General Guidelines for Exporters', he advised the readymade garment (RMG) units to power blackouts.

After a meeting with Agrani Bank and Janata Bank. Mahmud remarked to reporters. "I've read in newspaper reports that economists and political leaders have advised the government against raising diesel and kerosene prices. But, they haven't a clue about the petroleum sector. Diesel and kerosene account for 90 per cent of the country's total fuel consumption."

On some economists' and lawmakers' suggestion for raising

go for gas-run power generators octane and petrol prices only, he instead of diesel-run ones to face said it would be meaningless, as said it would be meaningless, as these two products make up only 10 per cent of the country's total oil consumption. Sadequee due All 7 JMB Shura back in NY court today

Ehsanul Islam Sadequee, accused of making false statements linked to an ongoing federal terrorism investigation, is due back in the Federal Court in New York today.

The hearing on the bail petition of Sadequee, a 19-year-old US citizen of Bangladeshi origin, is expected to be held in the court during his appearance. Defence Attorney Douglas Morris said on Saturday he hoped to prepare a bail application for Sadequee, said an AP report.

Sadequee was arrested by intelligence personnel of Bangladesh government on April 17 while returning his Baridhara home in the capital with his wife and extradited to the US in a plane on April 20. He was produced before the Federal Court on April 23.

Outlaw killed in 'crossfire'

A regional leader of outlawed Purbo Banglar Communist Party (PBCP) Communist War) was killed in 'crossfire' during a shootout between Rapid Action Battalion (Rab) and his accomplices at Alamdanga upazila in Chuadanga

The dead was identified as Shuklal, 40 of Bhogailkandi village in the same upazila According to Rab, a team of Rab-

6 arrested him from his hideout at Elenga of Gangni upazila in Meherpur on Wednesday evening During interrogation at the Rab

Chuadanga camp, Shuklal gave information about his accomplices and hidden firearms.

Following his confession, a Rab team took him to Bhogailkandi village to nab his accomplices and retrieve firearms. When the Rab team reached the village Eidgah at about 4:30am, PBCP outlaws opened fire on them prompting the law enforcers to retaliate, Rab said.

Shuklal tried to escape during the shootout and got caught in 'crossfire'. He died on the spot. Two Rab personnel were also injured in the gunfight.

One shutter gun and two bullets

were recovered from the scene. According to Chuadanga police Shuklal was accused in eight cases, including three for murder, filed with different police stations of Chuadanga and Meherpur.

The critically injured are Dhrubo, Anupom, Tamim, Anik, Mahfuz, Ripon, Prince, Shoeb, Moni, Anwar, Tania and Iva.

Students yesterday under the banner of "Jahangirnagar against Jamaat-Shibir" gave a three-day ultimatum to the university authorities to expel the ICS activists. They also demanded punishment to the Jatiyatabadi Chhatra Dal (JCD) cadres who launched the attack on the demonstrators.
