Inu granted anticipatory bail BDNEWS, Dhaka

The High Court yesterday granted anticipatory bail to Jatiya Samajtantrik Dal (JSD) President Hasanul Huq Inu in an arson attack case filed by the government.

After hearing a bail petition, a High Court division bench of Justice MA Rashid and Justice Mizanur Rahman Bhuiyan also issued a rule nisi upon the government to show cause within two weeks as to why the petitioner should not be granted regular bail in this case.

The petitioner appeared in person before the High Court bench for bail. Dhanmondi police filed the case

against Hasanul Huq Inu and 22 leaders and workers of the opposition parties on charge of preventing the police from discharging their duties during 14-party's sit-in programme on April 19.

Barrister M Amir-UI Islam moved the petition.

"Yes, I can still remember the days and I feel sad remembering those days," Stackpole said while ruminating the memories. He said the 1991 disaster gave us

all a lesson that communication. cooperation, coordination and collaboration can effectively address any disaster.

Ambassador Butenis said she feels proud to be associated with Stackpole in visiting the cyclone-hit area.

"The experience we had during the humanitarian efforts here in 1991 was of great use in post-disaster rescue and humanitarian operation in Indonesia after Nsunami and after the devastating earthquake in Pakistan. And I believe such humanitarian cooperation strengthens relationship between the countries," she added.

The Operation Sea Angel, which was launched within 24 hours of a request from Bangladesh government, involved over 7,000 sailors, marines, airmen.

During their 34-day stay in Bangladesh US forces provided food, water and medicare to nearly 20 lakh people and saved as many as 2.00.000 lives.
