## Adibasi Forum demands arrest of 'real' killers

Leaders of Adibasi Forum and some socio-political organisations on Monday held a rally in Durgapur  $demanding \, an \, impartial \, probe \, into \, the \,$ murder of local indigenous leader Sattyaban Hajong and arrest of the real

They urged police not to harass any innocent people in connection with the incident.

Earlier on the day, they visited Laxmipur village in Durgapur upazila where Sattyaban was killed on April 23 by some hoodlums allegedly backed by a local lawmaker and talked to some villagers and eyewitnesses to the

The team included Bangladesh Adibasi (indigenous) Forum president Rabaka Soran, general secretary Sanjib Drong, Gonaforum presidium member Pankaj Bhattachariya, Hajong Unnayan Sangathan president Nuhus Hajong and Prof Mesbah Kamal of Dhaka University.

 $Some \, local \, people \, and \, eye witnesses \,$ at Lakmipur told them that Sattyaban was killed allegedly by three known criminals as he declined to pay them toll, according to members of the visiting team.

The three are backed by some local influentials including a lawmaker, who are now trying to implicate two Hajong community men in the murder to save

the killers, they said. After the murder, Sattyaban's father filed a case accusing three personsRahimuddin, Suruj Mia and Kajimuddin.

Names of two other persons--Swapon Hajong, Sumon Hajongwere included in the list of accused later at the behest of the influentials with a motive to save the real killers, the local  $people\,told\,the\,visiting\,team.$ 

The rally held on local Shaheed Miner premises was addressed by Pankaj Bhatrachargya and other members of the team.

## Repairing one by damaging the other!

An embankment under Teesta Irrigation Project (TIP) is being repaired by using earth from the bank of a branch canal.

Labourers were engaged to repair about one kilometre embankment of Dinajpur canal, a major component of TIP. They were seen cutting and removing earth of the bank of a nearby irrigation branch canal (BC-3) at Deshibai village in Jaldhaka upazila, local people and BWDB sources said.

Jamaat lawmaker from Jaldhaka constituency diverted fund for the work under special allotment quota,

Instead of procuring earth, the project chairman who is also a Union Parishad (UP) chairman of Kathali union under Jaldhaka allegedly managed the BWDB officials for an order to

cut the bank of the canal. The branch of Dinajpur canal is meant for irrigation in the area.

Dhirendro Nath Roy, a labour leader told newsmen recently that his labourers are working at the directive of a BWDB section officer for the last few days. He also said the project chairman engaged 13 labourers for the

Farmers Yusuf Ali, Prokash Roy, Suresh Roy and Porimal Chandra said they lodged protest with the SO and the project chairman but to no effect.

On contact, BWDB executive engineer Abdur Razzak said that it is absolutely his discretion from where earth should be removed to repair the

'I am not bound to explain to newsmen as I do not work under their authority,' he said.

## JMB kingpins to be produced in Satkhira court today
