UNDP/UNAIDS Bangladesh seeks applications from both female and male Bangladeshi nationals for recruitment in a post of Vehicle Driver, to be based in Dhaka city, with requirements for field trips in/outside Dhaka city.

Duties and Responsibilities : The incumbent, under the direct supervision of UNAIDS Country Coordinator, shall have to (a) drive the office vehicle(s) within Dhaka city and on field trips outside Dhaka to meet the transportation needs of the UNAIDS personnel; (b) be responsible for day-to-day maintenance of the assigned vehicle(s); (c) perform minor repairs as and when necessary and ensure that the vehicle is kept neat and clean; (d) log official trips, daily mileage, gas consumption, oil changes, greasing etc; (e) ensure that the steps required by rules and regulations are taken in case of involvement in accident; (f) collect and deliver mail, pouches and other communication materials to and from the post office(s), affiliated offices and within the office(s); (g) sort, deliver and pick up mails from various places and keep records as required; and (h) carrying out other tasks as advised by the supervisor.
