Sagir murder accused killed in 'crossfire'

An accused in Juba Dal leader Sagir murder case was killed in an encounter between his cohorts and police in the city's Shyampur area early yesterday.

He was identified as Mazharul Islam alias Ripon, 35, son of Mansur Alam of Court-kachari road. Police said Ripon was wanted in 10 murder cases including that of Sagir.

Paltan police arrested Ripon at Ashulia Tuesday afternoon. According to his confession, they (police) took Ripon to Shyampur at about 2:30am to arrest his accomplices and seize hidden firearms.

When police along with Ripon reached Goshaibari, his cohorts opened fire, forcing the law enforc-Ripon received bullets during the

"shootout" and died instantly, while his accomplices managed to flee.

Ex-communist named as new Italy president

The Italian Parliament elected an 80-year-old former Communist to be president on Wednesday, paving the way for a government headed by centre-left leader Romano Prodi to be formed within days.

Giorgio Napolitano, a widely respected senator-for-life, was chosen during the fourth round of voting by some 1,000 electors, including lawmakers from the two houses of parliament and regional representatives

He was proclaimed Italy's new president by the head of the lower Chamber of Deputies, Fausto Bertinotti, after winning 543 votes well above the minimum 505 necessary for victory. A long found of applause erupted in Parliament **SEE PAGE 15 COL 2**

Thousands denounce 'fake' voter list

14-party demands scrapping of the roll

Several thousand demonstrators under the banner of the 14-party opposition line-up yesterday took to the streets in the capital and elsewhere in the country protesting what they termed the newly prepared 'fake voter list' and demanding immediate cancellation of it to ensure free and fair general elec-

In Netrokona, armed BNP men along with law enforcers attacked a cession of the Awami League (AL)-led opposition combine, leaving more than 50 injured, including 15 policemen and two journalists.

Those injured include District AL President Mohammad Samsuijoha. General Secretary Ashraf Ali Khan Khasru and police officials Saidur Rahaman and Osman Ali.

Protesting the attack, the 14party called a dawn-to-dusk hartal

today in the district. The opposition activists also caused damages to the office the superintendent of police.

On the other hand, ruling BNP activists went on a rampage at the district AL office and the house of district AL general secretary.

In the capital, a big 14-party

procession started from Muktangan amid tight security measurers and ended at the Central Shaheed Minar. The participants raised slogans against the 'fake' voter list and vowed to resist any election in the country without electoral

The demonstrators also demanded immediate removal of the chief election commissioner (CEC) and two 'politically appointed' election commissioners (ECs) for making the 'fake' voter list in a 'planned way' to create uncertainty about the next election and

Addressing a rally that followed the procession, senior leaders of the opposition line-up vowed to intensify the movement for realising their demands that include cancellation of 'fake' voter list, preparation of voter list as per a High Court verdict and other electoral reforms

More food produced, still half of households food insecure

Bangladesh now produces much more food compared to two decades ago but still about half of the households are far from being food secure. Food and Disaster Management Minister Chowdhury Kamal Ibne Yusuf told a roundtable in the city yesterday.

"The country cannot afford to be complacent with the current state and trends in improvement of food and nutrition security. We have around 60 million food insecure population, the third largest in number after China and India," he

Political will is the key element in any programme for sustainable food security and elimination of hunger and malnutrition, he stressed speaking as chief guest at the roundtable held at CIRDAP audito-

World Food Programme (WFP) and The Daily Star jointly organised the roundatble on 'What More Can We Do to Reduce Hunger and Malnutrition.' Editor and Publisher of The Daily Star Mahfuz Anam moderated the roundtable.

The minister said sometimes 'targets are too ambitious' and raise expectations that are likely to lead to disappointment. So, national decision-makers in many contexts are in tension due to the gap between expectations and reality.

"The challenge of eradication of hunger is huge and urgent. And more innovative approaches, advocacy for the hungry poor and strategic partnerships are required to optimise resource mobilisation and maximise the use of limited resources," the minister observed.

In a presentation on 'Who and where are the hungry people,' WFP

extreme poor are invisible even in their own community.

"Roughly 37 percent of the ultra poor are in the rural areas and 19 percent in urban areas." he said adding that women are especially vulnerable due to poor access to education

Dr Atiur Rahman, chairman of Unnayan Shamannay, in his presentation on causes of hunger and food insecurity, said continuous food price hike often due to bad politics, lack of competition due to syndication, absence of laws and institutions protecting consumers' rights mainly make the poor food

Hunger and famine constitute offence against and violation of human dignity, and the government has to create an enabling environment to ensure adequate

The nation's top judges had been widely expected to set a date on Tuesday, one day after the Constitutional Court scrapped last month's controversial snap polls that left the country without a functioning parliament.

But when the court released its 54-page ruling that nullified the polls, the judges said the government and the Election Commission should choose a date.
