PROTEST AGAINST EVICTION FROM GOVT FORESTLAND IN SHAKHIPUR

Magistrate, 5 cops among 30 injured in clashes

100 rubber bullets, tear gas fired

At least 30 people including a magistrate, five police men and some local political leaders were injured as demonstrators protesting eviction from government forestlands clashed with police at Shakhipur upazula headquarters vesterday

Police fired at least 100 rubber bullets and tear gas shells to disperse the demonstrators who besieged the Upazila Nirbahi Officer's office demanding removal of the UNO and the Assistant Commissioner of land revenue department, who started the eviction drive about a month

After launch of the eviction drive, an all-party body styled Shakhipur Bachao Sangram

After yesterday's clashes, the Sangram Committee announced hartal in Shakhipur for an indefinite period from yesterday.

Tangail Deputy Commissioner Saifuddin Ahmed Majumder and Police Superintendent Mirza Abdullahel Baki rushed to Shakhipur.

They were holding a meeting with the Sangram Committee leaders when the report was filed at about 9 last night.

Magistrate Ziauddin Ahmed and SI Abdur Razzak were injured by brickbats hurled by the demon-

Ten of the injured people including Sangrame Committee leader Shakhipur JCD (Jatiyatabadi Chhatra Dal) presi-Committee (committee to save dent Sabur Reza and Saiful Islam

were admitted to the Sakhipur Jpazila Health Complex.

> The injured also included Sangrame Committee convener Mir Shamsul Alam, who sustained beating by police, sources said.

> The clashes ensued at noon when the demonstrators marched with sticks and tried to besiege the UNO office. Police resisted the procession at the Upazila Parishad office gate. The protesters hurled brickbats at police.

The upazila administration said they launched the drive to evict encroachers from government forestlands. But the protesters claimed that the administration was also evicting lessees.

As the violence was quelled, the Sangrame Committee held a rally at Taltala in the upazila head-

MURDER OF EXPATRIATE IN RANGPUR

Procession with body for punishment to killers

Hundreds of locals in Dhap area in Rangour brought out a procession with the body of London expatriate Khondoker Iffat Elahi Mahbub yesterday demanding punishment to his killers

Adid-Bin Mahbub, brother of slain Mahbub lodged a case with Kotwali police station accusing Khondoker Mahbub Elahi Biplob, Captain Iftekhar Elahi Shanto, Ershad Elahi Shuvo, Laila Monjur and Pavel for

Police arrested only Captain Iftekhar who was caught by locals in Mahiganj on his way to Rangpur town from Rathbari, allegedly after dumping the body of Iffat.

Police said the rest of the accused are fleeing homes.

Police produced Iftekhar before a magistrate court and sought seven days' demand. The court granted

five davs' remand. Iftekhar is being guizzed at

Kotwali police station Police said, according to primary nvestigation, the accused had long been planning to kill Iffat who came to Bangladesh on April 30 from London.

Quoting from the FIR, police sources told The Daily Star that Iftekhar on Tuesday asked Iffat over cell phone over cell phone to come to his (Iftekhar) Dhap residence. Iffat is Iftekhar's cousin.

When Iffat came, Iftekhar proposed to his cousin to go to Kholahati cantonment for on visit

Adid said, "Khondker Mahbub Elahi Biplob, his brother

and Pavel of Kamalkatchna in left the house in the evening for Kholahati. We could not think of the murder of ffat till police informed us at night.

Meanwhile, a bomb went off on the yard of Pavel's Kamalkatchna residence yesterday morning, injuring a domestic help critically.

Locals in Kamalkatchna told this correspondent that inmates of the house immediately fled away with the injured domestic help.

Police is haunting for the injured domestic help and other inmates of

The rift became public on Monday when the two rival factions led by general secretary Ali Ahmed Biswas and vice-president Nazimuddin Ahmed brought out separate processions and held meetings as part of the party's countrywide programme to protest frequent hartal calls by 14-party opposition alliance.

The faction led by Nazimuddin held its meeting at Kadamtala in the town with Nurul Hasan Baku in the chair.

Speakers there termed Ali Ahmed Biswas an 'outlaw leader' and claimed that he is still involved in underground politics with Sarbohara Party.

They also alleged that Ali Ahmed is accused in at least 19 criminal cases including four for murder, one for looting Madhukhali police station

of Faridpur, three for robbery.

The speakers also accused him for sheltering anti-social elements and criminals.

Talking to this correspondent. Ali Ahmed denied his involvement with outlawed parties and tender manipulation. "My opponents are trying to tarnish my image", he said.

He however admitted some criminal cases against him and claimed that those were filed during Awami League rule to harass him. When asked about a separate party procession by his rivals, he said followers of some expelled leaders did that to damage the party.

Talking to this correspondent, former organising secretary of district Jubo Dal Khan Aminur Rahman Pikul however claimed that Ali Ahmed was involved with outlawed parties and that he along with his associates kidnapped businessman Sanatan Pal and realised Tk 8

lakh ransom last year. The BNP faction led by Ali Ahmed held its meeting at Shegun Bagicha in the town where senior vice-president Aminul Islam Chandu, organising secretary Akter Hossain and municipal chairman Abdul Gofur spoke.
