US wants fast enactment of law against terror finance

US asst secretary also offers technical help STAFF CORRESPONDENT

A visiting US high official yesterday urged the government to frame and enact an effective anti-money laundering law and take steps to curb financial crimes as part of the Bush administration's global drive against militancy

Patrick M O'Brien, assistant secretary for terrorist financing at the US Treasury Department, recommended the actions at a number of meetings with the central bank governor and high officials of home and foreign ministries during his two-day official visit here from Wednesday.

Why tele-tapping not illegal

HC asks govt to explain

The High Court in a rule yesterday ordered the government to explain within three weeks why Bangladesh Telecommunication (Amendment) Act 2006 empowering the law enforcement and intelligence agencies to tap telephones should not be declared illegal and unconstitutional.

A division bench comprising Justice M Awlad Ali and Justice Zinat Ara passed the rule in response to a public interest litiga-tion (PIL) filed by Odhikar, a human rights watchdog, and Nurul Kabir, editor of the New Age.

Jatiya Sangsad on February 12 passed the act amid protest by the

Earlier on December 11, President Iajuddin Ahmed promulgated an ordinance with immediate effect allowing the authorities concerned to tap telephones. The ordi-

nance led to an outcry among the

rights groups and political parties. The secretaries of post and telecommunication, law, and home ministries and Bangladesh Telecommunication Regulatory Commission (BTRC) have been made respondents in the case.

Law and Parliamentary Affairs Minister Moudud Ahmed yesterday told reporters that a reply to the rule will be placed within three weeks, outlining the rationale behind making the law.

The petitioners submitted that privacy is a fundamental right as per article 43 of the constitution. Tele-tapping and collecting information from the conversation of two individuals constitute a gross invasion of privacy and thus violates the constitution.

The petition said the telecom act will be a new weapon for the government to harass its political opponents as well as infringe on the privacy of general people.

It said the government has taken all measures to invade peo ple's privacy by tapping their telephones and thereby transgressing the bounds of decency and affront ing human dignity

Massive outage grips country as national grid trips

UNB, Dhaka

Almost half the country plunged into darkness as the national electricity grid tripped at nightfall yesterday, shutting down most of the power-generation units.

Four units at Ashuganj power station, two at Baghabari and one each at Barapukuria and Sylhet stations went off following the failure of the national power grid at 6:19pm, officials said. The shutdown sent many dis-

tricts into blackout. In some of those, power supply could be restored shortly after the mechanical breakdown, sources said.

The six districts of greater Mymensingh were worst affected as power supply remained cut-off for about two hours there following the collapse of Ashuganj station, UNB Mymensingh correspondent reported

Sources said electricity supply snapped at about 6:25pm in Mymensingh, Tangail, Kishoreganj, Sherpur, Netrakona and Jamalpur districts and was restored at about 8:30pm.

When contacted, local power office said, "Different units at Ashuganj stopped working for a sudden halt in supply from the national grid."

The massive outages affected life in the capital as well. Especially the HSC examinees suffered badly due to the power failure.

As of late last night, some of the power units were still shut down as PDB men were working hard to resume their normal operations.

Poll official quizzed, threatened for making allegation

The Election Commission (EC) Secretariat yesterday summoned the Assistant Registration Officer (ARO) of DCC ward no 41 Aminul Huq Bhuiyan who earlier told the press that he had been instructed by the election officials to include fake names in the voter list.

The EC Secretariat officials asked Aminul to return the 899 voters' registration forms given to him by the enumerators. Some 10 Secretariat officials interrogated him at the chamber of Joint Secretary (Law) AKM Salimullah for about one and a half hours.

Bangla Nagar Government High

School, however said he was right in his decision not to include the 899 "fake" names in the voter list.

He later told reporters that several EC officials threatened him on phone and when he went to the EC Secretariat they exerted pressure on him to return the registration forms by 9:00pm. They also enquired about his home address, family and other relatives.

Aminul earlier told the press that he had taken the decision after investigating the names in voters' registration forms submitted to the district election officer by one Aminul, also a teacher of Sher-e- Atiqul Islam who worked as

2 accused firm owners confess to smuggling another 64kg heroin

Apart from smuggling 54kg heroin to the UK, detained proprietor of Rainbow Enterprise Kazi Zafar Reza and Green Haven Enterprise owner Abul Bashar smuggled another 64kg heroin to the same country on different occasions, said an investigator.

Zafar and Bashar have confessed to their role in smuggling the drug in the name of a fake company, a member of the team probing the heroin smuggling told The Daily Star.

Police have already arrested BD Foods Limited Chairman Badruddoza Chowdhury Momen magistrate on May 14 that Badruddoza was the mastermind behind the trafficking of 22.5kg heroin to the UK.

"We are now trying to detect all others involved in the smuggling, the member said wishing not to be named. Asked about the name of the fake company, he said he would not disclose the name of the company for the sake of investigation.

Criminal Investigation Department (CID) recently filed a case with Sutrapur Police Station against Zafar and Bashar in connection with the smuggling of 54kg heroin to the UK. Later, Bashar's

US Assistant Secretary of State Boucher says

Corruption and bitter intra-party rivalries are challenges to Bangladesh's general elections in 2007, US Assistant Secretary of State for South and Central Asia Richard Boucher has said.

Giving a statement before the House Committee on International Relations in Washington on Wednesday, Boucher said corruption and poor governance are the main obstacles, which are a drag on Bangladesh's economy Boucher said in recent years the

growth rate would have a more dramatic impact on the standard of living in Bangladesh.

traditionally moderate and tolerant country that has made impressive progress in establishing democracy since gaining independence in 1971.
