Corruption now an acceptable conduct

CJ says many stalwarts of society have close involvement in this unholy process

STAFF CORRESPONDENT

Chief Justice Syed JR Mudassir Husain has said corruption in the society has reached such a point where it has created a national norm that corruption, especially petty corruption, is 'acceptable

"We must not sit idle, rather work to promote public awareness, so that the corrupt people do not get any chance to hold any public office or responsible position anywhere," he noted.

The state policymakers should take a 'three-pronged approach of

enforcement, prevention and awareness to combat corruption', the chief justice suggested while speaking as chief guest at a seminar on 'Corruption: Awareness of Citizens'in the capital yesterday.

"At this moment it would be an elusive goal for the nation to eradicate corruption as a whole because the scale of corruption is so enormous that many stalwarts of the society have close involvement in this unholy process," he said.

Chairman of Anti-Corruption Commission (ACC) Justice Sultan Hossain Khan, in his keynote speech at the seminar, said, "Politi

cal or grand corruption takes place at the highest levels of political authority

The ACC chairman said, "It is when the politicians and political decision-makers, who are entitled to formulate, establish and implement the laws in the name of the people, are themselves corrupt, they use the political power they are armed with to sustain their power, status and wealth."

3 'robbers' slaughtered Pabna AL terms it

Three alleged robbers were killed at Chatmohar upazila in Pabna on Friday night by other members of their gang over shares of looted

goods, police and the locals said.

Meanwhile, Bhangura upazila Awami League (AL) claimed the dead to be their party men alleging that the ruling party cadres murdered them in a planned way and staged the robbery.

The dead were identified as Rafiq, 30, of village Shatbaria, Golam Hossain, 24, of village Ramanathpur and Hassan Ali, of village Purbo Ramnagar under Bhangura upazila in Pabna.

Police and the locals said that the gang of robbers looted money and ornaments worth around Tk 5 lakh from the house of Abu Bakkar of Samaj Gram on Friday night.

Section 144 bars Ahmadiyyas from holding religious festival in B'baria

Ahmadiyya Muslim Jamaat could not hold their earlier scheduled religious festival 'Salana Jalsha' in the district town due to imposition of Section 144 yesterday.

The Ahmadiyya Muslims protested the religious bigots' barriers and imposing Section 144 by the district administration, and demanded giving back their mosque occupied by the fundamentalist force and legal help for holding its annual religious festival.

The religious bigots called a Tafsir Mahfil only to foil their religious festival, Ahmadiyya leaders said at a press conference.

The religious extremists have been interfering in their religious practice for over 50 years, they added.

COAL MINE FBCCI for renegotiating deal with Asia Energy

The Federation of Bangladesh Chambers of Commerce and the government to renegotiate its agreement with UK-based Asia Energy on the development of Phulbari Coal Mine Project.

"We think the government should renegotiate its agreement with the Asia Energy on the coal mine project... the existing agreement provides for only 6 percent royalty, which is very low compared to such agreements in other countries," FBCCI President Mir Nasir

Hossain said after a meeting with the chief of Asia Energy


Bangladesh project. Gary Lye, CEO of Asia Energy Corporation (Bangladesh) Pty Ltd. called on Mir Nasir Hossain at his office. Senior Vice-President of the FBCCI Mohammad Ali and Vice-President Dewan Sultan Ahmed and General Manager of Asia Energy Bangladesh Mushfigur Rahman were present.

During the meeting, Asia Energy Bangladesh project chief briefed the FBCCI president about the present state of Phulbari project.

Asia Energy Corporation (Ban-gladesh) Pty Ltd, a subsidiary of UK-based Asia Energy Corporation Pty Ltd, has been working to develop Phulbari coal mine under an agreement signed in 1998.

The company recently conducted a feasibility study and submitted a plan to extract coal from the mine through open-pit methodology.

The addresses for 99 voters on the list are mentioned as Babar Road and for 23 others as Salimullah Road water-tank

According to the rules of voters' registration, however, it is mandatory to mention the full address of a voter in the registration form.
