PM flies to **UAE** today

Prime Minister Khaleda Zia on a two-day visit flies for United Arab Emirates (UAE) this morning with issues of manpower and Bangladeshi product exports high on her agenda.

She also has development and investment assistance and purchase of oil at reduced rates on her

This will be her first ever bilateral visit since she assumed power in 2001. Earlier she visited UAE in 1993 during her first tenure. This time the visit is taking place at the invitation of UAE President Shaikh

The HC rule also asked the government and the BTRC to show cause why the Telecommunication (Amendment) Act 2006 should not be declared unconstitutional.

EPZ Workers GO BERSERK

2 RMG units set ablaze, 100 damaged

Several thousand workers of different garment factories in Savar export processing zone (EPZ) vesterday came out on the street, set two factories on fire, damaged more than a hundred factories and a number of vehicles, and put up barricades on roads demanding better wages, payment of unpaid wages, and other facilities.

They torched 10 to 12 vehicles on Parishad road in Ashulia inside the EPZ.

More than a hundred persons including workers, police and journalists were injured as employees loyal to the owners of different garment factories attacked the workers.

A worker named Rana was admitted to a hospital with a bullet wound in the buttocks.

Another worker Saiful, 30, received treatment at Dhaka Medical College Hospital for an injury in

This was the second incident of garment workers' protest in a week in the capital. The EPZ authorities announced a two-day shutdown of SEE PAGE 15 COL 1

POLICE REFORMS GET NOD

Cabinet committee for 26,000 more members, major increase in officers' number

The cabinet committee on law and order yesterday approved a massive reform in police organogram, suggesting an increase of over 26,000-strong force with major increase in the number of officer ranks to improve the quality of supervision in both investigation and controlling law and order.

Number of the force will be ncreased in phases, beginning in the next fiscal year.

The six-member committee also decided to introduce separate police units for investigation and law and order control at each police station (PS), establish Sylhet Metropolitan Police and Barisal Metropolitan Police, decided in principle to form marine police and introduce upazila police officer and strongly proposed setting up of traffic driving and peacekeeping training school The reform organogram will

come into effect after the cabinet approves it.

"Our police department is very undersized in comparison with our population, and the number of officers is too small for necessary jobs," LGRD Minister Abdul Mannan Bhuiyan, who heads the committee, said emerging out of the meeting that approved the organogram in principle at home ministry conference room vesterday.

The new organogram will raise the quality of service, training and logistic support besides increasing officers, he told reporters, adding that implementation of the new

organogram will take three to four

"We have reorganised the whole organogram after studying those in the neighbouring countries," State Minister for Home Affairs Lutfozzaman Babar said, adding that the present people-police ratio (1350:1) will be changed to 1000:1.

Bangladesh Garment Manufacturers and Exporters Association (BGMEA) leaders yesterday termed recent violence at garment factories as part of a "conspiracy by a neighbouring country' and demanded deployment of armed forces, BDR and Rab personnel at all factories in Dhaka and adjacent areas for safety.

SC judgment on CEC's

The Supreme Court (SC) will deliver judgment today on the appeal filed by Chief Election Commissioner CFC) Justice MA Aziz against the High Court (HC) directives over preparation of the electoral roll.

The SC full bench headed by Chief Justice Syed JR Mudassir Husain completed hearing of arguments of both sides in the case on the fifth day yesterday, and fixed today for judgement. The CEC's counsel TH Khan

vesterday submitted that national elections in the past were held on the basis of new voter lists but no political party objected to that. He also said there are no legal

provisions or rules that a fresh voter list cannot be made for an election. The Election Commission (EC)

Objections too small against enormity of fake voters

EC receives objections against 24,783 voters

Objections were filed against only 92 voters on the draft voter list for Dhaka district although at least 222 voters have so far been alleged as fake for being registered under mysterious addresses in

Mohammadpur area alone. In the district that witnessed 60.55 lakh voters on the draft roll. 5,202 people applied for registering their names as voters.

An EC press release said last night the election offices across the country have received objections against 24,783 voters since the publication of the draft electoral roll on May 3, while 59,803 others have applied for inclusion in the list.

Sources at the divisional election offices said over 3,000 voters listed in the draft have applied for minor corrections of names and

The draft list, however, shows at least 1.11 crore unaccounted for voters if one goes by the Bangladesh Bureau of Statistics census report 2001.

Following the publication of the draft voter list, the Election Commission (EC) invited claims, objections and corrections and received those until May 21. Officials at different election

offices said people are not much interested in identifying fake voters and the EC also has no mechanism to identify them. So, if no complaint is raised, the fake voters--if any-on the draft will remain in the final list too, they said

The highest number of 3,314 allegations was filed with the Rajshahi divisional election office while over 7,000 people have appealed for registering their names

The Barisal divisional election office received objections against 2 533 voters and received 2,814 applications for registration

The Sylhet divisional office received objections against 525 voters while 3,773 people applied for fresh registration. In Chittagong, objections against

2.200 voters were lodged with the divisional office and 5,196 others applied for registering their names. The Mymensingh divisional

election office has received objections against 711 voters while it received 6,211 applications for registration.

The revising authorities will resolve the cases of allegations and applications by June 6 and then the EC will fix the date for publication of the final voter list.

HEROIN SHIPMENT TO UK

Rainbow owner started smuggling following **BD** Foods' footsteps

Kazi Zafar Reza, proprietor of Rainbow Enterprise, yesterday told a magistrate that he started smuggling heroin hidden in vegetable consignments after he had incurred a huge loss in his legitimate vegetable export business

He said his legitimate business could not compete with BD Foods Limited, which used to sell vegetables at a lower price since its vegetables were only a cover for heroin smuggling. So he decided to join the heroin smuggling ring, he said.

Zafar, arrested for smuggling 54kg heroin to the UK, confessed to Metropolitan Magistrate Nani Gopal Biswas that he smuggled another 100kg of heroin to the same country in different shipments from 1989 to

He said BD Foods Chairman Badruddoza Chowdhury Momen used to pack heroin in cartons of Benson & Hedges and Gold Leaf cigarettes and smuggle those to the UK concealed in legitimate consignments of vegetables.

Man in fetters killed in 'crossfire'

A man in fetters was killed in a socalled "crossfire" between the police and his accomplices at Lalbagh in the city early yesterday while an alleged criminal was killed in a similar incident at Madanganj in Narayanganj. Lalbagh police claimed a police

team led by its officer-in-charge took Ismail Hossain, also known as Tunda Ismail and placed on remand earlier, to Noor Dairy Farm near Shahidnagar Balurmath to recover his hidden firearms around 3:55am.

Ismail's cohorts ambushed the team trying to snatch him from custody and the police retaliated leading to an encounter when Ismail received bullets, a police press release said. He was taken to Sir Salimullah Medical College Hospital where on duty doctors declared him However, Ismail's elder brother

Shah Alam said a chairman of Kamrangirchar area who is close to a ruling BNP lawmaker used the police to kill his brother over a land dispute. He also alleged the dispute with the chairman started in 2001 after he bought a piece of land which the chairman also wanted to buy. SEE PAGE 15 COL 2
