# Flood hits Sylhet, Moulvibazar Satkhira lawyers start

Heavy rain in last three days and onrush of water from hills across the border triggered flash flood in Sylhet and Moulvibazar districts, leaving at least 30,000 people marooned and disrupting road links in several

All the rivers in the two districts were flowing above their danger levels yesterday and were swelling

At many points the rivers are overflowing their banks.

The rise in water levels (of rivers in Sylhet) is abnormal an if it continues river embankments will develop breaches at many points in Sylhet", Water Development Board (WDB) Superintending Engineer in Sylhet GM Shamsur Rahman told the Daily

There was 271 mm rainfall in Sylhet city during 36 hours ending at 3 PM yesterday, meteorological

The Surma river breached its embankment at Lakshmipur in Kanaighat upazila while cracks have developed in the Surma Dyke in Gouripur-Kandipur portion, threatening nearby villagers, WDB officials

If the water level rises by one feet, there will be breaches in the dykes at several points, they said.

The Surma was overflowing its banks at Kanaighat upazila headquarters and at Atgram in Jakiganj

The Kushiyara is also overflowing its banks at Ujirpur and at Manikpur in bordering Jakiganj upazila. Sand bags are being dumped to

Road link between Sylhet city and Gowainghat upazila has been snapped for the second time in a week as the Sari-Gowainghat road went under three feet water.

At 3 pm yesterday, Surma was flowing 35 cm and 50 cm above danger levels in Sylhet city and Sunamganj district headquarters. It was flowing 172 cm above the red mark at Kanaighat upazila headquarters, WDB officials said.

The Kushiyara was flowing 185 cm above the danger level at Amolshid and 80 cm above the red mark at Sheola

In Gowainghat upazila, about 20,000 people in Alirgaon, Toakul, Lengura, Purba Jafflong, Pashchim Jafflong and Nandirgaon unions are marooned as all roads are under

Another about 10,000 are marooned in 15 villages in Jaintapur

Our Moulvibazar Correspondent adds: Seven unions of Juri and Baralekha upazilas in Moulvibazar district have been inundated.

The Juri, Fanai and Sunai rivers were flowing above their danger levels. Most areas of Juri upazila headquarter and 50 villages in the two upazilas have been flooded.

Moulvibazar Water Development Board (WDB) officials said they recorded 110 mm rainfall in the district in last 24 hours ending at 6 am yesterday. Flood situation in villages around

PROTEST AGAINST DECISION TO SHIFT COURT

#### Token hunger strike this morning

Members of Satkhira Bar Association will boycott all courts from today protesting a government decision to shift the Third Additional Judge's court from the district to Bagerhat.

They also will observe a twohour token hunger strike from 10 am to 12 am today demanding cancellation of the decision.

The decisions were announced at a press conference by association leaders held yesterday at its

In a written statement read out at the press conference, Bar Association General Secretary

advocate Shah Alam said the government took the decision when over 11000 cases are pending with the judges' courts and another 14, 458 with the seven upazila magistrate courts for long.

Cases are being piled up due to shortage of judges and magistrates,

He said, eleven posts of First Class Magistrate out of sanctioned 14 are lying vacant for last five years in the district, causing pile-up of cases and increasing sufferings of

The government should appoint judges and magistrates immediately to overcome the situation. Instead, it has decided to


shift the judge's court, he said.

He alleged the court is being shifted due to a conspiracy by some vested quarters when the government is enacting new laws for speedy trial and disposal of cases.

Lawyers will launch a tougher agitation to resist the move, he said.

"If our demand is not met within June 18, We will announce a tougher agitation programme on June 19", he said.

Among others, Bar Association President Tapan Chakraborty, advocates Samsul Haque, Golam Mostafa, SM Haidar, AKM Shahidullah, Abu Bakar Siddique and Amjad Hossain were present at the press conference.

Pneumonia claimed at least four children and attacked 780 others in Nilphamari and Dinajpur in the

Our Nilphamari Correspondent reports: Two babies, Babu and Sathi, died while the disease attacked over 500.

Senior medical officer of Nilphamari Civil Surgeon (CS) Office Abdul Majid said fluctuating temperature is the reason behind outbreak of pneumonia.

District health control room sources said 130 babies were treated in all the six government hospitals and health complexes on Wednesday. Of them, 30 babies were treated in Nilphamari 100bed Modernised Hospital. Parents alleged that their babies were kept in a congested and unhealthy female ward. The condition of the babies are worsening day by day, they said.

On contact, Nilphamari hospital Residential Medical Officer (RMO) Dr Khorsed Alam confirmed the deaths. He also admitted that the disease is spreading fast. 'The hospital authorities are facing trouble in tackling the situation due to lack of child specialist,' he said.
