- Eligibility of candidate**
 - Age in case of general quota candidates: Should be 18 to 20 years as of the date of selection test.
 - Age in case of freedom fighter quota candidates: Should be 18 to 32 years as of the date of selection test.
- Educational qualification: Should be SSC or equivalent examination passed.
- Nationality: Candidates must be permanent citizens of Bangladesh and should attend the respective district of permanent domicile for recruitment.
- Marital status: Must be unmarried.
- Quota: Govt prescribed freedom fighter quota as well as other quotas system should be followed.
- Physical fitness:**
 - Height should be minimum 5 feet 2 inches or 1.58 meter.
 - Weight should be of approved scale as per age & height.
- Candidates passing physical test shall have to participate in a written test of 40 marks 1 hours 30 minutes duration and candidates passing this examination shall have to participate in a psychological & viva voce test of 10 marks again. Candidates securing minimum 50% marks shall be treated as passed.
- Primarily selected candidates shall have to fill in the application form supplied by District Police Super & submit enclosing the undermentioned papers:
 - Bank Draft/Postal Order/Pay Order for Tk 15/- (fifteen) only (non-refundable) in favour of respective District Police Super.
 - Attested true copy of original/provisional certificate of educational qualification or attested photocopy of testimonial signed by school headmaster.
 - Certificate from union council or municipality chairman/ward commissioner (where applicable) as proof of district permanent domicile/nationality.
 - 02 (two) copies passport size recent photo attested by govt gazetted officer.
 - Freedom fighter quota candidates should possess, besides these papers, their parent's

- freedom fighter certificate (signed & countersigned by secretary & honourable minister/minister of state of the Ministry of Liberation War Affairs).
- Ansar & VDP quota candidates should possess original certificate of participation in the 42 (forty-two) days training.
- Primarily selected candidates after joining the training centre shall be verified on their physical fitness & other information by Re-selection Committee constituted with the representative of Police Headquarters and then included in the training.
- Training:**
 - Those adjudged eligible during re-selection by the Selection Committee, shall participate as Trainee Recruit Constable (Woman) in basic training.
 - In case any information furnished by the candidate is proved to be false during training or any time later on, legal action shall be taken including dismissal from service.
- Facilities during training: Free of cost dress materials, lodging & fooding, medical facilities shall be admissible. Besides this, an allowance of Tk 300/- per month shall be given.
- Appointment & service benefits:**
 - After successful completion of training appointment to the Post of Constable (Woman) in the police force shall be given in 2005 National Pay Scale with other benefits admissible.
 - Shall get free of cost dress materials, medical facilities and subsidised family ration items for prescribed number of family members as admissible.
- Those appointed shall be bound to join any district/unit if transferred to vacant post there.
- There is opportunity of promotion to higher post as per existing rules.
- The authority reserves the right to deduct/increase the number of post to be appointed on overall consideration. No TA is admissible.

BCIC Notice

Request for Expression of Interest (EOI) for joint venture with Bangladesh Chemical Industries Corporation to bring back into operation of North Bengal Paper Mills Ltd. (NBPM)

- Bangladesh Chemical Industries Corporation (BCIC), a statutory corporation wholly owned by the Government of Bangladesh (GOB), with its principal office at BCIC Bhaban, 30-31, Dilkusha C/A, Dhaka-1000 invites proposals in the form of sealed Expression of Interest (EOI) from local and foreign companies or a joint consortium of local and/or foreign companies for coming into a joint venture as equity partners with BCIC to manage and operate North Bengal Paper Mills Ltd. (NBPM) on a viable, sustainable and profitable basis by forming a new public limited company.
- As a part of government programme to encourage private sector to be involved more in the industrialisation process and to restart and operate the factory in a profitable manner, Bangladesh Chemical Industries Corporation (BCIC) invites joint venture partnership with either local and/or foreign firms/international companies/organisation having sound technical knowledge and financial capability to manage and operate similar or related larger industrial enterprise and ability to invest as a 51% equity partner to operate North Bengal Paper Mills Limited (NBPM) on a viable, sustainable and profitable basis by forming a new public limited company.
- Total assets value of NBPM Ltd as on 30.06.2004 has been assessed at Tk 4052.91 lakh by an independent audit firm. The total assets (fixed & current assets) value as determined by the auditor is not negotiable and shall be considered as the only and total equity investment of BCIC in the proposed new joint venture company. The bidder must have to state in their proposal that the abovementioned assets value of NBPM is acceptable to them. It is envisaged that joint venture partner will have to invest required money (as 51% equity & remaining as debts) for re-starting the NBPM Ltd on a viable, profitable and sustainable basis.
- It is envisaged that the successful bidder will be required initially to invest as equity an amount which will be required to restart production of the factory in full swing and effective manner on a viable, profitable and sustainable basis. And the successful bidder will be required to gradually increase his equity in such manner so that he becomes 51% shareholders in the new joint venture company. A consensus shall have to be reached separately with BCIC for protecting government/BCIC's interest.
- It should be understood that the assets of BCIC put as BCIC's equity must not be used as collateral for obtaining any loan. It is to be mentioned here that other than the present assets of NBPM, BCIC will not make any further investment of any sort in the new joint venture company.
- The intending entities submitting EOI may discuss any techno-commercial matters regarding the subject issue with General Manager (Planning), BCIC, BCIC Bhaban (15th Floor), 30-31, Dilkusha C/A, Dhaka-1000 on all working days up to 11.00am on 18.07.2006.
- A pre-invitation for EOI conference will be held 14 days before the closing of invitation for EOIs where all those who have purchased the invitation for EOI document shall be invited to attend to enable those who wish to submit offers against this invitation for EOI, to clarify any part and enable themselves to be acquainted with the situation on the ground.
- The prospective entities who would like to submit EOI's against this invitation for EOI are requested to submit their questions in writing before the pre-invitation for EOI meeting is held to enable BCIC to prepare answers which shall be provided during the pre-invitation for EOI meeting. Minutes of the meeting shall be issued after holding of the pre-invitation for EOI meeting.
- Invitation for EOI documents shall be available for purchase from Controller of Accounts, Bangladesh Chemical Industries Corporation, BCIC Bhaban (6th Floor), 30-31, Dilkusha C/A, Dhaka-1000, Bangladesh on payment of Taka 6,000/- or US\$ 100 (non-refundable) up to 11.00am on 18.07.2006.
- Each bid must contain a Bank Draft/Pay-Order from a scheduled commercial bank of Bangladesh of Taka 10,00,000.00 (ten lakh) only or its equivalent in US\$ in favour of Bangladesh Chemical Industries Corporation which will be returned after finalisation and completion of the selection process regarding the formation of joint venture company against this invitation for EOI.
