The Election Commission (EC) yesterday decided to send its officials even to villages now to revise the voter list, but people will still have to come to them to get enlisted, instead of them going to the people.

Election officials at district and upazila headquarters were already posted in accordance with the commission's earlier decision and they will continue discharging SEE PAGE 4 COL 6 | their duties there.

A total of 83 registration officers (RO) and 6273 assistant registration officers (ARO) will now be posted at suitable places at the wards of Union Parishads (UP), municipalities and city corporations, the new EC decision said.

"All necessary forms will be available from them (ROs and AROs). On the prescribed forms, any eligible person can apply for inclusion, correction and amendment of his or her name on the voter list," the EC Secretariat said yesterday in a news release.

Facing severe criticism and demands from a cross section of the people, the EC seemingly retracted from its earlier decision of letting its officials revise the voter list sitting in their offices at district and upazila headquarters

But the commission however remain rigid in its position of not visiting the prospective voters from door to door to revise the voter list. Rather people will have to come to the officials to get enlisted by SEE PAGE 15 COL 1

Graft thrives on poor governance

Seminar also laments lack of punishment to culprits

An environment of impunity created by lack of governance and accountability of the government coupled with an environment of resignation by the people, has encouraged corruption hampering the development process and undermining justice and the value system in the country, civil society members and business leaders said at a seminar yesterday.

Everybody talks about corruption, but they themselves do not undertake initiatives to curb it while the state machinery remains dysfunctional in most cases and operate on political considerations creating an atmosphere of impunity, they observed.

They suggested widespread media campaign for creating awareness among the people, formation of anti-corruption citizens' committees across the country, creation of demand for


Switzerland shot out


