15 Congressmen express concern

Fifteen Congressmen of the United States sent a letter to Prime Minister Khaleda Zia expressing concern about the adequacy of the progress made in the investigation and prosecution in the murder case of former finance minister Shah AMS Kibria.

Besides, a separate letter was sent to the Bangladesh Ambassador to the US Shamsher M Chowdhury on June 26 by 11 other senators that also dealt with the killing of the senior Awami League leader.

In the letter sent to the prime minister on June 30, the congressmen said prosecuting the case without further inquiry under the time limits imposed by the Speedy Trial Court would go contrary to the public interest, to the interest of justice and to the assurances of the

Zizou fires France into final

Zinedine Zidane fired France into their second World Cup final appearance in eight years here on Wednesday, scoring the only goal in a 1-0 semifinal victory over

The French captain shattered Portugal's dreams of a first ever appearance in the final after coolly converting a hotly disputed penalty midway through the first half at the Allianz Arena

Zidane's goal was a repeat of his spot-kick winner against the Portuguese in the semi-finals of Euro 2000 and sent France into a final on Sunday against Italy - just as it had done six years ago.

But the decider was shrouded in controversy, with Portugal protesting Uruguayan referee Jorge Larrionda's decision to point to the spot after Chelsea defender

Ricardo Carvalho brought down Thierry Henry just inside the area.

A clever touch by Henry wrongfooted Carvalho who fell but stuck his leg out, and although the Arsenal star reacted theatrically to clear contact, Larrionda had no hesitation in pointing to the spot.

Portuguese goalkeeper Ricardo had saved three penalties in his side's shoot-out victory over England in the quarterfinals on Saturday but though he dived the right way Zidane's 33rd-minute spot kick gave him no chance, SEE PAGE 15 COL 3



The home ministry in a rejoinder to The Daily Star report headlined Machine-Readable Pasport Scheme: Home ministry seeks quick nod of purchase body" published on Wednesday has given its own version of the story.

On the issue of hurried approval, the ministry yesterday said the programme of introducing machine-readable passport (MRP) and ID card is late by a year since it was conceived and approved by the prime minister more than two years ago with the implementation date of July 1 last year. Despite having the urgency of introducing MRP and ID card immediately, the ministry took more than 18 months to work out its requirements based on foreign studies, approved programme strategy and government procurement regulations and procedures.
