## Kuakata road project okayed when its life expired

Re-construction of the 22 km Kalapara-Kuakata part of Patuakhali-Kuakata road under a Danida assisted project has became uncertain as the project period is over.

The five-year project to renovate important roads in Patuakhali and Barguna districts was launched on May 1 in 2001. The project period expired on June 30 this year. The 22 km stretch of the road could not be renovated due to delayed project

approval by the government. The Patuakhali-Kuakata road development project involving Tk 126 crore was taken up considering prospects of tourism in Kuakata and

fish farming in the coastal areas. The 50 kilometre portion of the road from Patuakhali to Kalapara nas been reconstructed at a cost of Tk 70 crore, provided by Danida.

Under the project, periodic maintenance of 35 kilometre other roads in Patuakhali and Barguna districts has been completed at a cost of Tk6.85 crore. These are onekilometre Amtali-Barguna road, nine-kilometre Patuakhali-Mirzagonj road and 25-kilometre Labukhali-Baufal road.

An official of Road & Highways Department (R&H) in Patuakhali said, after completing the Patuakhali-Amtali portion of the road. Danida submitted a revised project in August 2004 to R&H Department for reconstruction of the Kalapara-Kuakata portion. The R&H department sent it to the communications ministry with a

The ministry sent it to the Cabinet Committee, which returned it to the ministry, seeking comments from the Economic Relations Division (ERD) and the Implementation, Monitoring and Evaluation Division (IMED) as it involved foreign assistance. The ministry then sent it to ERD and then to IMED.

The ministry had assured the R&H that the project would be approved by December 2004 but it

Meanwhile, the donors gave letters to ERD and the ministry to hasten the approval process. In reply, ERD assured the donors that the project would be approved by June 1, 2005 but it failed. At last, the ministry approved the project on June 30 this year when the project

"We failed to complete the Kalapara-Kuakata road as we lost 10 months from the project period due to delayed approval. Danida disagreed to extend the project"," an official of CAMSAQ, consulting firm of the project, told this correspon-

When contacted, R&H Executive Engineer Abdus Salam said. "A meeting was held between officials of Danida and communications ministry on June 20 this year in Dhaka, where Danida disagreed to extend the project period."

"Danida assured us that the project could be considered when they take up a new project in Bangladesh", he added.

He however said that the R&H department would complete the Kalapara-Kuakata road with its own resources if Danida finally refuses to do the work. "We will renovate the road to Kuakata tourist spot", he asserted.

The delay in project approval which left the road incomplete evoked criticism from local political

Local lawmaker Mahbuur Rahman said, "Danida should complete the whole project to establish better communication between Kuakata and the rest of the country to promote tourism and socioeconomic development of people of the area"

ABM Mosharrof Hossain, president of Kalapara BNP said, "We are hopeful that Danida would complete the project to establish a better road link to the tourist spot. We have requested them through the communication ministry to complete the whole project."

Besides development of tourism, there is bright prospects for private sector fish farming in the area, and many prospective investors showed interest after road renovation was

Pirates abduct 12 fishermen in Sundarbans for ransom

Pirates abducted 12 fishermen Thursday night from Badhan Jhhuti canal in the Sundarbans and demanded Tk one lakh as ransom for their release.

The pirates set a 7-day deadline for the payment and threatened to kill them for noncompliance.

Quoting local people police said, about 20 fishermen went for fishing in the Sundarbans on Tuesday after taking permission from the forest department.

When the fishermen were asleep on their boats at night, pirates attacked and abducted 12 of them, demanding a ransom of Tk one lakh.

The pirates kept the fishermen hostage in the deep forest, according to fishermen Saheb Ali and Abdus Samad of Patakhali village in Shyamnagr upazila, who managed to escape.

On contact, Afsar Gazi, father of victim Habibur Rahman and Fatik Sadar, father of another victim Abu Hossain of Sora village in the same upazila said their sons along with others went to the Sundarbans for fishing. Pirates abducted them for ransom, they said.

Afsar Gazi filed a general diary GD with Kalaroa thana.

Sub Inspector Swapan of Shyamnagar thana confirmed the

Piracy and abduction int he Sundbrans increased in recent years. In last six months, at least five such incidents took place in which over 50 fishermen were abducted for ransom.

The slide in law and order in the mangrove forest decreased fishing and honey collection in the area.

#### **Nagorik Committee rally** demands arrest of cops



Gaibandha Nagorik Committee leaders at a rally in the town yesterday demanded arrest of police men allegedly involved in Saiid murder.

They expressed resentment that there has not been any progress in investigation of the case 47 days after the murder.

A large number of people attended the rally held at the Shaheed Minar, where the speakers demanded capital punishment to the culprits to stop recurrence of death in custody.

Sajedur Rahman Sajid, 26, of Munshipara in Gaibandha town, a medical representative of a pharmacutical company, was arrested on the night of May 18. He was taken on seven days'



On May 21, on the third day of remand, he died in custody. Police claimed that he committed suicide but the autopsy report said the youth

was strangled. The death in custody triggered cultural organisations, who organised a series of agitation programmes including protest rallies, formation of human chains and submission of memorandum to the Deputy Commissioner for arrest of persons responsible for the alleged murder. Black flags were hoisted atop all houses and shops in the town as a mark of protest.

Speakers at yesterday's rally also demanded arrest of ruling party cadres who attacked and foiled a peaceful Nagorik Committee rally held earlier in the town to protest the

They alleged that former Officerin-Charge of Gaibandha Sadar police station was involved in the murder and demanded formation of a high-powered committee to inves-

### Thousands under open sky in Khagrachhari

Rains trigger flash flood, swell 3 rivers

Day-long rains yesterday swelled the three hill rivers in Khagrachhari, causing flash flood and displacing several thousand people.

The Chenghi, Mainee and Feni rivers crossed their danger marks and were rising as rains continued, official source said vesterday afternoon. There may be rain today also, they

Most of the low-lying areas in the district have been inundated, submerging scores of homesteads.

The worst affected areas include Gonjopara, Muslimpara, Golabari, Raj Jamonipara, Muslimpara, Mohazonpara, Shavdamiyapara, Aparna Chowdhury Para in the sadar upazila, where most of the homesteads and croplands have

gone under water, officials said Over 4,000 people left homes in

Sadar upazila alone and moved to higher places, they said. They are under the open sky and need food and drinking water.

#### Use of blood from professional donors down

Use of blood from professional donors decreased to 18 per cent from 70 per cent. Use of blood from relatives

increased from 15 per cent to 57 per cent while that of volunteers from 10 per cent to 26 per cent. Nilphamari civil surgeon (CS) Dr Abdur Rahim disclosed this at a

workshop held at his conference room on Thursday. Rangpur Dinajpur Rural Service (RDRS), a renowned NGO, organised the workshop while its project coordinator Anthony D'cruze graced the programme. It was possible following intro-

duction of a mandatory blood screening programme jointly initiated by the government and the United Nations Development Programme (UNDP) since 2000, the CS said. The programme was aimed at ensuring safe blood transfusion to recipients, he said.

The CS further said 29 per cent professional donors suffer from Hepatitis-B, 22 per cent from syphilis and six per cent from Hepatitis-C.

It was not mandatory to screen blood in either government or nongovernment hospitals before

launching of the programme. Hospital sources said blood transfusion is required for surgical operations, treatment of anemia and recovery of rapid loss of blood

after accidents.

In Bangladesh, over 3.75 lakh units of blood are required annually. At present, about two lakh units of blood can be screened from blood transfusion centres including 53 district hospitals. The World Health Organiation (WHO) provides training and technical support and helps install equipment. There are blood banks and reference laboratories in the centres

Dr Abdul Mazid, In-charge of blood transfusion centre of Nilphamari district hospital said the aim of the project is not only to ensure blood screening in a proper manner but also to create low risk donor group. Cent per cent voluntary blood donation is the goal of the programme, he said.

RDRS director (Community health) Dr Selina Rahman said her organisation is assisting the government to enhance awareness among people and conducting motivational campaign for voluntary blood donation. 'Accessibility to safe blood is

people's right,' she said. RDRS co-ordinator (Social empowerment) Liaqat Ali Khan said his organisation will form voluntary blood donor group comprising 1,000 eligible officers, staff and group members of village federation (local

people's body). Physicians and nurses of government hospitals, blood transfusion technicians, local elite and journalists were present at the workshop.
