### BDR, BSF trade fresh aunfire

BDR sources said the Indian border guards of Char Benuka border camp suddenly opened fire at about 8:30pm without any provocation, prompting the BDR to retali-

Both sides exchanged 60 bullets during the skirmish that continued for 25 minutes

Lt Col Lutfor Rahman of the 6th Rifles Battalion told the BSS that exchange of fire between the BDR and the BSF took place at Hakimpur and Poladanga frontiers in Sadar upazila and Kironganj Telkupi and Wahedpur frontiers in Shibganj upazila of Chapainawabganj district on June 8,16,18,19, 23 and July 1

### Italy to grant citizenship to legal immigrants after 5 years

Italy's new centre-left government plans to give Italian citzenship to immigrants who have lived in the country legally for at least five years, Interior Minister Giuliano Amato said on Thursday.

"I see no reason why we should not grant citizenship to those who acquire a residence permit and thus demonstrate their commitment to this country," he said during a public debate in Rome.

Amato said his ministry was currently study the project.

But he rejected proposals to grant immigrants citizenship after only two years. "I think that's too short because many immigrants come to Italy to earn some money, then leave for home again." he

The minister's proposal prompted a sharp reaction from the Northern League, a minority party with a populist and xenopho-

#### Raid on criminal groups hiding in Sundarbans

Security forces including the coastguard have cordoned off different vulnerable points in the Sundarbans since Thursday night to arrest over 200 armed members of eight criminal groups who threaten lives and property of nearly five lakh Bawalis (honey collectors), and fishermen working in the Sundarbans.

Combing operations in the Sundarbans have been intensified in the wake of alarming rise in crimes including rampant abduction of fishermen and Bawalis for ransom, Commander of the West Zone Coastguard Md Anowar Hossain said yesterday.

On Wednesday night, several people were injured in an hour-long gun battle between the coastguard and pirates at Narkelbarhi near Dublarchar where pirates escaped leaving 31 empty bullets, three daggers, three torchlights and a rifle carrier on the riverbank, he said.

Hundreds of fishermen and Bawalis have left the Sundarbans fearing abduction for ransom.

Criminals have taken over the forest where forest guards are quite helpless, said fish traders Abul Hossain and Anis Fakir, who bought freedom from pirates for two lakh taka on June 26.

Sixteen fishermen kidnapped on June 30 from the Sundarbans also returned to Sharonkhola on Thursday after paying Tk 3 lakh as ransom to Motaleb Bahini ringleader Motaleb, who resides in Khulna city, sources said.

# BNP men eat up 500 ton rice in Bogra

At least 500 metric ton rice was lifted against some 150 fake development projects mostly submitted by ruling BNP leaders and activists in different upazilas and municipality areas in Bogra during the last financial year, sources said

District administration sources said most of the development projects were taken in the name of youth clubs and organisations run by the ruling BNP men. They alleged that some projects were implemented for personal gain.

An official at the sadar upazila project implementation office told The Daily Star that almost all development projects were approved upon recommendations from the Bogra municipality chairman, several ward commissioners, special representative of prime minister and

Ward Commissioner Nilufa Quddus undertook the earth-filling work under the Majibur Rahman lane development project at Shibbati in the town although the road already has bituminous carpet-

She said she implemented the project in "public interest" but there are allegations that she actually aimed at filling the lowland shown in the plan and owned by her family members with the project money.

In another project named Shaheed Zia Smriti Sangha development project at Katnarpara under Bogra municipality, two metric ton rice was withdrawn showing the

completion of the project.

However, no club with that name was found in the area although a signboard bearing the club's name was seen hanging from a tree. Locals also said there is no such club in the area.

A resident of the area said he heard that some BNP men were sanctioned rice for the "development work" of the so-called club Another two metric ton rice was

sanctioned for the work under Malotinagar Dakkhinpara earthfilling project in Bogra town headed by the local female ward commis-

# Road accident in Habiganj kills 12 of a bridal party

Twelve people, including three children, died and 15 others were injured in a road accident on the Dhaka-Sylhet highway in Bahubal upazila of the district yesterday.

Police and locals said the accident occurred at about 2:30 pm when a Habiganj-bound microbus, carrying a bridal party, collided with a bus in Kamaichhara area, killing 11 people on the spot and injuring16 others.

One of the injured died at Habiganj Sadar Hospital, while the remaining 15 are undergoing

treatment at the hospital. Of the deceased, eight were identified as microbus passengers Alauddin. 25. Monir Mia. 30. Sohel Mia, 20, Waresh Mia, 20,

Suleman, 9, Hamdu Mia, 36,

Mohid Mia, 18, and Didar Mia, 40. The identity of four others--driver and helper of the microbus and two children--could not be known.

The microbus carrying the bridal party was on way to Habiganj from Laharpur village in Srimangal

In Keraniganj of Dhaka district, one person was killed and eight others were injured when a threewheeler tempo with a bridal party on board collided with a bus at Nazirerbagh at around 11:30am

The dead was identified as Robu Mia, 60. The injured--Eva, Nurjahan, Taherun, Maria, Monir Hossain, and tempo driver Chunnu Mia--were first admitted to Midford Hospital and then shifted to Dhaka Medical College Hospital (DMCH).

# Israel presses Gaza assault, 26 killed

Israel pressed on with its bloody offensive against Gaza yesterday a day after reoccupying land and waging multiple air strikes in the deadliest 24 hours in the Palestinian territories for four years.

Three Palestinians, one of them a teenager, were killed as Israeli artillery and aircraft pounded the northern Gaza Strip for a second day. Twenty-five Palestinians and one Israeli soldier have been killed Wednesday.

Faced with the mounting death toll and the worst Middle East crisis in months, the UN Security Council debated a draft resolution demanding Israel withdraw from Gaza immediately and release detained Palestinian officials.

But the United States, Israel's closest ally, described the text as "unbalanced" and troops continued their ground assault aimed at securing the release of a soldier captured

by Palestinian militants 12 days

A Palestinian teenager, a deaf man and militant were killed by Israeli tank fire and an air strike on the town of Beit Lahiya, the main battleground in northern Gaza, medical and security officials said.

In a refugee camp in the occupied West Bank, another Palestinian militant was shot dead in clashes with Israeli forces in

## 3 Ahab leaders get bail in **Brac office** robberv case

Three top leaders of Ahle Hadith Andolon, Bangladesh (Ahab) are about to be released from Naogaon jail soon as they were granted bail on Wednesday in the case for Brac office robbery at Kotalipara in Gopalganj.

They are militant kingpin Asadullah Al Galib's second-incommand and Ahab Nayeb-e-Amir Abdus Samad Salafi, General Secretary Maolana Nurul Islam and Organising Secretary ASM Azizullah.

Eleven militants, including kingpin Galib, were named as accused in the case. Galib, however, was denied bail.

An investigator said the militants would be released from jail as they were granted bail in two NGO office robbery cases while the four others of the six cases filed against them were dismissed.

Sources said the release is taking place at a time when nspector General of Police Abdul Quaiyum, who played a vital role in the countrywide militant busting drives, has been transferred.

Abdul Aziz Khalaph Malullah, Bangladesh chief of Revival o Islamic Heritage Society (RIHS), the top suspect donor NGO of the militants, is also visiting the country at the time, they said, adding SEE PAGE 15 COL 4

#### Skop threatens strike, road-rail blockades

Some vested quarters in the country and abroad are hatching conspiracy to foil the agreement, the Skop leaders said, urging all garment workers to be united to resist the conspiracy to save themselves and the industry.

Cautioning the government and garment owners, the leaders said they will go for a tough movement again if any condition of the agreement is violated.

Over 800 mobile phone sets worth Tk 40 lakh were seized while being carried illegally through Chittagong Shah Amanat International Airport yesterday.

According to sources, customs officials recovered 820 mobile sets of Nokia model No. 1100 from a passenger of a Hong Kong-Dhaka-Kolkata flight of GMG Airlines around 1:00pm.

The passenger was identified as Abu Rustam from Mirpur in Dhaka. Sources said the phone sets were brought by another passenger from Hong Kong on his way to Kolkata via Dhaka and Chittagong.

The unidentified passenger handed over the luggage containing the mobile sets to Abu Rustam who boarded the same flight from Dhaka to deliver them in Chittagong evad-Rustam was trying to get the

consignment out of the airport through the flexible customs checkup for domestic passengers, said the sources. Acting on a tip-off, a customs

team led by Assistant Commissioner Mostafizur Rahman intercepted Rustam after the flight landed at the Chittagong airport at 12:45pm and recovered the mobile

The other passenger involved,

however, escaped safely by the same flight.

She will also seek to know from the local leaders about prospective candidates from their respective areas," BNP Secretary General Abdul Mannan Bhuiyan said yesterday.

On the ruling four-party alliance's nomination of candidates, Bhuiyan said they would discuss this with their coalition partners after finalisng selection of the BNP candidates.

Sources mentioned that while facing the opposition's oust government movement politically, the prime minister is now trying to expand the BNP-led alliance to face

the next election. She already had talks with Jatiya Party (JP) Chairman and former president H M Ershad and JP

(Manju) chief Anwar Hossain Manju. The BNP high command is also making efforts to bring a number of leaders of opposition parties to the ruling coalition ahead of the election, party insiders said without

giving details They mentioned that a number of party high-ups, specially those at Hawa Bhaban led by Senior Joint Secretary General Tarique Rahman, have long been working on drafting the election manifesto and preliminary selection of deserving candidates. They are activating the organisational network and stepping up mass contact.


