Opposition got frustrated for Govt retreats from Hasina terms move to amend constitution

Just three days into its decision, the government yesterday retreated from amending the constitution incorporating a new provision for not holding by-election to a vacant seat if the tenure of parliament remains for 180 days or less.

Completing all arrangements for passing the bill, including even extension of the current session of the House, government policymakers asked the Speaker to suspend the process regarding the bill okayed by the cabinet last

Following the government decision, the current session was prorogued last night without witnessing the placing of the muchtalked-about bill although it was enlisted in the day's order.

The government's sudden retreat from passing the amendment bill has now put the Election Commission (EC) into trouble as it will have to conduct by-elections to two parliamentary seats--Dinajpur-3 and Comilla-8.

The seats fell vacant following the deaths of ruling BNP lawmak-Law Minister Moudud Ahmed ers Khurshid Jahan Haque and Col

(retd) Akbar Hossain recently.

Lawmakers in the House were stunned by the sudden decision for not extending the tenure of the

Speaker Jamiruddin Sircar said they were not interested in extending the tenure of the current session as they wanted to stay in their constituencies ahead of the next parliamentary elections.

Ministry forcing RHD to sign construction deal despite faulty design

Ignoring the reservations expressed by various authorities, the communications ministry is forcing Roads and Highways Department (RHD) to sign a Tk 338 crore contract today with a Chinese company for the construction of faultily designed Karnaphuli

Transparency International Bangladesh (TIB) yesterday explained the method of its corruption database saying that it was merely a compilation of 2,128 corruption incidents published in 24 leading Bangla and English newspapers in 2005.

The question of withdrawal of the report does not arise as the corruption database only put the newspaper reports together and the authenticity lies on the news-

papers concerned, said Prof Muzaffer Ahmad, chairman of TIB trustee board while addressing a press conference at the lativa Press

The TIB is not against the government but it is unfortunate that whichever party remains in the power tries to undermine it, he said, adding that the ruling parties also try to tarnish the image of the TIB trustee board members.

Law enforcers on high alert

The law enforcement agencies have been put on high alert in the country following Tuesday's serial bombings in Mumbai that claimed around 190 lives and injured several hundred others.

State Minister for Home Affairs Lutfozzaman Babar apprised the journalists of the precautionary measure at his office yesterday.

"Since a neighbouring country is under attack, we should take all possible measures to avert such incident," said the minister.

"Law enforcement agencies have been directed to remain alert, and stringent security measures have also been taken at all key-point installations across the country," Babar informed the newsmen.
