# Teachers in clutch of moneylenders

At least 200 teachers of nongovernment high school and 100 of government primary schools took voluntary retirement in last two yeas in Nilphamari district and left the poorly-paid profession.

Tobarak Ali, teacher of Nitai Government Primary School in Kishoreganj upazila, committed suicide two years ago as he could not meet the demand of a moneylender with his total retirement

Abu Jar Gaffari, teacher of Darul Huda Government Primary school in Nilphamari Sadar upazila, died of heart attack a few months back as a moneylender pressed him to repay an amount which was not covered by his retirement benefits. The amount demanded was much

had taken.

These and many other starling information came out during investigation by this correspondent on the plight of schoolteachers, now on an indefinite strike to realise their 21-point demand including enhancement of salary and bene-

Schoolteachers easily fall into the clutches of moneylenders because of the system of payment of their salary, sources in teachers associations in the district said.

Salary of government schoolteachers is paid through banks and the payment is irregular. Teachers are given cheques in advance, which they cash in banks when payments are disbursed, often at intervals of three to four months, said Abdur Rashid Sarkar, general

upazila unit of Bangladesh Teachers Association.

To meet family expenditure or emergencies, many of the teachers take loan from moneylenders against cheques. Often, teachers sign their cheques in advance and hand over those to moneylenders, who cash them at banks.

The moneylenders realise at least 30 per cent interest per month on the loan. At times, they compel teachers to put their signatures on blank non-judicial stamps and put

While talking to this correspondent, president of Nilphamari Primary Teachers Association Mejajuddin said around 80 per cent of primary teachers become victims of moneylenders and bow down to their harmful conditions.

the district involved with the dishonest business with teachers. It is now a good business

Last year, a big businessman in Kishoreganj, who is also a moneylender, filed a case against some primary school teachers and realised amounts what he demanded as the teachers refuse to pay so high interest.

Abdul Goni, a former teacher of Dolua Government Primary School in the Sadar upazila, said he took Tk 80,000 loan from a moneylender for treatment of his wife. He surrendered cheques for his monthly salary for two years. But this was not enough. The moneylender claimed Tk 1.5 lakh and threatened to file case. To avoid case, Abdul Gani took voluntary retirement and gave the money to

Bimol Kumar Roy of Sonaroy Government Primary School in the Sadar upazila. Anwar Hossain of Naotara Government Primary School in Dimla and many others in the district did the same thing, Mejajuddin said.

Habibur Rahman, president of Sadar upazila unit of the association alleged that a section of bank employees are involved in the practice. Banks allow moneylenders to cash as many salary cheques of teachers as they like in a day, which is illegal, he said.

He said headmaster of a government primary school having completed masters degree gets a basic salary of only Tk 2850, whereas a SSC pass block supervisor of agriculture department gets a basic salary of Tk 5100.

## Interns at RMCH continue strike

Sufferings of patients mount

Intern doctors continued their strike at Rangpur Medical College Hospital (RMCH), causing sufferings to patients.

They began the strike on Tuesday in protest against attack on some of their leaders and demanding demolition of all illegal shops and structures on the campus.

Earlier, they had observed strike last week on the same demands. They resumed the strike as the authorities did not fulfil their demands by Monday, promised by it.

Ali Reza, a leader of the Intern Doctors Association, said, "The RMCH authorities had promised to us to demolish illegal shops on the hospital campus and take action against miscreants who beat our

"We resumed our strike as they

did not keep their promise", he said. Ali Reza said they will continue

the strike till the demands are met. Meanwhile, sources at RMCH said that third and fourth employees of the hospital threatened the RMCH authorities to go on indefinite strike if shops on the campus are demolished.

The third and fourth class employees have taken a stand against the intern doctors, the sources claimed

They also submitted a memorandum to the director requesting him not to demolish the shops.

RMCH Director Shahajahan Bishwas later said he has called a meeting of intern doctors with BMA and RMCH trade union leaders today (Thursday).

#### 'Gangraped' AL leader Chhabi Rani gives deposition

Chhabi Rani Mondol described in a court here yesterday how she was gangraped and physically tortured by BNP cadres at their party office in Rampal upazila in Bagerhat on the night of January 21, 2002.

Trial of the sensational Chhabi Rani Mondol rape case began yesterday in Khulna Women and Children Repression Control Tribunal. Judge Md Belayet Hossain fixed July 23 as the next date for

Bagerhat Awami League leader Chhabi Rani Mondol. who is the complainant and at the same time number one prosecution witness in the case, gave deposition in the court amid pin drop silence.

She told the court that party cadres led by BNP leader Kazi Abul Bashar abducted her on the night of January 21 in 2002 from Rampal bus stand. They took her to Rampal BNP office and raped and tortured me, she said.

Chhabi Rani told the court that proprietor of Rampal Palash Studio Bazlur Rahman took photograph.

The Awami League leader at one stage of her deposition broke into tears. The court, however, adjourned hearing of her statement, which will resume on July 23.

Chhabi Rani lodged an FIR with Rampal Police Station accusing 15

### **Traders observe** half-day strike in Gaibandha

Procession, rally held demanding trial of accused cops

Businessmen in Gaibandha town vesterday observed a half-day shut down demanding fair trial alleged murder of Sajedur Rahman Sajid in custody and exemplary punishment to the accused persons.

Gaibandha Traders' Coordination Council called the shutdown from 6 am to 12 noon demanding arrest of the Sadar thana Officer-in-Charge.

During shutdown, traders, joined by people, brought out a procession n the town and held a meeting at local Shaheed Miner premise.

Presided over by Shajada Anowerul Kadir, the rally was addressed by, among others former chairman of Gaibandha Pourashava Wahiduzzaman Khan Titu, Sajid's father Abdur Rouf Sarker and elder brother Majedur Rahman Maied.

The speakers expressed their concern and indignation at the silence of the administration regarding arrest of the culprits. Non of the accused persons ahas been arrested 52 days after the alleged murder in custody, they said.

custody has become a common

practice to realise toll. Such incidents are increasing because the culprits go unpunished, they said. There should be a code of con-

duct for policemen to interrogate arrested persons to check custodial death, they said. Sajedur Rahman Sajid, 26, a

medical representative from Munshipara area in the town was arrested on the night of May 18. On May 21, his body was found at the police station.

Police said Sajid committed suicide but the autopsy report said he was strangled and the body was

His death in custody sparked protests in the town. People joined by activists of different socio-culture organisations held rallies, brought out processions, formed human chains, hoisted black flags atop houses and submitted a memorandum to the Deputy Commissioner for arrest of the culprits and their

A case was filed with Sadar police station accusing 22 people, which was transferred to Criminal Investigation Department for investigation. But there has not been any progress in the investigation,

There are about 50 male and female outsiders working at RMCH

This correspondent talked to some others like Asma. All of them said they were engaged by some hospital staff, mainly third and fourth class employees. They have actually formed a gang.

Abdur Rahman, another man working at RMCH illegally said he is working at RMCH with the permission of RMCH trade union leaders.

"As the hospital lacks sufficient manpower, we give services to patients. In return we money from patients," Nurul Islam, another unauthorised person working at the hospital said. Allegations have it that the

patients and medics are virtually hostage to the gangs of unauthorised people at the hospital sheltered by trade union leaders and a small section of vested quarters. Patients have to give them money for service. Medicines are often stolen. Attendants of patient keep mum and even doctors do not dare to speak against them.

"Patients coming from rural areas are the worst victim of exploitation by these unauthorised people at the hospital," said a registrar at the medicine ward.

At the female ward, Amina Begum, 60, who from Chilmari in Kurigram, said she does not get her meal regularly.

"A man demanded Tk10 per

meal but I could not pay him". She could not name him. Seeking anonymity, a doctor said a number of third and forth class

employees of the hospital have

engaged the outsiders at the hospital. They have neither training nor education, he added. In every ward, there are five to six such outsiders, engaged by the 'ward sarder (a forth class

employee), who earn Tk200 to Tk 250 a day on an average. Each unauthorised worker pays the sarder Tk 50 a day, he added. Asked, RMCH Director

Shahajahan Bishwas said, "I noticed this when I joined the hospital." He said, he had imposed restric-

tions for outsiders at the hospital "After my order, all employees

now have ID cards hung from their nick so that patients can differentiate outsiders and hospital employees." he said. Abdur Rouf, president of RMCH

trade union, however denied the allegation that outsiders work at the "Fourteen outsiders were engaged last year on the basis of

understanding with some employees. Their contract period is over. Some of them might be visiting wards now for work." he said.
