Manmohan vows to win 'war against terror'

Indian Prime Minister Manmohan Singh said the war against terror will be won and "no one can make India kneel.'

"This is not the first time that the enemies of our nation have tried to undermine our peace and prosperity. These elements have not yet understood that we Indians will never let them win," he said in an address to the nation over television last night.

His speech came a day after the series of blasts in Mumbai suburban trains that left some 200 dead and over 700 wounded.

DEEP SEAPORT Deal signed with Japan firm for feasibility study

UNB, Dhaka

The government yesterday signed a deal with a Japanese firm to conduct a feasibility study for setting up a deep seaport in the country

Under the deal, Pacific Consultant International (PCI) of Japan will complete both technical and economic feasibility of the proposed deep seaport within a year.

Joint secretary of Shipping Ministry Nepal Chandra Sarker and PCI Director Mototoshi Kakiuchi signed the deal on behalf of their respective sides at a simple ceremony at the ministry.

State Minister for Shipping M Quamrul Islam, Chittagong Port Authority (CPA) Chairman SM Shahadat Hossain and Mongla Port Authority (MPA) Chairman Abu Taher were, among others, present

The PCI won the contract offering the lowest cost of Tk 11.27 crore among the three bidders. But the total price of the contract stands at about Tk 13.24 crore after inclusion of different taxes.

The state minister told journalists that with the signing of the deal, the government has virtually entered into the process of con structing a long-awaited deep seaport, which will immensely benefit the nation. "The government has taken the move to construct the deep seaport keeping the country's future business potentials in mind.'

The shipping ministry officials said the contracting firm will carry out its study in nine locations of Bangladesh deep sea territory.

As per the deal, the Japanese firm will cover different aspects of

the project, including the review and analysis of the present situation port administrative and public service participation models assessment of potential market and business opportunities, site selection, site surveys and investigations planning, layout plans, conceptual designs and cost estimates, project

appraisal and the project management for deep seaport development The ministry officials said the PCI will conduct the feasibility study while three local and one Bangkok

based firms will be its associates in work The local firms are Dexterous Consultants Ltd, JEP Consulting

Bangladesh Ltd and Dev Consultants Ltd while the Bangkokbased one is Asian Engineering Consultants Corp Ltd.




Highway for nearly 10-hours yester day, as a truck got stuck on a bridge Kaliakoir causing immense sufferings to the people travelling.

9 killed in Baghdad bombings as Rumsfeld flies in

At least nine people were killed in two bombings in Baghdad Wednesday as US Defence Secretary Donald Rumsfeld arrived to review the security situation in Iraq, security sources said. A suicide bomber walked into a

restaurant in the capital's eastern suburb of Baghdad Jadida, killing seven people and wounding 20, an interior ministry official said.

Two people were killed and two others wounded in a car bomb attack against a police patrol in the Sunni neighbourhood of Adhamiyah. Also in Adhamiyah a civilian was wounded in a roadside bombing

Six Palestinians killed in Israeli air strike

Six Palestinians were killed Wednesday and Hamas's top militant leader reportedly wounded in an Israeli air strike that decimated a Gaza house, as troops pushed a new offensive in the territory.

The armed wing of the governing Palestinian movement, which claimed joint responsibility for the capture of an Israeli soldier, sparking a three-week Israeli aerial offensive, vowed a "strong and painful" response to the attack.

Opening a new front in the Middle East crisis, the Israeli army also launched a ground and air assault on Lebanon after militants from the Shiite movement Hamas said they had captured two soldiers on its northern border.

Israel said Mohammed Deif, the top militant leader of Hamas's armed wing, was wounded in the air raid, without being able to say how seriously.

A Palestinian medical source told AFP that Deif had been operated on but his life was not in danger, adding that another three Hamas military leaders were being treated at the hospital

But Abu Obeida, a spokesman for Hamas's Ezzedine al-Qassam Brigades, categorically denied Deif had been hurt and slammed the "deceitful information intended to cover up Zionist crimes" Israeli army radio reported that

Deif, considered one of Israel's top enemies and wanted for years, had been wounded while in a meeting with at least three other senior




Local medical sources said the six dead were all from the same family and included a Hamas political leader, Nabil Abu Salmeeyah, who owned the house and taught at the Islamic University, his wife and two of his children. Security sources said an F-16 jet

demolished the house in the latest wave of air strikes in Israel's deadly offensive that has killed 60 Palestinians in a week in the hope of freeing a captured soldier and ending rocket attacks. "Our reaction to this massacre

will be painful and strong for the Zionists and we will make the enemy leadership sorry for their crime," the Qassam Brigades vowed in a swift response to the

"Our message to the Zionists is that your leaders are leading you to violence from which no one will be safe and when they target civilians they decided for you to be the target of our resistance. SEE PAGE 15 COL 7
