# Victims give July 22 deadline to meet demands

Stage sit-in, submit memo

Villagers affected by the Tengratila blowouts have given the authorities a July 22 deadline to meet their 6point demand and threatened of

They announced that office of the Canadian company Niko will be locked and a fast unto death by the affected people will begin on the gas

They staged a sit-in in front of the field office premises if the demands gas field office, held a rally and are not met by July 22. The 6-point demand includes payment of Tk 84 crore in compensation for environmental damage proper compensation for the 611 affected families, employment for locals in the gas field, establishment of a gas-based 50 MW power plant

near Tengratila and a health complex, arrangement for supply of safe water in the affected villages. seestablishment of a health complex in the area and inclusion of 28 more affected families who were dropped 'intentionally' from the

compensation list. The affected people did not get compensation even a year after the second blowout and fire that took place in the field on the night of June

They launched agitation afresh to press their 6-point demand as the Canadian company and the government remained silent on the issue of compensation.

Even, the authorities could not settle payment of compensation for the burnt out gas and environmental damage, which has estimated by a government appointed technical

Explosions took place twice during drilling, which caused extensive damage to the ecology. Most croplands in the area have turned uncultivable and greens have been damaged. Pure water is scarce as the explosions polluted water bod-

# A problem ignored for long

#### Patuakhali town protection project gathers dust

It is a perennial problem, ignored by the government for long. Two-thirds area of Patuakhali town go under water during high tide, mainly in the wet season from June to October.

The most vulnerable areas included Puran Bazar, Chalk Bazar, Kath Patti, Nabab Para, Shimul Bagh, Muslim Para, College Road, Sadar Road, Post Office Road, Munsef Para, where 3 to 4 feet water remains stagnant for a day after the tide.

About 50,000 people in these areas suffer a lot as water inundates most of the houses, shops and other establishments.

Patuakhhali town is surrounded by Patuakhali river on the north and Lohalia river on the east. Water from the rivers roll into the town when ever they swell during high tide.

A town protection embankmentcum drainage project, taken up nine years ago, is yet to be implemented.

The Tk 17.27 crore project was taken up after the visit of the then agriculture minister Mazid-Ul\_Haque to Patuakhali in 1997.


The project includes construction 4.20 km flood control embankment and one kilometre wall and installation of seven sluice gates and four power pumps in 38 outlets.

The project is still awaiting approval by the ECNEC (Executive Committee of National Economic

The Water Development Board (WDB) engaged a consulting firm to make a survey to implement the project. The consulting firm-Centre for Environment and Geographic Information Service (CEGIS)-- submitted its report to the water resources ministry in April this year.

Pourasabha Chairman Mostaq Ahmed said the townspoeple held demonstrations on numerous occasions for construction of a protection embankment. They have given up hope as all their agitation failed to draw the attention of the authorities.

When contacted, WDB Executive Engineer Abdul Mazid Mollah said, "We sent several letters to higher authorities to take immediate step to implement the project but to no

### Newsman takes life

Police and family sources said, Krishna Basu had recently started business but incurred heavy losses. He was suffering from deep frustra-

At about 8.15 am, he went to Noapara station and jumped onto the track just before the Benapole bound commuter came. The body was cut into two pieces, police said.

## Three to die for carjacking, killing driver, helper

The Sylhet Divisional Speedy Trial Tribunal has given death sentence to three persons for a double murder in Habiganj in January last year.

The convicts are Masum Ahmed alias Kalam, 32, son of Abdur Razzaque, of Gangpar Purba Bhadeshwar village in Bahubal upazila; Abdus Salalm, 35, son of Abdur Rashid Purba Shahpur village in the same upazila and Sujan Dev, 23, son of Samiran Dev of Purba Barachar Binandapur village in Shaistaganj

The court also fined Tk 5.000 each. The verdict was given by Judge Biplob Goshwami on Thursday. Masum and kalam are absconding

The judge convicted four others to three years' RI and fined them Tk 5,000 each. They are Sohel Khan, Afsar Uddin, Borhanuddin and Sunny Ahmed Sentu, from Demra area in Nartayanganj. Sentu is also absconding.

All of them have been convicted for hijacking a rented microbus by murdering its driver Babul and helper Ashab Ali in Bahubal on the Sylhet-Dhaka highway on January 2

The microbus was rented from Habiganj for a trip to Dhaka.

Bahubal police recovered bodies of the driver and the helper next morning. The microbus was recovered from the possession of Sunny in Demra. After hijacking, the vehicle was sold for Tk.44,000 only.

Habiganjh Sessions Court sent the case to Speedy Trial Tribunal, Sylhet on 22 March this year.

## 2 sisters fight for life at Osmani Hospital

Two minor sisters are fighting for life at Sylhet MAG Osmani Medical College Hospital with serious acid burn injuries. They were admitted to the hospital Thursday morning.

Family sources said, Farzana Akhtar. 14 and Lima Akhtar. 9. sustained serious injuries when acid was thrown on them at about 2 AM Thursday through the window when they were asleep at their house at Khagahata village in Chhatak upazila of Sunamgani district.

Hearing their screams, their parents and other members of the family came and saw the two girls

They were rushed to Chhatak upazila health complex, wherefrom

they were sent to Sylhet MAG Osmani Medical College Hospital.

Police officials visited the remote village, about 35 kilometres off the upazila headquarters. The victims

are students of class VIII and IV. Filing of a case is in process, the victims family told this correspon-

dent at the hospital. When contacted, the Officer-in-Charge of Chhatak thana said previous enmity could be behind the gruesome incident. "We are investigating the matter", he said. Meanwhile, the Sylhet unit of the Committee for Elimination of Acid Violence formed a human chain in front of the Shaheed Minar yesterday demanding immediate arrest and exemplary punishment to the culprits.
