BSP, Noab urge PM to cut import duty on newsprint BSS, Dhaka

The representatives of Bangladesh Sangbadpatra Parishad (BSP) and Newspaper Owners Association of Bangladesh (Noab) yesterday urged Prime Minister Khaleda Zia to reduce the import duty on newsprint paper and increase the rate of government advertisement and its budget.

The prime minister however said the matter would be reviewed at the appropriate level.

She was speaking to representatives of BSP and Noab who called on her at her office yesterday. President of BSP Mainul Hossain, Editor of The Daily Star Mahfuz Anam, Editor of Prothom Alo Motiur Rahman and Editor of Jugantor Golam Sarwar were members of the delegation

Tk 192cr project inflated to Tk 349cr, land price hiked 300pc over three years

To siphon off huge development fund, the communications ministry inflated a Tk 192 crore road construction project to Tk 349 crore by manipulating all components of the scheme, revealed a government investigation

The ministry hired 429 contractors for the earth-filling work of the 61km road construction project from Joydevpur to Madanpur of the Dhaka-Chittagong Highway through Debgram, Bhulta and Nayapur Bazar, meaning each contractor had to fill only 140 metres

The move led to lack of competition among the contractors as well as dominance of incompetent contractors and wastage of resources.

Consequently, the quality of the road has been very poor, said the investigation conducted by the Implementation, Monitoring and Evaluation Department (IMED).

Awarding such a task to so many contractors was in violation of the government rules in the first place. The IMED found that the biggest manipulation in the scheme took place in the case of land acquisition.

In the original project, the ministry sought Tk 18 crore for land acquisition but revised it to Tk 48 crore by showing prices of per hectare land 300 per cent higher than in the original project.

"The three- or four-fold hike in land price within only three years of conception of the project is in no way logical," said the IMED report filed at a meeting of the Executive Committee on National Economic Council (Ecnec) chaired by Finance Minister M Saifur Rahman vester-

DRAFT VOTER LIST EC makes fresh bid to justify its earlier move

The Election Commission (EC STAFF CORRESPONDENT yesterday made a fresh bid to justify its earlier move for publication of the controversial draft voter list prepared in violation of the High Court directives

The EC cited the opinions of its counsel and the attorney general to explain its stand in a working paper for a meeting.

It however did not refer to the issue of law minister's approval of the attorney general's views.

"Counsel for the Election Commission and the attorney general opined that there is no bar or prohibition to initiate steps for preparing the voter list. Depending on the opinion, time limit for related activities including publication of the draft voter list has been fixed," the EC claimed in a working paper for a with meeting SEE PAGE 15 COL 1

Apparently annoyed by the finance minister's repeated refusal, the CEC said the EC is a constitutional body and preparation of the voter list is its constitutional duty.

"As per rules, we sent our budget proposal to the government, not to any person. The government must allocate the money needed by the Election Commission, no matter whatever the amount," Aziz told

The CEC declined to specify the amount in the proposed budget but said, "Of course, we will get the money, otherwise how will the task be done?

The finance ministry earlier allocated about Tk 60 crore for the preparation of the voter list. The EC on May 3 published its controversial draft voter list spending Tk 43 crore. The Supreme Court later declared

the draft electoral roll illegal. There are allegations of misus ng the allocated fund.

"The Election Commission will have to justify the money allocated earlier. No money will be disbursed unless it provides accounts to the point about the expenditure. SEE PAGE 15 COL 4

Dhaka seeks help to evacuate Bangladeshis from Lebanon AFP, Dhaka

Bangladesh has sought help from the Geneva-based International Organisation for Migration to evacuate more than 10.000 of its nationals from conflict-stricken Lebanon.

"The Bangladesh government has formally requested us to evacuate around 10,000 Bangladeshis now living in Lebanon," Dhaka chief of the organisation Shahidul Haque told AFP

The inter-governmental organisation deals with migrants, crossborder trafficking and migrationrelated issues and has offices worldwide

"We have a team in Beirut and they will help evacuate Bangladeshis from Beirut to Damascus by road, and from Damasacus, they will be brought back to the country by air," he said.

There are an estimated 10,179 Bangladeshis in Lebanon, which has been under attack from Israel for the past week. Most of them are migrant workers engaged in construction and textile sectors

At least 55 civilians were killed yesterday as Israeli jets and gunboats pummelled towns and villages across Lebanon and tens of thousands fled an increasingly bloody conflict both sides defiantly warned would have no limit.

Israeli ground troops headed back across the border to strike Hezbollah outposts as another volley of rockets fell on northern Israel on the eighth day of an offensive that the international community has so far done little to end.

Streams of Lebanese were fleeing their homes to find safe havens and thousands of foreigners, mainly Westerners, were being evacuated by sea to the neighbourng Mediterranean island of Cyprus. Meanwhile, seven Palestinians

were killed yesterday as Israeli troops moved into a Gaza refugee camp, pushing a campaign to dier and stop

"The security cabinet met this morning and decided on the continuation of the offensives in Lebanon and Gaza with no time limit," an Israeli official said, describing the military's action as an "intensive war against Hezbollah.

2 JMB men get 48yrs in prison

A special tribunal court in Gaibandha yesterday convicted two Jama'atul Mujahideen Bangladesh (JMB) Ehsar members in an August 17 bomb blast case, sentenced them to 48 years of rigorous imprisonment, and fined them Tk 7.000 each.

The convicts are Ziaur Rahman Badal also known as Reaz and Abdul Quivum. Harun-ur-Rashid. also an accused in the case, was acquitted.

Judge Md Mohsin Mollah of Special Tribunal-2 handed down the verdict amid tight security in side the courtroom. The two accused were found guilty in the case filed under Explosive Substances Act.

According to the prosecution, Rapid Action Battalion (Rab) personnel arrested Ziaur Rahman Badal at Ansari Mosque near Gaibandha Circuit House on January 22 this year with two live bombs and five books on jihad in their possession.

Following Reaz's confessional statement, Rab later arrested Abdul Quiyum and Harun-ur-Rashid.

Two cases, one under Explosive Substances Act and the other under Special Powers Act, were filed in this connection.

After investigation, the investigation officer sub-inspector Abu Farhad submitted a charge sheet against them on February 20.

RMG workers, owners at odds over wage

Garment owners and workers are at loggerheads over fixing a minimum wage for employees as the BGMEA is pursing Tk 1,230 a month while the workers are demanding Tk 3,000.

A six-member board formed by the government last month has already held a series of meetings to re-fix the minimum wage for the workers and will sit again today to settle the issue. The board will have to recommend a new pay scale for the workers in 90 days.



"We would like to give the workers more but we have to consider the financial abilities of the factories. MUHURI MURDER CASE HC upholds death sentence of four

The High Court (HC) yesterday upheld a lower court verdict awarding capital punishment to four convicts in the sensational Muhuri murder case of Chittagong. A death reference bench of the

HC also confirmed life imprisonment of two of the four persons in the case and acquitted two.

The HC also upheld the lower court acquittal of four of the accused persons.

The convicts with death penalty are Nasir alias Gittu Nasir, Shafiul Azam, Alamoir Kabir alias Baitta

Alamgir and Taslim uddin Montu. Of the four, Gittu Nasir was killed in crossfire with Rapid Action Battalion (Rab) on March 2 last year and the others are in jail.

The two given life-term are Mohiuddin alias Mohinuddin and Habib Khan, both absconding.

The other two, whom the lower court had awarded life-term but the HC acquitted, are Saiful Islam alias

Chhoto Saiful and Mohammad Shahiahan, Criminals killed Saiful on 29 June, 2004, at his house.

Four others acquitted are Prof Mohammad Idris Miah Chowdhury, Prof Mohammad Zahurul Haq, Prof Tofazzal Ahmed and Nasir alias Shibir Nasir.
