Frequent power outage protested in Gaibandha

People from all walks of life formed a two-kilometer long human chain and held a rally at Dariyapur on the outskirt of Gaibandha town protesting frequent power outage in six upazilas of the district.

The programmes were organised by Palli Bidyut Grahak Sangram Samity, a newly formed civic body. The upazilas are under the command area of Gaiabandha Rural Electrification Association.

The protest meeting held at Dariyapur Bazar was addressed by, among others, Sangram Committee Convener Hasan Mahmud Siddique, Ahsanul Habib Sayeed, Kabir Mondal, Mihir Ghosh, Aminuzzaman Rinku, Sultan Ahmed, Sontosh Barman

and Ali Ahsan. They said, apart from creating sufferings to people, the frequent power outage is affecting operation of small mills and factories, household units like poultry farms and agriculture in rural areas

According to sources in the Rural Electrification Association, there are about 41,900 consumers in six upazilas in Gaibandha district. Every day, it needs 15 MW power electricity but only 6 MW during day time and 2 MW at night. Consumers in rural areas alleged that on an average, they

get power supply hardly for 3-4 hours a day. Power goes several times in a day, and they have to spend most of the nights without electricity, they said.

registration officials have been appointed at field level in the district to update the voter list About 6000 people were

engaged to prepare the draft voter list a few months back, he said. "Though it is a tough job to complete the work in 10 days, I hope they will be able to do it", he said. The voter updating must be completed by August 10, as fixed by the Election Commission

7.8 per cent of the new voters out of 3,15,000 (listed a few months back) were enrolled in last 10 days. The work will be hastened in next 10 days as the enumerators will be relieved of their work at schools, he Most of the enumerators (assisting officers) have been recruited from among schoolteachers

UPDF activists kill son of PCJSS man 9 killed in 15 days OUR CORRESPONDENT, Khagrachhari

Armed activists of the United People's Democratic Front (UPDF) Sunday night shot dead son of an activist of rival Parbatya Chattagram Jana Sanghati Samity (PCJSS) at a remote village in Chaillatali Donga Para in Laxmichhari upazila.

The dead is Milon Kumar Chakma, 18, son of Rashik Kumar Chakma, 40, an active member of PCJSS, sources said.

Local people and security sources said, a group of UPDF activists attacked the rice mill of Rashik Kumar. In his absence, they caught his son Milon and killed him in a brush fire.

Police recovered the body and sent it to Khagrachhari Sadar Hospital for autopsy.

Local people and security sources said the attackers demanded Tk 1 lakh as ransom from Rashik. As he refused to pay the ransom, the raiders killed his son, security sources said.

Our Rangamati Correspondent said: At least nine persons were killed and 10 others injured in clashes between the PCJSS and the UPDF over establishing supremacy in different areas of Chittagong Hill Tracts in last 15 days.

The clashes restarted on July 9 after a pause for a few months. Three UPDF activists including an elderly woman were killed and two others were injured as a group of PCJSS activists attacked their stronghold at dead of night at New Karetchhari of Kutukchhari union in Sadar upazila

The dead are Tulumoni Chakma, Sushil Chakma and Premolata Chakma while the injured are Sontosh Chakma and Sidhe Chakma

The July 9 incident infuriated the UPDF activists who launched attacks on the PCJSS activists. One person, Parban Chakma was killed while two others were injured in a clash at Dhudukchhari of Panchhari upazila in Khagrachhari on July 19.

The next day, PCJSS activist Kalpa Chakma succumbed to his severe bullet injuries following attack by the UPDF at Logang village in the same upazila in Khagrachhari.

Indigenous people resist community afforestation bid

Locals in Bhaluka demand partnership; case against 31

A case has been filed against 31 indigenous people for allegedly 'foiling an afforestation programme' in government forests in Dakatia union in Bhaluka upazila of Mymensingh district.

Forest Officer Saidul Islam of Angargara bit filed the case with Bhaluka police station Saturday night. The accused people are from Dumneeghat and Chhitnipara villages in Bhaluka.

On Saturday, hundreds of indige-nous people from Dumneeghat and Chhitnipara villages resisted forest officials and employees when they went there to plant saplings under a 'community afforestation programme' covering 75 acres in Dakatia and Angargara villages. Bhaluka police rescued them.

Leaders of local indigenous people told journalists on Sunday that forest officials were pressing them for about three months to participate in the programme without any partnership deeds. They wil not allow the afforestation without

Dinajpur Medical College was closed sine die Sunday following JCD-Shibir clashes in which about 60 students were injured.

The students were leaving their dormitories till filing of this report yesterday. Sporadic clashes took place between JCD and Shibir on Saturday and Sunday over control of a hall room.

Of the injured, 11 ICS activists were admitted to Rangpur Medical College Hospital (RMCH) in a critical condition while others were shifted to other hospitals and clinics.

The Dinajpur Medical College academic committee, at a joint meeting vesterday, formed a fivemember probe committee led by Dr Mosaddeque Hossain to investigate the matter. The committee was asked to submit its report within three days of its formation.

Campus sources said, JCD activists ousted ICS cadres from the room Saturday afternoon triggering violence. Both the clashing groups used lethal weapons including Chinese axe, hammer, iron rod and bi-cycle chain during the clash.
