After the hearing from the prosecution and the defence on the discharge petitions filed earlier, Judge Malik Abdullah Al Amin of the Special Court for Dhaka Division will decide whether the charges would be framed against Ershad and others.

CASE AGAINST ERSHAD, MANJU In the first case. Ershad and former energy and mineral resources minister Anwar Hossain Manju are accused of causing a loss of \$79,000 to public exchequer.

Bhuiyan to sit with Jalil if proposal comes

She also asked the field level leaders to work unitedly to ensure the victory of party candidates in the next elections.

127 killed as clashes flare up in Lanka

Fierce fighting between government troops and Tiger rebels in north and eastern Sri Lanka yesterday left at least 127 people dead and another 280 wounded, the military said.

Up to 500 rebels from the iberation Tigers of Tamil Eelam (LTTE) attacked across a de facto front line in the northern Jaffna peninsula and a nearby islet, militarv spokesman Athula Jayawardena said

"We estimate at least 100 to 150 Tigers were killed and 200 to 250 were wounded," Jayawardena told reporters here.

"We had our share of casualties too with three officers and 22 other rankers and two sailors killed. Eight

officers and 72 other rankers were wounded. They have all been evacuated for treatment.

The fighting lasted nearly 10 hours as the querrillas fired heavy artillery towards military bunkers as well as the main airfield of Palaly on the northern edge of the peninsula,

An airforce Bell 212 helicopter as well as other equipment were damaged, he said, but rejected a report on the pro-rebel tamilnet.com website that the querrillas used an aircraft to attack a government

"We didn't see even a kite of the Tigers," he said. The military repulsed the guerrilla offensive and carried out aerial attacks late Saturday against Tiger gun positions also in the north, he said.

However the Tiger rebels claimed the military initiated the fighting on Friday in Jaffna and in eastern Batticaloa and continued attacking on Saturday.

"The Government of Sri Lanka launched a two-front offensive in Jaffna district and Batticaloa district (in the island's east) on Friday, causing hundreds of civilians to displace," the LTTE said in a state-

The navy said the Tigers had also fired artillery at the main naval and air forces bases in the northeastern district of Trincomalee, but troops retaliated

Israel triples troops in Lebanon after UN resolution

Israel poured thousands of extra troops deeper into Lebanon vesterday after launching a broad "openended" offensive despite a unanimous UN Security Council call for an end to the month-old war.

At least eight Lebanese civilians were killed in air attacks that also destroyed a power station in the war-rayaged south, and hit roads leading to Syria in the north.

Israel said it had tripled its troop numbers in Lebanon and warned the expanded ground operation could last for weeks as it struggled to deliver a knock-out blow to Hezbollah querrillas

But international envoys in the region called for a ceasefire to take hold rapidly after the Lebanese and Israeli governments give their approval to the UN resolution hammered out after days of diplomatic

"The cessation of hostilities should take place as soon as possible. Too many lives have been lost.' said Geir Pedersen, the representative of UN chief Kofi Annan in Lebanon.

But Israel pressed ahead with a broader assault aimed at wiping out Hezbollah from border areas and halting rocket attacks, hours after the UN Security Council unanimously adopted Resolution 1701 calling for a cessation of hostilities and deployment of a 15,000-strong international force.

"We have multiplied by three the number of our troops operating in Lebanon," Israel's army chief Dan Halutz said. He gave no figures, but an estimated 10,000 troops were already believed to be operating inside

A top military official had said that four divisions -- between 24,000 and 40.000 -- would take part in the expanded offensive.

The military said the new ground operation could extend up to the strategically important Litani River. which runs up to 30 kilometres (19 miles) from the border.

'This is a phased plan and the first stage allowing us to control the ground could take a few days," said General Alon Friedman, a senior commander in northern Israel. 'Cleaning up operations will follow, in a stage that could last a few days

The clash left some 15 students and SI Abdul Latif injured. They were taken to Kulaura Hospital.

The Shibir activists launched fresh attacks when the all-party student group brought out a procession at the Kulaura upazila headquarters in the afternoon.

Hizbut Tawhid men to be quizzed by JIC

The seven suspected militants of Hizbut Tawhid arrested Thursday night will be sent to Dhaka for guizzing by a Joint Interrogation Cell (JIC) team to unearth information on the organisation's activities, sources said yesterday.

They were placed on a ten-day remand yesterday at Bandar Police Station.

The police in separate raids arrested sub-assistant engineer of Chittagong Urea Fertiliser Ltd (CUFL) Abdul Hamid Mian, Suncrest Cola officials Humayun Kabir, Mohammad Raju and Jamal Uddin, and Munir Khan, Mohammad Akkas and Nurul Islam Khokon in Fakirhat and Chittagong Export Processing Zone (CEPZ) areas on Thursday night.

The seven are active members of the Hizbut Tawhid, an Islamist organisation that aims at establishing Islamic rule in the country through armed revolution.

The organisation has been operating in the country since 1994 under the direction of its country chief Bavezid Khan Panni, a cousin of former deputy speaker of parliament Humayun Khan Panni

It has around fifty members including females in the port city. The female members of the organisation conduct their activities persuading the neighbours by distributing Islami books and leaflets. The male members gather at the

residence of Humayun Kabir, ameer

of north division of the organisation's city unit, in the city's Shantibagh area every Monday at 8:00pm. Humavun's wife Rabeva Bashri who is also an active member of

Hizbut Tawhid, told The Daily Star that they have been working in the city for the last five years. She denied having any connec-

tion with the outlawed Jama'atul Mujahideen Bangladesh (JMB). "The police arrested my husband and others without any specific allegation and the Hizbut Tawhid has no military section or militant activities," she said. She, however, expressed satis-

faction over her husband's arrest, saying, "It will give our organisation and its activities better publicity and more people will be able to learn about us by reading newspaper reports.

Humayun's colleagues at the Suncrest depot at Dhanialapara became astonished after hearing about his involvement with Hizbut Tawhid. "We knew him as a polite person involved with some Islami organisation but we had no idea

Bangladeshi expatriates in Lebanon are now passing their days in mounting panic and uncertainty as air strikes, bomb blasts, destruction of buildings and roads and killing of civilians continue unabated in the war-ravaged country, returnees from Lebanon say.

All their hopes are now shattered as many of their employers have been killed or have left the country for safety, forcing them to live on the streets and return home with very small amounts from their earnings or empty handed. The returnees are happy that

they are back home but worried over their future as they had to leave major part of their earnings with their employers. Many of them said they also heard of the deaths of some

Bangladeshis in the war-torn

Lebanon but the authorities in

Dhaka said no killing of Bangladeshis was reported.

They shared their experiences on their return to Zia International Airport (ZIA) at 4:45am yesterday from Lebanon. A special chartered flight of

Middle Eastern Airlines (MEA) flew 252 Bangladeshis from Damascus to ZIA where Qatar Charity gave them Tk 2,000 each and the expatriates' welfare ministry Tk 500 each. The government, with financial assistance from the International Organisation for Migration (IOM),

brought them home from the Syrian capital where they had gathered following registration for returning home. The total number of returnees rose to 534 so far. "Wherever you go, horror runs

after you. Bombs, fires and smokes are daily incidents in Lebanon. Nobody in that country is safe, let SEE PAGE 15 COL 3
