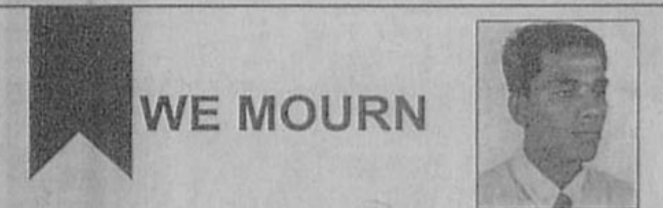

CARE Bangladesh entered into an agreement with USAID and subsequent agreement with Government of Bangladesh for a program entitled SHOUHARDO (Strengthening Household Ability for Responding to Development Opportunity) for the period of October 2004 to September 2009. The goal of which is to improve availability and economic access to food for targeted vulnerable and poorest people living in the deep Chars, Haors, Coastal Areas and Urban Slum of Bangladesh. Under this agreement, CARE Bangladesh received the following commodities from USA for using under SHOUHARDO Program.
