PKSF-SDF jt initiative for Monga mitigation

Social Development Foundation (SDF) and Palli Karma-Sahayak Foundation (PKSF) will launch the 2nd phase of 'Monga Mitigation Initiative Pilot Project (MMIPP)' this year to provide employment opportunities and livelihood assistance to Monga-affected families in four north-western districts, says a press

The four districts are Kurigram, Gaibandha, Nilphamari and Rangpur. The project will cover about 18,000 families to benefit 90,000 hard-core poor directly and 1.10.000 indirectly

Under the MMIPP-II, the beneficiaries will be provided with training in livelihood activities that will help them to overcome the onslaught of Monga. The trained beneficiaries will be provided with a flexible micro-

credit under 'Ultrapoor Programme'. However, the most vulnerable members will be supported with

monthly allowance of Tk 600 during September-December. Moreover, 'Cash for Work' will be implemented in order to generate employment opportunities.

This programme is aimed at preventing advance sale of labour by ultrapoor/hard-core poor and ensuring food security during Monga. PKSF, SDF and PO will jointly monitor all activities under MMIPP- II. A Memorandum of Understanding (MOU) between PKSF and SDF was signed on August 23 in this respect.

Fakhruddin Ahmed, managing director of PKSF, Muhammad Fazlur Rahman, managing director of SDF. Mosharraf Hossain Khan. deputy managing director of PKSF and officials of the two organisations were present at the signing cere-

2 Ctg restaurant owners jailed

A mobile court in an antiadulteration drive at the city's Sadarghat area yesterday fined two restaurants Tk two lakh and awarded imprisonment to the own-

ANTI-ADULTARATION DRIVE

During the drive the court fined Café Al Munir and Shah Badar Hotel and Restaurant Tk 50000 and Tk 1.5 lakh respectively for producing, preserving and serving foods in an unhygienic condition.

Chittagong Port Authority (CPA) Magistrate Mohammad Munir Chowdhury led the anti-adulteration drive with the help of Chittagong Metropolitan Police (CMP) and officials of Bangladesh Standard Testing Institute (BSTI). The court awarded Mohammed

Yousuf, 45, owner of Café Al Munir, seven days rigorous imprisonment (RI) while Kajal Chandra Ghosh, 35, of Shah Badar Hotel and Restaurant, was awarded 15 days RI, sources said.

Both of them were sent to Chittagong Central Jail in the afternoon after realising the fines,

The court found that Café Al Munir was producing and serving food in an unhygienic condition and preserving lower quality ghee, flour, milk and spices in its storeroom.

On the other hand, the court also found unhygienic condition in the

Shah Badar Restaurant and seized 1200 Kg of label-less tea, sugar salt, condensed milk, palm oil and

insect infected products including pulse and turmeric, sources added.

Foreign investors should up equity

within acceptable limits, he added. Salehuddin was talking to journalists at his office after a meeting

with non-bank financial institutions. He said many foreign companies while registering with the Board of Investment (Bol) say they would operate on an equity-debt ratio of 60:40, but in practice they do the opposite, keeping the ratio at 30:70.

"We have suggested that they maintain a debt-equity ratio of 50:50," he said. Besides, the BB has asked the

foreign investors to offload a portion of their shares in the local capital market to increase the equity, added the governor. He observed that in many coun-

tion in the early years of investment and offload their shares only when the profit becomes thinner. Eyeing a long-term benefit for the country's economic health, we are trying to persuade the compa-

tries the foreign companies take

advantage of large profit repatria-

nies to offload their shares in the local stock market," he said. Regarding the BB measures, he said the central bank has already issued letters to different companies. But it is not possible to set any rigid guidelines or force the multinationals to offload shares, he said.

"We have already asked many companies to start the process of off-loading," Dr Salehuddin said adding that some of the companies have been asked to float shares by

2007 and some by 2008. Commenting on the external balance sheet, he said in the last fiscal, the country's balance of payments suffered a deficit due to a decline in FDI and lower aid inflow. In FY 05-06. FDI declined by 15

per cent while foreign aid by 2 per cent, according to BB statistics. The balance of payments in the last fiscal reported a deficit of \$ 24

million while in the preceding year it had a surplus of \$784 million The BB governor noted that the investment inflow into the country last year decreased because of lower fresh investment and slow-

down in fresh reinvestment of the foreign companies "The lower external aid has also contributed to the dip in FDI," he said adding that despite the set-

back, the trend of FDI is still good. Speaking on the country's previous records, he said that FDI inflow made a 'quantum jump' in FY 04-05. It rose to \$800 million from \$385

million in FY 03-04 However, the FDI coming down

to \$675 million is not worrisome, he

Four get life in Sajib murder case

Four people were sentenced to life imprisonment in the sensational Sajib Murder Case yesterday.

Three others were acquitted as the prosecution failed to prove the

charges brought against them. Additional District and Session Judge Golam Morshed of the Special Tribunal Court in Satkhira delivered the verdict in presence of all but one accused in a crowded courtroom.

After examining 20 witnesses, the judge pronounced the verdict. The convicts are Abdul Alim of village Gangnia, Akhtarul Islam Moina and Anowarul Islam Anu of village Bahera and Abdul Karim Gazi of

village Alipur under Sadar upazila. The acquitted are Shafiqul Islam Bhutto, Sakina Khatun and Anisur

Of the accused Abdul Alim has been absconding since the incident. The prosecution story in brief is that

victim Sajib, 7, son of Prof Manirul Islam of Bahera village under Debhata unazila was slaughtered in a nearby bush on August 30, 2002.

The victim's father had filed a case with Debhata Police Station. After investigation the Criminal Investigation Department (CID) submitted a charge sheet before a magistrate's court at Satkhira against

seven people on March 26, 2003. The investigation officer (IO) in the charge sheet said victim's father had a long standing land dispute with Anowarul Islam.

Sajib had to pay his life for witnessing a love affair of Anowarul's daughter with a local boy, the IO added

KILLING OF RANA None arrested vet

None has been arrested yet in Rana murder case, a college student who was beaten to death at Dhaka Dental College dormitory at Sobhanbagh for allegedly stealing a cell phone.

Jahangir Miah, the investigation officer (IO) of this case claimed that a mobile set went missing from the dormitory half an hour before the incident.

Dormitory students might have killed Rana suspecting him to be the stealer, as stealing is a frequent incident in the dormitory, he added.

"Many of our valuables went missing from the dormitory on different occasions" claimed a dormitory student. Besides, police suspect Rana

to be a drug addict who might have come to the spot to take Family sources, however,

blame Shujon, who took him to the dormitory on that day, to be allegedly involved in the murder due to previous enmity.

"Shujon deliberately killed Rana who once had beaten Shujon following some internal feuds a year back" added the family sources.

Police informed that they are yet to arrest anyone in this connection as they are not sure whether it was a pre-planned murder or mob beating.

Saiful Alam Rana, an HSC examinee, was beaten to death by Dhaka Dental College dormitory students on August 17 allegedly for stealing a mobile phone.
