One last shot at gold!

Bangladesh have a realistic chance to win their second and probably, the last gold medal at the 10th South Asian Games when hurdler Mahfuzur Rahman Mithu gets into action today, the second day of the athletics competition.

Mahfuz, only the second hurdler in the 13-member athletics team. will compete in the 110m hurdles this afternoon at the tracks of Sugathadasa Stadium.

He will be facing stiff competition from Pakistan, who bagged both the gold and silver at Islamabad 2004.

Bangladesh coach Kitab Ali told yesterday that SA Games gold medalist Abdul Rashid was ignored for the Pakistan squad but they have brought a new face whose recent timing is 14.18s.

"Mahfuz won the national championship in 14.10s (hand timing), which means around 14.35s in electronic timing. His timing has bettered during preparation. I am hoping he could finish in 14.20.

"I am expecting an exciting battle as both Mahfuz and his Pakistani opponent are making

their first international appearances. Mahfuz needs to hold his nerve if he wants to win as he has been put under pressure by colleagues to win a gold," Kitab told.There was however bad news for the men's 4x100m relay team as top sprinter Masudul Karim injured his little finger in the left hand during baton change at

The men's team compete in today's final event but Kitab Ali was worried about Masudul, who is the most important member of the relay team.

"He was in tremendous pain last night and has received treatment. He will have to run with a bandage. I am more hopeful to win a relay medal, so we might have to sacrifice his 200m sprint today. We need him to recover before tomorrow's relay," the coach informed before yesterday's men's 200m heats.

Hafizul Islam, Shamsuddin, Mohon Khan are expected to team up with Masudul with Al Amin as a reserve for the relav.

The two female jumpers meanwhile will find it hard to win a medal. India's top athlete Anju Bobby

George will start as favourite to win the long jump after recovering from an injury while Bangladesh's Fouzia Huda Jui, who won silver in Pakistan two years ago, will be under pressure to be among the pete in high jump.

The Bangladeshi women also compete in 4x100m relay. Nazmunnahar Beauty, Shamsunnahar Chumki, Sumita Rani Das and Ishrat Jahan Eva make the women's relay team.

The hockey competition concludes today with India defending their gold medal against archrivals Pakistan in the final at Matale. Earlier on the day, Bangladesh will take on hosts Sri Lanka at the same venue for the bronze play-

Row might split ICC: Pak boss

Pakistan's sports minister has warned that the ball-tampering row which blew up here last week could split cricket's world governing body.

Mian Shimam Haider said there was a "real possibility" Asia's four Test-playing countries would form a faction within the International Cricket Council (ICC) over the row, which has prompted racism claims against umpire Darrell Hair.

"He's been controversial. He had done the same thing with the Indians, he had done the same thing with the Sri Lankans, Bangladesh, Haider told the BBC.

"There could be groups and the ICC would be divided into two groups."

The minister called for the ICC to withdraw the claim that Pakistan cheated in the fourth Test against England or bring evidence to prove it.

"We feel they should withdraw these allegations or if they have the cameras, they have the proof, they can prove it. If they prove it, fine, we

Pakistan refused to return to the field after tea at The Oval in protest at Hair's decision to punish them for ball-tampering, prompting the Australian official to call the first forfeit in Test history. Pakistan's President Pervez

Musharraff has also weighed into the dispute, a move endorsed by his sports minister.

"I think the president did the right thing. He had to support his team,

Speed on peace mission

International Cricket Council (ICC) chief executive Malcolm Speed was said to be flying in to London from the governing body's Dubai headquarters to help broker a deal that could keep Pakistan's tour of England on track after the fall-out from last week's ball-tampering controversy at The Oval.

"We have an indication from our lawyers that they have information Malcolm Speed is likely to be coming," said Pakistan Cricket Board (PCB) chairman Shaharyar Khan at the team's London hotel on Wednesday after meetings ended with the future of the upcoming oneday series against England still

Officials from both boards met before Pakistan's players, who earlier in the day had taken part in a closed training session at Lord's, held a meeting amongst themselves as they too considered the fall out from the ball-tampering row which cut short last weekend's fourth and

final Test Pakistan had threatened to boycott the five-match one-day series if captain Inzamamul Hag was banned as a result of charges of ball-tampering and bringing cricket into disrepute following their forfeiture of the fourth Test against England at The Oval.

A disciplinary hearing was due to take place on Friday in London but was postponed Wednesday because of the unavailability of International Cricket Council (ICC) chief match referee Ranjan le, who had been due to

hear the case.

In a statement Speed said he thought it would be "extremely difficult" to reschedule the hearing during the one-day series proper which starts this coming Wednesday in Cardiff.

Later in the day England and Wales Cricket Board (ECB) chairman David Morgan met with Pakistan counterpart Shaharvar and Inzamam for more than 30 minutes with the Welshman refusing to reveal afterwards what had been discussed.

Inzamam faces the possibility of a two-match limited-overs ban for ball-tampering and an eight-match suspension for bringing the game into disrepute -- but it is the lesser charge, with its associations with cheating which is causing most anxiety to Pakistan.

Woolmer staying put

Bob Woolmer said Thursday he would remain as Pakistan coach but admitted he had contemplated resigning in the wake of the balltampering row that has threatened to wreck the team's tour of England.

And, in a separate announcement, Pakistan Cricket Board (PCB) chairman Shaharyar Khan, also on London, insisted the side would go ahead with the one-day international leg of the tour.

Woolmer, who some press reports suggested was on the verge of resigning, told AFP: 'Throughout this whole affair I have

remained solidly behind the Pakistan team and captain.

'I did contemplate resigning as I am 58 and at an age where I do not need these things in my career and life." the former England batsman admitted

"I was very 'down' at the time but I feel it is important now to stay strong at this time.

"I have always been 100 per cent with the team and the captain," Woolmer, keen to stress there was no rift between himself, skipper Inzamamul Haq and the players,

Pakistan threatened to boycott the remainder of their tour if captain Inzamam was banned as a result of charges of ball-tampering and bringing cricket into disrepute following their forfeiture of the

fourth and final Test against England at The Oval.

His case was due to be heard in London on Friday but the hearing was delayed because of the unavailability through personal reasons of International Cricket Council (ICC) chief match referee Ranjan Madugalle to hear the case.

However, Shaharyar said there would be a meeting in London on Friday between legal representatives which he was confident would produce a new date and venue for the hearing. "A team of ICC legal experts are

coming and they will meet with Pakistan's legal experts. We will know the new date of the hearing on Friday.' He added there had been no

Howard bats for Hair

notable scorer with 97

Australian Prime Minister John Howard weighed into the Pakistan cricket controversy Thursday, saying the game would descend into "chaos" if umpires did not receive support when enforcing the

While refusing to comment on specific issues arising from Australian umpire Darrell Hair's involvement in the ball-tampering controversy. Howard said umpires deserved support for applying the

"I always believe that umpires

and referees should be supported

by the governing body of the game, Howard told public radio. "There are rules and, provided the rules are followed and properly

applied, then the umpires should be supported "Once you start cutting and running from supporting umpires,

vou have chaos. Asked if he gave Hair his full backing, Howard said: "I'll leave that to the International Cricket Council."

The crisis erupted last Sunday when Hair and fellow umpire Billy Doctrove ruled Pakistan had forfeited the Fourth Test against England when they refused to take to the field after tea in protest at a ball-tampering allegation. Howard's position is at odds with

Pakistan President Pervez Musharraf, who phoned national captain Inzamamul Hag after the incident to express his support for the protest. The prime minister said he

hoped the matter would be resolved because Pakistan was a great cricketing nation. "Their president is a cricket fanatic, like I am, and I just hope that

the matter is resolved and we go back to normal operations," he said. Howard also involved himself in the previous controversy involving Hair, when the umpire no-balled Sri Lankan spinner Muttiah

Keeper keeps SL on gold course

Goalkeeper and captain Sandun Devinda stopped four penalties including three in the shootout to keep Sri Lanka's hopes alive to win their first football gold medal in the history of South Asian Games.

The hosts, down to 10 men, edged India 6-5 in tiebreaker after the regulation and extra times ended 1-1 in the first semifinal here vesterday to reach the final of the 10th edition of the biennial regional

The first 90 minutes ended goalless at the Sugathadasa Stadium but the match came alive in extra time as Sri Lanka's Lochana was sent off for his second bookable

offence after three minutes. India took the lead in the 98th

minute when Lalramluaha scored from a freekick and looked set to book a place in the final when they won a penalty in the dying moments of the first-half.

But Sandun saved the 12-varder from India skipper Zaidin to keep the home side in the game. Sri Lanka were fortunate to force a draw when defender Perera cancelled India's lead from a controversial penalty one minute from the final whistle.

Indian defender Hirohito, who handled the ball to concede a penalty against Bangladesh in the group stage, similarly threw a lifeline to the home side while trying to clear a freekick. However, it was harsh from the referee to award a penalty as the ball hit the arm of the defender rather than him handling it intentionally.

In the nerve wrecking shootout, both sides were locked 4-4 after five shots each. In the sudden death, there was more drama, both sides missing their first chances and
