Alliance tickets for JP will be a big blow for Jamaat

Jamaat-e-Islami's plan to expand it's network in greater Rangpur and Dinajpur districts and bag more seats in the coming election by using BNP's 'shield' will be shattered if Jativa Party joins the fourparty alliance, according to political observers.

There are 33 parliamentary seats in the region22 in greater Rangpur and 11 in greater Dinajpur.

Contesting alone, Jamaat fielded candidates in all the seats and got only two seats in the region in 1996 election. BNP got three seats two in Panchagarh and the other in Dinajpur Sadar. Awami League got 10 seats and the rest 18

Using BNP's influence in the name of alliance in 2001 election, Jamaat got four seatsNilphamari-1, Gaibandha -1 and Dinajpur-6 and Dinajpur-1.

Of the rest 30 seats, JP bagged 14, BNP 9, and AL got 6 in 2001

The constituencies from where Jamaat contested in 2001 election are Thakurgaon-1(Abdul Hakim), Dinajpur-1 (Abdullah Hil-Kafi), Dinajpur 6 (Azizur Rahman), Nilphamari 2 (Abdul Latif), Nilphamari-3 (Mizanur Rahman Chowdhury), Lalmonirht-1 (Abu Hena Md Ershad Hossen), Lalmonirhat-2 (Md. Mozibur Rahman), Rangpur-1 (Abdul Gani), Rangpur-2 (ATM Azharul Islam), Rangpur-5 (Hifizur Rahman), Kurigram-3 (Abdul Latif),

Gaibandha-3 (Prinicpal Nazrul

In the coming election, Jamaat is demanding seats as a partner in the ruling alliance.

Jamaat is demanding 28 seats in the region and 60 across the country in next election.

Sources said, Jamaat targeted this region as it is a poverty stricken and the people are religious and

simple-hearted. It's prospective candidates have already started campaign in their respective areas.

The party has changed campaign tactics. It is not shouldering the government's alleged failure in checking price spiral, maintaining law and order and incidents of harassment of opposition leaders and minority community people at

It is blaming BNP for these and trying to prove its innocence, taking the advantage of having no party representation in parliament from the areas concerned, political observers said.

In campaign, Jamaat leaders tactfully avoid other issues and concentrate only on political issues, mainly criticising Awami League.

A number of BNP leaders talking to this correspondent said Jamaat's campaign policy in the region is to keep them aloof from non-political issues to present themselves as 'clean man'. At places, they even shift the blame on the prime minister, the BNP leaders said.

But Jamaat's dream has been

shattered with the possibility of JP's

joining the alliance. JP is claiming most of the sets in this region in the coming election. The JP central vice president

Ahsan Ahmed said that JP has strong footing in the region. He said JP bagged 14 seats in last election and its candidates got more than 40,000 votes in other 14

constituencies. "The polls scenario is better for JP now because of government's failure in ensuring power supply, price hike of essentials and rise of militants during the government's


tenure". Ahsan said He claimed that it is not Jamaat but JP that deserves alliance nomination in all the seats in greater Rangpur and Dinajpur.

He claimed that his party candidates are in better position now in constituencies where Jamaat won with alliance ticket in last election.

He said his party, with alliance nomitees, would rout Jamaat from greater Rangpur and Dinajpur.

Wen contacted, Moniruzzaman Nontu, vice-president of Nilphamari district Jamaat and convener of sadar upazila unit of the party claimed that his party is in good position in many of the constituen-

He said Jamaat has good organisational strength with dedicated leaders and workers. We were in second position in many constituencies before 1996 election and our position has improved, he

Doctor denies removing kidney

A doctor here facing a charge for removing a kidney from a patient yesterday denied the allegation.

Dr Abu Sayeed at a press conference at Brahmanbaria General Hospital said he removed a stone from a kidney of Nasir Uddin. A false case has been filed against him to harass him, said the doctor.

Dr Abu Saveed performed an operation in one of the kidneys of Nasir Uddin Chowdhury of Mahammadpur village in Madhabpur upazila on April 18 2005 to remove a stone from it.

On July 21, 2005, Nasir Uddin relative of Habzo Mia, went to Saudi Arab for a job. He returned home on May 4 this year as he was found physically unfit.

Back to Bangladesh, Nasir Uddin did a lot of lests at differernt hospitals in Habigani, Madhapur and at repued liagnostic centres in Dhaka

All the reports said that Nasir lost his left kidney. On June 10 this year, Nasir's

relatives rushed to Dr Abu Sayeed nd showed him all the test results. Nasir Uddin's relative Habzo Mia then filed a case with a First class Magistrate court against Dr Abu Sayeed on August 27, alleging that

the doctor removed a kidney from

Nasir Uddin's body and sold it.

A showdown aimed at next polls

Taking the advantage of countrywide hartal enforced by the 14-party combine, Rajshahi district Awami League president Taiul Islam Md Faruk and his followers yesterday staged a showdown in his constituency in Puthia-Durgapur upazilas.

Faruk started the showdown from Durgapur at around 3pm in two private cars and nearly 100 motorcycles. His workers in more 100 motorcycles joined him at Ashraf's Crossing on Dhaka-Rajshahi highway.

Faruk's motorcade went to Belpukur crossing where he addressed a roadside meeting.

The motorcade then went to Bhallukgachhi union in Puthia uapzila and Faruk addressed another meeting there, organised by local AL.

The showdown drew flak from party leaders who, seeking anonymity, said this would create a bad impact among people

"His work will make us ashamed", said an AL leader.

Faruk was not available on phone for comment. His aides said he was busy in party activi-

New Gaibandha AL body triggers protest

A section of Gaibandha district Awami League leaders and activists brought out a procession in the town Tuesday evening rejecting the newly formed 71-member district committee, saying dedicated leaders have not been

included in it. The new full-fledged committee headed by Mohammed Khaled as president and Abu Bakker Siddique as secretary was announced in Dhaka on Sunday.

Party sources here said the party may face a split in Gaibandha because the new committee has been formed by avoiding 'dedicated leaders'. This has been done under the influence of some vested quar-

Many 'unknown' people have been included in the new committee, they said.

The committee has been formed to serve purpose of some individuals, Saiful Alam Saka, a 'deprived' leader, told this correspondent vesterday.

Saiful and some other 'deprived' party leaders blamed Mahbub Ara, a close aide to party chief Sheikh Hasina, for formation of the commit-

tee 'just to make her men happy'. Many leaders like Ahsanul Karim Lachu. Abdur Rashid and Abdul Hye have been dropped from the committee. Even general secretaries of Shaghata, Fulchari and Gobindaganj upazila unit are not in the district committee, they said.
