Handover of Ctg airport to Thai airline uncertain

Handover of the management of Shah Amanat International Airport in Chittagong to a foreign company, which was due today, has now become uncertain as the government is still undecided over the matter on the backdrop of possible opposition by the port city people before general elections.

The Thai Airways is supposed to takeover the management of the second largest international airport of the country for a period of ten years as per an agreement signed on December 1 last year with the Civil Aviation Authority of Bangladesh (Caab), the owner and operator of the airport.

The Caab chairman, Air Commodore AKM Harun Chowdhury, however, said the airport's handover is under process and they are ready to give its charge

Meanwhile, the government sought more time from the Thai Airways to complete the handover process, sources in the Ministry of Civil Aviation and Tourism said, adding that execution of the contract between the government and the THAI was originally supposed to start in February this year.

According to the air travel business circle, protests from Biman employees, who feared job losses, and Bangladeshi politicians, have caused delay of such handover of the Shah Amanatairport several times.

"The four-party alliance government is reluctant to take a risk before the general election by handing over the airport to a foreign company despite its completion of all necessary formalities nine months back," a Caab official said.

Passing off a long time after inking of the deal, Thailand's national carrier was approaching to file a lawsuit against the Caab for its failure in handing over the management of the airport, but the latest talks between Bangladesh's foreign minister and his Thai counterpart Kantathi Supamongkhon at Dhaka saved the Caab from such

Under the decision taken at the ministerial meeting, THAI will allow Biman to operate ground handling services, cargo and catering for its own aircraft and passengers at Shah Amanat International Airport, while it will operate ground handling and passenger services for other international airlines, especially those from the Middle East countries.

reference in the 10-year agreement, THAI would have provided all the airport services to the airlines and passengers.

Had THAI taken over the charge to run the Shah Amanat airport, the estimated amount of its earning from fees would have reached US\$9.06 million. The Thai airlines is learnt to have taken up a strategy to manage some of the regional airports as well as small and medium-sized airports in Nepal, Bhutan, Burma, India, the Philippines and Indonesia.

Meanwhile, the THAI proposed an increase in the number of flights between Bangkok and Dhaka from seven to 10 per week.

Another source said several airlines from the Middle East, China and even Malaysia are planning to operate through the airport in Chittagong.

Thai experts warn against early take-off for new airport

Bangkok's much-delayed new international airport is due finally to open next month, but following years of setbacks Thai travel industry experts still question whether it is really ready.

Apichart Sankary, president of the Association of Thai Travel Agents (ATTA) whose 200 members toured the site last week, warned the September 28 opening date was too early and risked causing a host of operational problems.

Don Muang can still handle the arrivals. We should wait until Suvarnabhumi is totally ready, then we could open it," said Apichart.

DSE turnover hits Tk 80.92cr

Turnover on the Dhaka Stock Exchange (DSE) yesterday reached Ik 80.92 crore, the highest after 1996's bubble and bust.

Earlier on August 21, the DSE witnessed its highest turnover after 1996 with Tk 79.87 crore.

Market analysts said the institutional investors like banks and financial institutions, which play important role in keeping the market vibrant, were more interested in investing money in the market yesterday.

They also attributed the recent upward trends mainly to preelection buying spree, coupled with a series of positive corporate results.

Besides, they said liquidity situation on the stock market also improved in recent times as the inter-bank call money rate eased, which encouraged the institutional investors including merchant banks to channel their funds to the

"Fresh funds are coming into the market," said a DSE broker. With the improvement in liquidity situation large investors have become active, he added.

Along with the turnover, the indices also went up. The DSE General Index rose by 21.89 points or 1.39 per cent to close at 1587.07 points while the DSE All Share Price Index increased by 25.52 points or 1.97 per cent to close at 1321.01 points yesterday.

A total of 75,36,261 shares of 199 issues worth Tk 80.92 crore changed hands on the DSE yesterday. Of the issues traded, 122 closed in gains, 56 suffered losses and 21 remained unchanged.

Saarc chamber to lead business team to WTO in Sept

The Saarc Chamber of Commerce and Industry (SCCI) will lead a delegation of business representatives from South Asia to the WTO. headquarters in Geneva in September to undertake a stocktaking of the multilateral trade negotiations and flag the concerns of developing countries.

The delegation will meet WTO ambassadors of all Saarc countries posted in Geneva and WTO Director General Pascal Lamy, SCCI President Dasho Ugen Tsheup said here on Tuesday.

Addressing a South Asia conference on "WTO and Doha Agenda", he urged developed countries to deliver on their commitments and improve market access and remove all barriers for goods and services of export interest for developing and least developed countries to help successfully conclude the Doha round of talks.

He said SCCI has organised a series of seminars and conferences in Saarc countries to whip up an environment that builds up an understanding of the Siddiqui told a national consultation meeting.

"We are at the rudimentary stage of e-governance and we are implementing a large number of projects to support ICT. But I am not satisfied with the progress. We have to go a long way if we want to establish e-governance in the country," he said.

US interest rates pose risks for robust Asian economies, a UN report said Thursday, calling for more regional cooperation to weather financial downturns.

Economic fundamentals in the Asia-Pacific have grown strong since the 1997 Asian financial crisis but the region faces risks such as soaring oil prices and rising interest rates in the United States, the world's biggest economy.

"High and rising oil prices are the main threat to the prospects of net oil importing economies in the region," said the report by the United Nations Economic and Social Commission for Asia and the

"High oil prices have already pushed up inflation in the region and hurt the current accounts balances of oil importers," it said.

The World Bank has forecast East Asia's economy will grow at a slower 6.6 percent in 2006 after 6.8 percent in 2005 due to the impact of high oil prices, which continue to stay above 70 dollars a barrel.

Apart from the oil factor, the UN warned further rises in interest rates in the United States, the eurozone and Japan could trigger a slowdown in the global economy and hurt export-led Asian econo-

Samsung sees higher global handset sales

Samsung Electronics Co. Ltd. said on Thursday it sees global mobile expected this year while its own handset sales would meet its tail

"At first we expected some 900 million in sales this year, now it looks like 950 million," Lee Ki-tae, president of Samsung's telecommunication networks business, told a news conference held on the sidelines of the Samsung 4G

In July, Samsung forecast 910 million unit sales in the global handset market.

Lee said Samsung expected to meet its own mobile phone sales target of 115 million this year "without problem" and its handset business would improve in the second half from the first.

But he admitted the company was losing market share by underperforming rivals: "The most urgent problem is market share," Lee said.

Samsung, trailing Nokia and Motorola Inc. in the handset market, saw its mobile phone sales fall in April-June from the previous quarter as Motorola enjoyed booming sales due to its blockbuster

"New models and seasonal demand should help (a recovery), but it won't be enough for Samsung to significantly regain market share against Nokia or Motorola," said Choi Yong-kyu, a fund manager at IBK SG Asset Management.

India to launch industrial research with
