Striking Sust teachers announce fresh agitation

Sit-in in front of admin building Sept 6,7 for VC's withdrawal

There is no sign of resolution of the crisis in Shahialal University of Science and technology (Sust), one month after its reopening.

The situation is getting worse as the authorities are not taking any step to end the stalemate while teachers announced a fresh agitation programme yesterday for withdrawal of the vice-chancellor.

The inquiry committee formed at a Syndicate meeting to probe the incident in which a student was killed in police firing could not start work in about one and a half months.

Left leaning teachers, now on an indefinite strike protesting harassment allegedly by some Shibir activists, at a meeting yesterday decided to stage day-long sit-in in front of the administrative building on September 6 and 7 to press their demand for 'withdrawal of the corrupt VC to save the university'.

The meeting was presided over by Dr Akhtarul Islam, former president of Sust Teachers Association. Students also formed a human chain at the central Shahid Minar in Sylhet city yesterday and held a rally there demanding resumption of academic

The Samajtantrik Chhatra Front took out a procession from the Central Shahid Minar towards the Sust. Police intercepted it near the BDR Gate at Akhalia, about half a kilometer off the Sust

Opposition-backed student bodies, who are agitating for withdrawal of the VC and other

As police stopped it near the BDR Gate, the processionists held a rally there, vowing to continue the agitation till withdrawal of the VC.

BNP-Jamaat demands party quota in Ruet jobs

VC given 7-day deadline

Some ward commissioners of Raishahi City Corporation (RCC) joined by local leaders and workers of BNP and Jamaat-e-Islami yesterday demanded 'party quota' in jobs in Rajshahi University of Engineering

and Technology (Ruet). Ruet Vice-chancellor Prof ANM Anwarul Hague become sick as the demonstrators allegedly exchanged words with him in a noisy atmosphere, campus sources said. He was instantly shifted to his resi-

dence in a microbus. The sources said that at around 11.30 am, over 100 activists of BNP, its youth front Juba Dal and Jamaat, led by RCC ward commissioners Alamgir Hossain, Tarigul Islam Paltu. Azab Ali and Monwara Begum gathered in front of Ruet administrative building. The demonstrators included

BNP leaders Khazder Ali and Bakul. Without caring for official formalities, the RCC commissioners and BNP leaders forcibly entered the VC's office and asked him, "Why are you not appointing local BNP men in vacant posts in your university?".

They cautioned him saying, "You are posted here (Reut) due to blessings of the ruling party."

They demanded of the VC appointment of party men on ad hoc basis before end of tenure of fourparty alliance government, the sources said.

They gave the VC a seven-day deadline saying, "If you fail to recruit them (in class III and IV posts) the

university will face a deadlock". Amid exchange of words, the VC fell sick and was rushed to his residence. The demonstrators then left the spot

Hours later, the VC again came to office but officials there did not allow newsmen to talk to him. On behalf of the VC. Ruet Public Relations Officer Golam Murtuza said, "Such incident is nothing new in

the university. Several months ago, activists of the political parties under the banner of a Local Interest Protection Committee vandalised some Ruet offices on the same demand, campus sources said.

After vesterday's incident, teachers, students and staff of the university met with the VC and assured him that they would guard against such incidents in future.

People will foil 'election engineering', Hasina says

Awami League (AL) chief and Leader of the Opposition in Jativa Sangsad Sheikh Hasina said here vesterday the Four-party Alliance has finalised a blueprint to descend to power in the next general election by means of vote rigging but the 14-party Combine will foil the conspiracy at any cost.

Hasina was addressing a roadside meeting at the Janata Bank intersection in Gobindaganj here yesterday while on her way to Phulbari in Dinajpur. Gobindaganj Upazila AL president Tozammel Huq Prodhan presided the meet-

AL chief said so-called uncompromising leader Khaleda Zia has compromised with her husband's killer Ershad just to clinch to power. As a consequence, Ershad is being released from the corruption cases one after another, she said. As the prime minister has no confidence on people, so she extended her hands with autocratic Ershad, she

The Alliance government has formed a puppet Election Commission (EC) just to bring the polls result in their favour, but the 14-party Combine would resist such move. Hasina said.

Hasina said the Khaleda-Nizami Government is patronising Islamic militants and using them in own interest. The ruling Alliance announced death sentence to kingpins of militants so that they do not disclose names of their patronisers, she said.

AL general secretary Abdul Jalil, in his address, said no election would be held in the country unless reforms in the caretaker system of government and EC. He said if the Alliance Government refuses to meet the demands, those will be realised through non-cooperation movement during the next Caretaker Government's tenure.

Among others, central leaders Mahmudur Rahman Manna, Mirza Azam, Jahangir Kabir Nanonk Advocate Fazley Rabbi, Pankoj Dev Nath and Mahmud Hasar

Earlier, at a similar meeting held at Mitidali intersection on the outskirts of Boara town. Rice price increased from Tk 10 to 20 per kilogram as soon as the Fourparty Alliance came to power, she
