## Killing of jute mill worker fuels protest in Sirajganj

The striking workers and employees of Quami Jute Mill in Sirajganj vesterday brought out a militant procession wielding sticks and carrying black flags and held a rally in front of the mill condemning the killing of a fellow worker in Khulna on Thursday and demanding fair probe into the incident and trial of

Workers of government owned jute mills across the country are on strike and staging demonstration since Thursday to press their eightpoint demand including payment of arrear dues and procurement of jute for running the mills properly.

In Sirajganj, the workers staged several demonstrations vesterday to protest the killing of a worker of Quami Jute Mill in Khulna.

The demonstrators paraded main roads of the town chanting slogans and held a rally in front of mill gate. Abdul Khalek, president of Quami Jute Mill Workers Union presided over the rally.

Among others, workers union leaders Sujabot Ali, Nobokumar Karmaker, Shahidul Islam, Gazi Shah Jamal, Esmail Hossain and Gazi Shahin addressed the rally.

The speakers bitterly condemned the police action on peaceful demonstration by jute mill workers in Khulna.

The government is killing workers as they demanded arrear salaries and steps to run the mills

The government wants to close

all jute mills across the country like the Adamjee jute mill to hand over those to the private sector, they

said and vowed to continue the agitation till the demands are met. They said about 4000 workers without salary but the government is unconcerned. Henceforth, any anti-worker

step will be retaliated, they said. On Thursday, a worker was killed and over 100 were injured, between law enforcers and jute mill workers at Khalishpur in Khulna.

The dead, Noor Mohammad alias Jashim, was a casual worker at the spinning section at Crescent

Speakers at the rally called upon the authorities to take immediate steps for resumption of classes and academic activities and trial of the killers of fellow student Mosharraf Hossain Shamim, who was died in police firing on May 14.

The students have been agitating since closure of the university after the May 14 incident.

They took out processions, held rallies, observed token hunger strike and staged human chains in Sylhet city to press their demand.

Court sources said, five cases were filed with Sadar Police Station in connection with bomb blasts at five points in the district town on August 17 last year.

The cases were transferred to KDST on June 21. But the cases were returned to District and Sessions Judge Court, Satkhira on July 31. Citing flaw in trial procedure, the cases were again transferred to KDST after proper maintenance of trial procedure.

Earlier, the date for hearing was set for September 3.

## **Bachchu Molla sets** stage for Nasir **Uddin's expulsion**

The intra-party feud in Daulatour BNP over nomination has taken a new turn with the upazila committee suggesting expulsion of party leader and industrialist Nasir Uddin Biswas, allegedly at the behest of Reza Ahmed Bachchu Mollah, a party lawmaker from the area.

Nasir Uddin is also a prospective nomination seeker from Daulatpur (Kushtia-1 constituency).

The upazila committee in a resolution sent to the district committee suggested 'immediate expulsion' of Nasir for his alleged antiparty activities, party sources said yesterday. The resolution was signed by 'majority members' of the executive committee of Daulatpur upazila unit of BNP.

The resolution was adopted at a party meeting held at Daulatpur Shilpakala Academy on Thursday. It was presided over its president Reza Ahmed Bachchu Mollah MP, the sources said.

#### Drug trader killed in 'crossfire'

A top drug trader in Kushtia allegedly linked with an outlawed party was killed in a crossfire at Char Amlapara in the town in early hours of Thursday.

He was identified as Badsha alias Dail Badsha, 38, son of late Atiar Rahman alias Luta of Mazampur area of the town.

A team of Detective Branch (DB) police led by Sub-inspector (SI) Obaidur Rahman arrested Badsha, convicted for life, from Cheuria in Kumarkhali upazila Wednesday evenina.

Police claimed that Badsha was caught in a crossfire and killed when he tried to flee from custody.

Badsha was also involved with outlawed Gono Mukti Fouz (GMF). A court in Kushtia sentenced him to life term in 2004 in an arm smuggling case.

Nasir brushed aside the allegations. "Who is Bachchu Mollah to suspend me? I was in Daulatpur and will remain. I have a great contribution for the people of Daulatpur. They love me," Nasir told this correspondent when contacted over cell phone on

BNP in Daulatour is divided into two factions over nomination for the coming election, one led by Bachchu Mollah and the other by Nasir Uddin, also a member of the district BNP.

Nasir, chairman of Nasir Group of Industries, also sought BNP nomination in 2001 election and in the by-election in 2004 but was

Bachchu Mollah, son of former minister Ahsan-ul-Haq Mollah, became a lawmaker from Kushtia-1 constituency in the 2004 byelection, held following the death of his father. No party except for BNP took part in the by-election.

Bachchu Molla and Nasir Uddin are engaged in mudslinging over nomination.

At a recent press conference, Nasir Uddin called Bachchu Molla a godfather of hoodlums and claimed himself to be the fittest candidate.

Bachchu Molla termed Nasir Uddin a seasonal bird in politics without any contribution to the people of the area.
