Lawyers concerned over mass arrest

ROUNDTABLE ON CLIMATE CHANGE

'Raise adaptive capacity in agri production'

Bangladesh needs to increase adaptive capacity in agricultural production, revise water management policy and invent appropriate technology in order to attain development goals in the face of rapid climate change, said speakers at a roundtable yesterday.

Protection of the country from the negative effects of climate change requires strong political commitment, huge investment in agricultural research and human resources, and spread of appropriate technology to the remote areas, they observed.

The roundtable titled 'Climate Change and Bangladesh: Serious Crisis Looms' organised by Bangladesh Unnayan Parishad (BUP) was held at National Press Club in the city.

Speaking on the magnitude of climate change and its effects on the country, Executive Director of BUP Ahsan Uddin Ahmed said

average temperature of Bangladesh may increase by 1 to 1.4 degree Celsius by 2030 and Average rainfall during the rainy

season may increase by five to ten per cent and it will decrease by 2 to 5 per cent during the dry season by 2030 and 2050, he added citing some studies Level of seawater in the coastal areas is likely to increase

by 14 to 32 centimetres by the same period that will cause inundation of the coastal districts, he said. If the current trend of climate change continues, frequency of heavy floods will increase, north-

western region will face draughts, salinity in the coastal areas will increase and rate of river erosion will multiply, he added. All these factors will have negative effects on our agriculture and entire population and eventually

the whole nation will suffer from food insecurity, he added. Speaking at the programme, Dr Zahurul Karim of Krishi O Khaddo Niranotta Parishad said if temperature increases by one degree, corresponding decrease in country's total cereal production will be 46 per cent.

He also warned that due to climate change new diseases in human and animal bodies may

Prof K B Sajjadur Rashid of Dhaka University said despite Bangladesh's reputation for its disaster management capacity, it will not be able to face disasters that affect livelihoods gradually over the decades

Emphasising the need for indepth study on the effects of climate change, Chairman of BUP Dr Qazi Khaliquzzaman said Bangladesh does not have enough data and in-depth study on the possible effects of climate change on its economy

Iftekharuzzaman in his paper identified lack of political commitment, visionary leadership, accountability mechanism and focus and priority, and government's control of its operational independence and noncooperation of its commissioners as the reasons for its ineffective-

To make the commission effective and credible, he recommended a degree of overall independence of the commission, its control over its financial resources, authority in key operational and management decisions, leadership capacity of the commissioners, creating public trust in the commission, and making it accountable.

Brushing aside several allega-

tions brought by speakers against the government for making the ACC ineffective, Maniruzzaman said, "The problem is within the commission.

ACC lacks transparency completely

Many things had happened in violation of the rules and have been happening without knowledge of one or more commissioners, the ACC commissioner said. On another commissioner's

claim that the ACC had sent the rules to the Cabinet Division for its nod, he said, "The draft of the rules is still lying with the Commission." He also criticised the govern-

ment for illegally sending the former Bureau of Anti-Corruption (BAC) officials on deputation to the Commission without the knowledge of the commissioners.
