# No relief for Barapukuria

CMC, Hosaf now offer to take over the coal mine after years of mishandling

failures and irregularities.

After turning Barapukuria coal mine project into a liability for the nation by doubling its cost and halving its production capacity, the project's Chinese developer CMC and its local agent Hosaf Group have jointly proposed taking over the mine, highly placed sources

The CMC and Hosaf Group in their two-page proposal made earlier this month wanted to take over the mine on the basis of unsolicited negotiation. In the early nineties, Hosaf Group helped the CMC get the mining project contract through unsolicited negotiation under a Chinese Supplier's Credit undermining the national interest.

Sources said that in the last one decade, the CMC and Hosaf drained out hundreds of crores of

And now the Hosaf-CMC consortium seeks a joint venture with Petrobangla that owns Barapukuria Coal Mine Company Ltd (BCMCL) and offers Petrobangla 30 percent equity, keeping 70 percent of the coal production to itself. The Hosaf chief is the brother of a ruling BNP

When the mining project started in 1994, price of coal was less than \$25 dollars a tonne. Now, the global coal price has skyrocketed to \$75 per tonne

A Dhaka court yesterday sentenced five Jama'atul Mujahideen Bangladesh (JMB) members to 78 years' rigorous imprisonment in two cases filed for possessing illegal firearms, ammunition and explosives in January this year.

Meanwhile, a Dhaka court today is expected to deliver the verdict of a case filed against JMB military commander Ataur Rahman Sunny and five others in connection with an August 17 serial bomb blast last year.

## BNP gets tough to quell inner conflicts

The ruling BNP has begun to take action against its dissident leaders in different districts to resolve intra-party conflicts ahead of the next general election scheduled to be held in January.

The party leadership has already suspended two leaders and served show cause notices on at least 10 others in different districts for their anti-party activities.

Besides, it has dissolved Satkhira district committee of the party for internal conflict, and a district committee issued show cause notice against five thana level leaders for opposing a Jamaat-e-Islami leader as prospective ruling four-party alliance candidate in the next election, BNP sources said

"We have identified at least 30 party leaders across the country who are trying to create problem

possible coalition candidate in the next election. Some of them have already been issued show cause notice, and final decision about them will be taken after getting their reply," a top BNP leader said, wishing anonymity.

Earlier, the National Executive Committee (NEC) of the BNP at its August 26 meeting decided to take action against anybody breaking the party discipline. At the meeting chaired by party Chairperson and Prime Minister Khaleda Zia, several leaders demanded immediate action against the party's rebellious leaders at all levels.

Meanwhile, the BNP chief received allegations from several grassroots level party leaders against lawmakers and ministers during the exchange of views meet ings in last two months.

These leaders even expressed their grievances while talking to the

media after the meetings, and the BNP high command is considering

Sirajganj district BNP General Secretary Humayun Kabir has already replied to the show cause notice for his comments to the media after an exchange of views meeting with the party chief.

Ohidul Islam, president of Chuadanga BNP has been suspended for anti-party activities.

The party unit here is plagued with persisting conflicts between activists loyal to the incumbent and former lawmakers. Former lawmaker and Jatiyatabadi Krishak Dal President Shamsuzzaman Dudu did not get nomination in the last election due to intra-party conflicts and he could not even visit the area in the last few years.

## Vegetable prices double Ramadan on Ramadan eve

Four days of torrential rain caused an inadequate supply of vegetables to the kitchen markets in the capi tal pushing the prices very high ahead of the Ramadan.

Wholesalers said the supply of vegetables decreased as harvest was not possible due to the sudden rainfall across the country.

The prices of green chilli, aubergine, cucumber, palwal, jhinga, papaya, bitter gourd, pumpkin, kakrol, long beans, tomato, and other vegetables almost doubled in some cases.

The price of green chilli jumped

to Tk 70 per kg from Tk 20-25 in the retail market while the price of aubergine rose to Tk 40-60 per kg from Tk 15-20.

Tomato, the price of which was around Tk 50-55 per kg in retail markets two or three days ago, is nowselling at Tk 65-70.

Cucumber that sold at Tk 15-18 perkgis now selling at Tk 24-30. Palwal is being sold for Tk 14-20; the price was only Tk 10-12 before

Mobs beat three alleged criminals to death in separate incidents in Keraniganj and the city's Ramna area yesterday.

At Khajurbagan Bastuhara slums in Keraniganj, locals captured three -- Nadim, 35, Arif, 32 and Mainuddin, 30 -- after chasing them for almost a kilometre.

The chase started on the other side of the Buriganga after the three had shot timber trader Dilip Pal Chowdhury, 50, inside his shop at SEE PAGE 15 COL 2 | Farashganj. As the timber shop
