The WTO on Friday confirmed its partial condemnation of the European Union in a dispute with the United States, Canada and Argentina over genetically modified organisms (GMOs), giving the parties 60 days to appeal.

The World Trade Organization officially published its report on a complaint by the three countries going back to 2003 and charging that a European moratorium on GMO imports was more about trade protectionism than concerns about the health of consumers or the environment.

They accused the EU of abusing a WTO agreement that enables members to restrict imports on health grounds

The EU had argued that the moratorium was needed to give it time to gather data from biotech firms and decide how to update its rules on

Most of the WTO report, which until now had been confidential, was leaked last February, with all parties involved thinking they had won their

The official publication of the report, which takes no stand on the safety debate over GMOs, allows for a legal delay of 60 days for appeals to be filed. When asked Friday, the parties concerned said no decision had yet been made about an appeal.

The 1,050-page report, the biggest ever done by the world trade regulators, said the EU must comply with the rules of global commerce, set by the 149 trading nations in the WTO.

Nigeria, Venezuela to cut oil output

Opec members Nigeria and Venezuela are to cut their crude oil production in the face of sliding prices, a move limited in scope and likely to have an uncertain impact on the market.

Their combined reduction amounts to 170,000 barrels a day, according to a spokesman for the Organization of Petroleum Exporting Countries, which pumps

about 40 percent of the world's

"Venezuela has formally informed Opec that it will be cutting voluntarily production by 50,000 barrels a day as of the 1st of October," Opec spokesman Tarek Amin said Friday.

"Nigeria will cut their production by five percent, which is around 120,000 barrels a day. These are both voluntary cuts, these are not cuts made by the Organization.

Pak PM wants textiles to be competitive

Prime Minister Shaukat Aziz has called for making the textile industry viable, more competitive and sustainable in view of the paradigm changes in the industry globally.

Chairing the first meeting of National Textile Strategy Committee at the PM House on Friday, he asked the committee to create the necessary linkages between industry, academia and the government.

The Prime Minister said textile was the premier core business of the country contributing 66 percent to country's exports, 40 percent to employment and 8.5 percent to the

GDP growth. He described it as the backbone of economy and said the government will take all measures to help the industry sustain its present position in the global trade and to increase its share to avail the oppor-

tunities of quota free environment.

The Prime Minister asked the committee to adopt a result and action oriented approach and come up with tangible short, medium and long term measures to increase production of cotton and improve productivity and competitiveness of the textile sector.

He said the strategy should have recommendations for improvement and an implementation plan for best

The Prime Minister also asked the committee to analyze country's trade diplomacy and market access policies and suggest appropriate

The Prime Minister said the committee should critique textile vision 2005 which will provide the base for the new strategy. He asked the committee to submit its final recommendations by December 31.
