Tk 596cr siphoned off by a few shareholders

Reveals BB report; same group using political clout to take over bank again

A few politically powerful share-holders, their friends and top management of the Oriental Bank have defrauded the bank of Tk 596 crore through blatantly corrupt methods, said an interim investigation report of the Bangladesh

The same group of corrupt people is now lobbying with the Prime Minister's Office (PMO) to take over the Oriental Bank by unduly influencing the central bank, sources said.

The BB took over Oriental Bank in June in the wake of its total finan-

The BB interim report submit-

ted to the finance ministry last week said the corrupt section of shareholders have obtained Tk 488 crore from five branches of the Oriental Bank by simply issuing vouchers.

Finance ministry sources said records of these branches--Karwan Bazar, Mirpur, Nababpur, Principal Office and Bangshal--showed that the sum was sent to the bank's head office under two "adjustable block accounts"

About 60 per cent of the sum was taken from the Bangshal

The group also obtained another Tk 108 crore against 26 different accounts held by unsuspecting accountholders. The investigation team found out that these accountholders did not have any clue that their names and accounts were being used for draining out such money

"High credit limits were set against each of these accountholders without their knowledge and the corrupt group took the money against these accounts," said an Oriental Bank

The entire sum of Tk 596 crore was drawn between 2003 and 2006, mostly during 2005-2006 until the central bank took over Oriental

"Such corrupt practices by the owners and management of a bank is unheard of in the country's

banking history," a finance ministry official said.

The BB investigation team probed into 22 of the total 33 branches of Oriental Bank. It will continue to probe into the books and ledgers of the remaining branches, sources said.

Oriental Bank sources told The Daily Star that ousted managing director Kais Sami and top officials helped the shareholders drain out money by giving verbal orders and instructions to various branch managers.

Speaker's new sense of time

Speaker of Parliament Jamiruddin Sircar yesterday did not allow opposition lawmakers to speak in the House about the August 21 grenade attack on an Awami League (AL) rally and the killing of former finance minister Shah ASM Kibria terming the issues old.

But he did not term the topics regarding formations of Rakkhi Bahini and Baksal during the first AL regime just after the independence as old when ruling BNP lawmakers spoke on the issues blast-

Irked by the speaker's action of switching off the microphone of an AL lawmaker while he was still speaking, AL deputies walked out of the House for a brief period and later accused the speaker of being biased to ruling BNP in running the parliament.

"The speaker has proved himself to be very much loyal to ruling BNP by destroying the norms and conventions of parliamentary democracy," AL lawmaker Sheikh Fazlul Karim Selim said in a news briefing after the walkout.

Selim, who was interrupted by the speaker while he was speaking about the government's indifference to punishing the police personnel who were involved in an attack on the residents of Shamsunnahar Hall, a women's dormitory in Dhaka University, in July 2002.

Condemned militants

All sought permission to appeal

won't be hanged in

Bangladesh (JMB) militants condemned to death for killing two judges last year will not be executed during the tenure of the present government as all the convicts have sought permission to appeal against their sentences.

The Supreme Court registrar yesterday ordered stays of execution of the death penalty of JMB military commander Ataur Rahman Sunny and Majlish-e-Shura member Abdul Awal following their special prayers through the jail authorities for leave to

The decision marks the end of the fevered speculations whether the militant kingpins would be executed within the term of the

four-party alliance government. Of the seven militants convicted of murder, six are behind bars while Arif, the other one, is still at large.

Although the convicts had earlier said they would not file any appeal with the worldly courts, they have grabbed at the opportunity to appeal against their sentences that were confirmed by the

High Court on August 31.


Sunny and Awal submitted their prayers to the Dhaka Central Jail authorities on Monday, three days after expiry of the seven days' time since reading out of the death warrants to the convicts.

. The jail authorities sent the prayers to the SC Registrar Fazlul Karim yesterday.

The SC registrar later sent separate letters to the home ministry, jail and the other authorities concerned, ordering postponement of the execution.

He told The Daily Star yesterday that he had passed on to the authorities concerned the administrative orders staying execution like he did in cases of the condemned JMB Chief Abdur Rahman, Majlish-e-Shura member Siddiqul Islam alias Bangla Bhai, Khaled Saifullah and suicide bomber Iftekhar al Mamun.

Supreme Court officials said that in line with the apex court practices, the execution of the death penalty was temporarily stalled, pending the acceptance of the petitions for hearing by the Appellate Division of the Supreme Court.
