He has begun running again and there has been talk he could play in the final two Tests as England look to retain the little urn.

"Everything would have to go perfectly between now and then but in my mind there is a small window of opportunity," Vaughan told the

"I would have to make runs in Perth and, of course, I would have to stay fit.

"It would also depend on the state of the series and how the England management are thinking. But it is definitely what I'm aiming for and definitely a target."

Vaughan is currently taking part in golf's Dunhill Links Championship in Scotland as a "mental break" from his recovery programme.

India helps to drive cricket's economics, as five of the ICC's six main sponsors are Indian firms or the Indian branches of international businesses.

If the country refuses to play ball, dollar deal to sell broadcasting and sponsorship rights could be affected.

The ICC's current 550-milliondollar, seven-year deal with Global Cricket Corporation, a venture owned by Rupert Murdoch's News

International, expires after the 2007 World Cup in the Caribbean.

The ICC hopes to double that amount in a new eight-year deal that covers 18 tournaments, including two World Cups, three Champions Trophies and the first two Twentv20 world championships

Other events include the ICC rophy for associate members and the under-19 World Cups.

The BCCI caused a major row ahead of the last World Cup in South Africa in 2003 when it declined to sign the MPA.

The BCCI objected to a clause which prevented its players from advertising products from rivals of the ICC's official sponsors for three months on either side of the World

After prolonged negotiations, India relented and sent a team for the tournament but the Globa Cricket Corporation withheld almost 47 million dollars in payment to the Modi said the BCCI will not "fall

into the trap" like it did before the 2003 World Cup. Significantly, the BCC announced earlier this week that it

would also make a bid for the ICC's global media and marketing rights for the next eight years. The BCCI secured a whopping

612 million dollars for its own rights for the next four years from the Corporation. "We have successfully sold our

own rights and I am confident we can do well with the ICC's global rights also," Shah had told AFP on

Delhi cops to quiz Gibbs

South African batsman Herschelle Gibbs is likely to be questioned by Indian police over a 2000 matchfixing scandal during the Champion's Trophy which starts Saturday, officials said.

The 32-year-old, who has played 79 Tests, had admitted accepting money from disgraced former captain Hansie Cronje to score fewer than 20 runs against India in a one-dayer during their 2000 March-April tour.

He subsequently scored 74 runs and said he had "forgotten" about his deal, but was suspended and fined. "The case of cheating the

public at large is open as none of those named (in the scam) have appeared before us," a senior Delhi police officer handling the case told AFP.

"As Gibbs is a co-accused his questioning by us is logical."

Gibbs is scheduled to arrive in Mumbai accompanied by a South African lawyer on October 10, four days after the rest of the South African squad.

Police said if necessary he could be asked to travel to the

Indian capital for questioning.

The Delhi city police prosecution department also confirmed the case remains on file against Gibbs, who has previously refused to tour India after failing to obtain assurances he will not be detained.

"We will re-open the case and if some kind of interrogation is required then it will be done," YS Yadav, Director of Prosecution, told AFP.

Implicated in the same scandal was Cronje, who admitted involvement on his part and was served with a life ban before dying in a plane crash in 2002.

South Africa, winners of the maiden Champions Trophy in 1998 in Bangladesh, are scheduled to play their first match against New Zealand in Mumbai on October 16. The International Cricket

Council in May said it would do everything possible to ensure Gibbs could tour India without fear of arrest in the match-fixing case. The Champions Trophy will be

held from October 7 to November 5 in Mumbai, Mohali, Ahmedabad

Styris cleared for Trophy

New Zealand cricket all-rounder Scott Styris has been cleared to play in the Champions Trophy tournament after coming through a training camp unscathed over the last week.

Styris injured his back playing for Middlesex in the English county championship last month and was the most in doubt among a bowling line-up which has had to overcome a raft of injuries this year.

Styris pulled out of his last English county game on September 10, a week after the back pain first "I wasn't too sure when I came

immediately with most of us. from the federation, all inside. I thought that was all

The police, out of nowhere, started scaling the walls and the locked gate and went after us. I ran inside but they caught up with me and started lashing at me with sticks. I fell down when everyone else, around 30 of my junior students (some of whom are new in Dhaka as well), were running in all directions.

It was unimaginable -- the number of policemen kept on rising inside the camp, range as well as the entire complex. I must mention here that there are numerous guns lying systematically all around the range. As I was being dragged away by the police, my eyes fell on a row of guns just a few metres away from the range. I just hoped that nobody picked up a gun and shot at the police. Thankfully, we kept our discipline even though there were a lot of young men who could have easily fired at the police. All of this took place in only four to five min-

So as I was being dragged away, I saw others still being mauled to the ground. I was taken to a van and was kicked at, which I really found very humiliating.

After being taken to the Gulshan

police station, we were asked our

names. I was almost feeling a certain

numbness because this was actually the first time that I have ever been to a police station in my life. As one of them wrote my address, he said, "Ah, you're from Kushtia, Pabna (Asif), Bogra

(Shipu) -- the land of criminals.' "The gold has made you too big. We will get the gold out of you," said someone to Asif.

The words were starting to blur into my ears. They forced us to lie all of us on the ground. And then one by one, they took our shoes off and battered our soles. I have never felt

such pain; my body was just giving

up its weight. I heard them say, "This is the coach of the criminals."

I think they broke around 6-7 sticks and after that I saw a few hockey-sticks being brought in. We were taken into the remand room as they were saying to each other and writhing 5-10 minutes I

was half-awake, half-senseless.

was fading away everytime my back

was smacked with a hockey-stick. The hardest part was just listening "You will never forget us and this beating," someone told me. Indeed, I shall never stop thinking about this indiscriminate pounding. My head completely stopped working by then. I saw Asif's neck bleeding and checked to see if I was losing blood too. I don't even remember when I got hit on my forehead but I found a lot of blood as I raised my heavy hand. By then I was sure that I have a broken hand, a smacked forehead and unbelievable pain on my sole

My clothes were torn into pieces. They tied it up near the shoulder and took me outside, and to the CMM Court. I couldn't open my eyes when I

ber seeing any photojounalists or any other people In my life. I have never seen what a police station looks like. I felt as if this the lowest I could go. The humiliation was unbearable

I was returning after shopping for groceries from Gulshan market and had no idea of what was going on. I had just gotten to the gate and I knew nothing of what had happened. Suddenly a few policemen grabbed me by the neck. Someone shouted "Catch him and beat him up." The next thing I knew was that I

was subject to a volley of blows to every part of my body. Before I had time to say anything I was packed off into a vehicle and taken to the Gulshan station. There I was put in the same room as Asif and Shoeb bhai and beaten. I protested my innocence but it fell of deaf ears. They beat me all over and although I screamed and cried and swore on my mothers name it did not make them stop. We were then taken to court and following that sent to jail.

JANNATUL FERDOUS

(Ansar) I was on cooking duty for the week and I was getting ready to prepare lunch when duty called. Under government regulations we are supposed to act whenever there is a commotion. So I grabbed my dress and raced downstairs upon hearing of the trouble. It was pandemonium from then on. There were scuffles with police officers and I fell in between. I was packed off with the others to the station. All the way I kept telling them that I was from Ansar but they laughed it off. At the police station they put me in the same room with the others and stripped me before hitting me at all parts of my body with a variety of objects. It was beating like we had never seen before. This was the kind of story that I had heard from my previous generation about how the Pakistan army used to beat the Bangladeshi people. A police officer passed hockey sticks and asked the men to "beat them for me twice." They threatened us many things including saying that they could put us in 'crossfire.' It was like hell.
