Normalcy crawls back to cities, towns

District administrations hold meetings with political leaders

Normalcy crawled back to some cities and towns yesterday after two days of political violence.

But clashes took place in some areas including Rajshahi city where at least 100 people were injured when Islami Chhatra Shibir activists attacked a rally of 14-party

Road-rail barricade continued till yesterday in some districts though the Awami Leagueled 14-party alliance withdrew the programme following positive political developments in the capital, our correspondents reported.

Section 144 clamped to stave off violence was still in force in some areas. Rival parties brought out processions in some district towns as a show of strength but avoided clash.

Barisal city witnessed a calm day yesterday after two days' clashes between Awami League and BNP activists that left a BNP activist killed and over 40 people injured, our correspondent reported.

The rival party activists also ransacked each other's party offices, houses and business enterprises at many points in the city during the violence.

Section 144, imposed in the city centre and surrounding areas, remained in force till yesterday. Patrol on streets by Rab, APBN and police continued. Deputy Commissioner of Barisal Metropolitan Police Skaikh Abdur Rahim told our

correspondent that Section 144 will continue in certain areas of the city till normalcy returns.

The roadblock program called by the opposition alliance continued in highways and adjacent areas. This correspondent saw the Barisal-Dhaka highway barricaded at Amtala intersection in the city yesterday evening. A small number of transports however plied some city streets.

Vehicles did not ply highways and inter-district routes till yesterday evening. Transport owners said they will ply vehicles from morning today.

Launches and other river transports started moving. But Most of them were over-loaded with passengers.

Banks and other financial institutions, most markets and shops reopened.

However prices of the essentials rose as supplies were disrupted due to countrywide road blockade.

Presence of people in offices and courts were less than normal as communication is yet to return to normalcy.

Classes and examinations in educational institutions did not resume vesterday.

In Rangpur, calm prevailed in the town while a Jamaat office was torched in Pirgacha yesterday afternoon.

Local Jamaat leaders claimed that the party office was burnt by 14-party activists, an allegation denied by their leaders. Police was yet to identify

Rangpur Police Superintendent Hasanul Haider held a meeting with representatives of all political parties to maintain law and order.

Meeting sources said the political leaders said they would try to check violence during political programmes and help the administration maintain peace.

Our Mymensingh Correspondent reported that a normal situation was prevailing in the district after two days unrest which left over 50 people injured, including three journal-

Shops reopened and people were seen on streets, shopping centres and kitchen markets in large numbers.

Transport company owners said they will ply their vehicles from night (Monday night).

Mymensingh Police Superintendent Chhibgat Ullah held a meeting with leaders of all political parties seeking their cooperation to maintain peace and order.

District BNP president AKM Mosharraf Hossain, secretary Monjurul Haque Monju, Awami League president Motiur Rahman and secretary Abdul Matin Sarker and front ranking leaders of other parties attended the meeting.

In Brahmanbaria, an uneasy calm prevailed in the town while BNP held a mourning meeting at a community centre in the town and brought out a procession in

the afternoon to protest the killing of its district vicepresident advocate Sheikh Md. Habibullah in a bomb attack on

a party procession Friday night.

Markers and shops started reopening after three day's shutdown following clashes between BNP and Awami

Tension prevailed in the political circle as Juba League worker Md. Haroon Mia and Chatra League activists Md. Iqubal, injured in a clash in

Bancharampur upazila, were sent to Dhaka for better treat-

At the meeting, BNP decided to hold a protest meeting on November 6 at Poura Mukta Mancha here.

Brahmanbaria Bar Association also brought out a mourning procession in the court complex to mourn the death of district BNP vicepresident.

According to police sources, three platoons of BDR and five platoons of police headed by two magistrates were deployed in the town.

During clashes on Friday and Saturday, at least 16 houses and four shops were damaged.

Leaders and activists of Awami League and its front organisations went to the office of Deputy Commissioner Golum Mowla chanting slogans and handed over the memorandum to him.

In the memo, they alleged that the chairmen of the bodies were appointed illegally by the 4- party alliance government and they will try to influence the coming election.

A journalist of Bagmara in Rajshahi was tortured for several hours by members of the Rapid Action Battalion (Rab) after his arrest on suspicion to be an outlaw from his house at night on Saturday

Focus Bangla journalist Shafiqul Islam was sent to jail yesterday under Section 54 after inhuman torture. Shafiq who also worked for Janakantha earlier, narrated his plight yesterday after he was produced before a magistrate court. He said the Rab members

gave electric shock on his body and tortured for eight

hours hanging him upside down at their office. While torturing, they named Prothom Alo staff reporter Anu Mostafa, The Daily Star reporter Anwar Ali, Sangbad reporter Zahangir Alam Aakash and Janakantha photojournalist Selim Zahangir as their next target, he said.

Shafiq confessed before Rab to his involvement in the police murder of Chowbaria.

Later, he was handed over to Bagmara police

Meanwhile, Rajshahi Jouranlists' Union brought out a protest procession in Rajshahi city before holding a rally at Shaheb Bazar. RUJ president Hasan Millat

Speakers criticised Rab for harassing journalists without specific charges. The lamented saying Rab did not arrest Rajshahi University Shibir president Mahbubul Alam Salehi, a killer of Prof S Taher Ahmed.


They said the law enforcers still show favouritism towards BNP-Jamaat activists despite change in the 4-

BNP RIFT WIDENS AS MONI JOINS LDP

SQ Chowdhury eyes Rangamati constituency

Rift in Rangamati district BNP has widened with a party stalwart from Chittagong joining several contenders for alliance ticket from the hill district in coming election

They have already started campaign, displaying posters, meeting people and holding party workers'

Salauddin Qauer Chowdhury, former parliamentary affairs advisor to the prime minister will seek nomination from Ranbgamati, party sources claimed. His posters have appeared at different areas of the district.

They claimed that the rift widened as Khaleda Zia did not declare any party candidate from this constituency during her visit to CHT last month though, at a public meeting in Khagrachhari, she announced the name of Wadud Bhuiyan as alliance candidate from there

They said joining of former deputy

minister for CHT affairs Moni Swapan Dewan to newly formed Liberal Democratic Party (LDP) contributed to widening of the rift in the 4-party alliance in Rangamati. BNP may face a crisis in finding a 'competent' candi-

date, political circles observed. Sources close to Moni Swapan said he left BNP as the party ignored him during last five years.

As per provisions of the CHT peace accord. Moni was supposed to be full minister for CHT affairs, but the government made him deputy minis-

ter. This aggrieved him, they claimed. Party high-ups neglected Moni Swapan as he raised his voice for full implementation of the accord. Future of BNP in Rangamati has now become uncertain after Moni's joining the LDP, they claimed.

"We eagerly waited for Khaleda Zia's announcement regarding party nominee from Rangamati. But we were frustrated", a senior BNP leader said seeking anonymity

Appearance of Salauddin

Quader's posters under the banner of Samo Odhikar Andolan (SOA) has surprised many of us, he said. Samo Odhikar Andolan is a platform of Bangali settlers formed by Wadud Bhuiyan after the 4-party alliance came to power in 2001 election.

The political scenario will be complicated if Salahuddin Qader Chowdhury, vies for nomination from Rangamati. BNP leaders

District BNP president Md Nazim Uddin, claiming himself to be the most competent candidate and a dedicated leader, is seeking nomination

There are other contenders in BNP. Talking to this correspondent, party's district secretary M Zahir Ahmed said, "I am holding the post of secretary for 18 years. My contribution is greater than any other leader. I will seek nomination and I think party high-ups will consider".
