lajuddin not making

Following the meeting, Hasina briefed journalists about the current political situation, the 11-point task proposed to the CG by the 14-party coalition, and the demand for reconstitution of the Election Commission

Saying that lajuddin is unable to perform the duties of two posts and could not make the CG effective and functional even after 10 days of forming the interim government, Hasina urged him to appoint a new person as the CA in line with the constitution for smoothing the functioning of the interim adminis-

She also alleged that the president cum CA has made his situation more complex by taking charge of 14 important ministries and divisions. "We have shown tolerance and given the president cum chief adviser time to prove his neutrality, but he failed," Hasina added.

The AL president also came down heavily on Chief Election Commissioner (CEC) Justice MA Aziz. Hasina alleged that the appointment of Aziz as CEC has been controversial as a case was filed against the appointment in the High Court.

Hasina categorically stressed the need for reconstituting the EC saying that a free and fair election is not possible under the current EC led by CEC MA Aziz. Different international organisations as well as the council of advisers to the CG also stressed the need for reconstitution of the EC, Hasina mentioned.

Terming Aziz 'mentally sick and shameless', Hasina accused him of pushing the country towards a confrontation only to help one party's design to rig the next elec-

She asked Aziz to quit the post showing respect to the people's demand just like the way two former CECs Justice Sadeq and Justice Sultan Hossain Khan resigned in the face of the people's demand.

Drawing attention of the President, the AL president said the country will head towards a confrontation and bloodshed, if the CG tries to hold any election keeping Aziz in the office of the CEC.

Urging the president to reconstitute the EC in order to hold a free and fair election, she warned lajuddin and those who are 'controlling him from behind' that they will be liable for any 'bloodshed' following he CG's failure to meet the 11-point charter of demands by the November 12 deadline.

Hasina, a former prime minister, said although they extended the ultimatum by a week from the first deadline of November 3 on the request of the two advisors sent to her by the president, they have seen nothing that reflects the CA's neutrality. The CA did not take any action to meet the demands, Hasina

If the demands are not met by the new deadline, she said, all roads, rail and waterways, ports, and every other means of communication will be shut down from November 12 until a congenial atmosphere is created for a free and fair election.

"We don't want violence, we want free and fair elections in a peaceful atmosphere. But the president cum chief adviser has not vet proven his neutrality through any of his actions. Time is running out fast and there are only four days in hands, we have not witnessed any activity from which we can ascertain his (CA) neutrality. Rather, the president is wasting time," Hasina

She also demanded updating of the voter list by excluding 1.40 crore 'fake voters' and by enlisting genuine voters instead. Time is there to correct the voter list, she said adding that some of the members of the advisory council of the CG have also not been included on the list.

The AL chief said the people will resist with oars and poles any attempt to rig the next election.

Hasina demanded immediate posting of the officials who had been made OSD.

Criticising police and Rab guarding Hawa Bhaban, Hasina demanded the Hawa Bhaban be sealed off instead. She urged the Rab and police to investigate and dig out illegal deals and activities that occurred in that office.

Hasina appealed to the Baitul Mokarram National Mosque committee and devout Muslims to protect the sanctity of the mosque while commenting on Jamaat-e-Islami activists firing gunshots from the mosque on October 28.

While commenting on Jativa Party Chairman HM Ershad's reversal of decision to join the 4-party alliance, Hasina said Ershad has just addressed the reality, as BNP's position in rural areas is fairly poor.
