## VIOLENCE AGAINST WOMEN '80pc incidents take place within family'

Eighty percent of incidents of violence against women take place within the family, and the media is mostly responsible for aggravating the situation, speakers at a workshop observed yesterday.

Bangladesh National Women Lawyers' Association (BNWLA) organised the workshop in the city with a view to creating a platform for iournalists to raise awareness about the social menace.

"We are growing up in a culture of violence where women are the targets of violent abuse and the media through advertisements, movies and dramas often encourages such behaviour," said Prof Dr Geeti Ara Nasreen of Mass Communication and Journalism Department, Dhaka University.

In her speech, which was followed by a lively view exchange session, she cited examples from different films, dramas and advertisements where physical and verbal assault of women are being shown as norms.

Giving an example, she said that in an advertisement a young boy is seen braving all odds to reach a dancing girl. Portrayal of such acts might sow the seeds of violence in the minds of youths, she added.

Rabeya Raushan, a freelance consultant, regretted that the dailies are not properly highlighting the incidents of violence against women

She said that even the family members are forcing girls aged as young as eight into prostitution in Raishahi where hotel-based sex trade is rampant.

Prof Nusrat Amin of law department. Dhaka University, discussed the legal aspects of the draft law on domestic vio-

lence and its urgency in society. She also called for updating the laws and plugging the loopholes to curb domestic violence. People cannot be made sensi-

tised to this problem unless the state recognises the issue by adopting a specific law in this

regard, she observed. Journalists along with judges, lawyers and civil society members should also play an active role in the remote areas of the country in sensitising the people, said Salma Ali, executive director of BNWLA.

Farida Yasmin, editor, women's page, the daily Ittefaq, Advocate Rehana Sultana, Advocate Fawzia Karim Firoze and Sadrul Hasan Mazumdar also spoke.

# **Expats demand reforms in EC**

Bangladesh International Expatriate Welfare Association yesterday demanded that the caretaker government (CG) reform the Election Commission (EC) as well as update the voterlist to hold a free and fair election.

The speakers at a press conference at the Dhaka Reporters' Unity (DRU) also urged the caretaker government to create an atmosphere so that the expatriates could cast their votes in the next election.

They said around 60 lakh expatriate Bangladeshis can be voters within a very short time with the help of Bangladesh missions abroad through EC and can cast their votes in mis-

sions, consulates or different places selected by the missions.

The speakers also urged the CG to resolve the issue of exporting manpower to Malaysia through Bangladesh Overseas and Services Limited (BOESL) with guaranty as there is a potential job market there for Bangladeshis. Work permits of hundreds of labourers were cancelled in Malaysia due to faulty strategy of the immediate past government and conspiracy by a section of manpower

agents, they added. They also called upon the government to provide loan with five per cent interest to those who have got permission to go abroad so that they do not have to sell their land and property. They urged the government not to

take more than Tk 50,000 from or those who intended to go to Malaysia. They demanded cancellation of licences of those recruiting agencies,

which realise a lot of money from the people in the name of sending them abroad or sending people abroad through false documents. They said if people go abroad

through BOESL they will get compensation in case of deception or repression in the recipient country. Association President Dr

Mohammad Abdur Rahman Secretary General Syed Nasir Uddin and Vice President Mohammad Shah Alam spoke at the press conference.

A bus owner was shot dead by a gang of unidentified criminals at Jatrabari in

Witnesses said three assailants shot Liakat as he was coming out his residence at Dakkhin Kajla in Navanagar at about 9.30am, leaving him critically injured. Liakat's brother-in-law rushed him

to Dhaka Medical College Hospital (DMCH) at 10.30am where the attending doctors declared him dead. Liakat was shot in his head, abdo-

Md Ripon, Liakat's brother in law, said Liakat came out of his house after receiving an anonymous call.

men and hands, hospital sources said

Anwar Hossain, a local extortionist, has been threatening Liakat for the last few months demanding extortion and issued a 15-day ultimatum to meet the demand, Ripon said. Liakat was

scared due to his threat, he added. Victim's younger brother Humayun Kabir said he might have been killed over an internal feud of transport owners

Liakat's wife Mansura Akhter filed a murder case with Jatrabari Police Station in this regard.
