CA offers to appoint 2 new commissioners

Decision comes after meeting with BNP; Iajuddin may address nation today; AL hints at accepting proposal if new ECs replace Aziz, Zakaria

President and Chief Adviser (CA) Iajuddin Ahmed last night proposed appointment of two new election commissioners in his last ditch effort to strike peace between two major parties wrangling over reconstitution of the Election Commission (EC).

The proposal that came after BNP Chairperson Khaleda Zia met Iajuddin at his Bangabhaban office at 6.40 pm was summarily ruled out ment took over on October 29.

Iajuddin, who postponed his meeting with his advisers in the morning, will address the nation today or tomorrow to explain his efforts in resolving the tethering political crisis that dogged the nation since the caretaker govern-

Milon rebuts Barrister Zia's kidnap claim

Former state minister for education Ehsanul Haq Milon yesterday denied the allegations made by Liberal Democratic Party (LDP) leader Barrister Ziaur Rahman Khan of attempting to kidnap him and claimed that Zia wished to return to BNP willingly.

"Barrister Zia asked me to communicate with Hawa Bhaban (BNP's Banani office) as a mediator about his return to the party," Milon said at a press briefing at BNP's central office at Naya Paltan in the city.

Navy flouts rules in boat spares deal

Set to procure Tk 1.6cr spare parts at Tk 6.19cr

Bangladesh Navy is procuring Tk 1.5 crore worth of spare parts for its six high-speed boats for an exorbitant Tk 6.19 crore violating rules and bypassing the director general of defence purchase (DGDP),

On November 5, based on a restricted tender the Naval Store Sub-Depot (NSSD) issued three separate work orders for spares for these speedboats. Two of these work orders worth Tk 2.66 crore and Tk 3.42 crore were issued to one firm -- AJA International -- and

the other worth of Tk 11 lakh to a month and in January. firm -- Habib Enterprise.

Interestingly, this supply will be delivered to Bangladeshi peacekeeping mission in Sudan, and not in Bangladesh. The Bangladeshi peacekeepers there are using these boats purchased in 2005 only for Tk 8.5 crore. The boats were delivered in Bangladesh.

Sources said while the price of Tk 6.19 crore itself is highly inflated, it includes import duty and taxes to be payable to Bangladesh. But these will not be paid to Bangladesh as the goods will be delivered in Sudan this

Navy sources said actual price of the spare parts would be Tk 1.5 crore, and even if taxes are included, the price would be around Tk4 crore.

The deal was pushed by a relative of the immediate past prime minister along with a former political appointee of the Prime Minister's Office (PMO).

One of the in the deal includes a former official of the PMO during the Awami League (AL) rule. He was included as a 'future strategy'. In case the AL returns to power in the next elections and starts punishing

those involved in corruption in naval procurements, he would 'save' them. The suppliers who were given the job do not include names of any of these beneficia-

Sources said the procurement process is a gross violation of defence rules that demand purchases through the DGDP. The navy authorities are buying these parts directly without holding any open tender despite such high cost involvement.

The World Bank is committed to microcredit, an official said Friday after Nobel Peace prize winner Muhammad Yunus attacked the lender for all but ignoring tiny loans for impoverished people.

Bank director Elizabeth Littlefield rejected Yunus's criticism, at a microcredit summit in Canada this week, that "not even one percent" of the World Bank's total lending goes to microcredit funding.

Says blockade to start again if demands not met by today

14-party warns CA

The Awami League (AL) led 14party coalition will resume nonstop blockade across the country tomorrow if President/Chief Adviser Iajuddin Ahmed does not meet by today its 11-point demand.

"If the conspiracy to rig the election continues, our blockade


programme will culminate in a one-point mass movement for the ouster of lajuddin," 14-party Coordinator Abdul Jalil told a press briefing at the AL's Dhanmondi office yesterday.

Earlier on November 15, AL President Sheikh Hasina postponed the blockade, considering public sufferings and the combine's confidence in the talks with

advisers. She gave the chief adviser four more days to prove what she said was his neutrality.

Meanwhile, the 14-party lineup from a rally at city's Muktangan yesterday threatened to lay siege to the Bangabhaban in the event of the president not conceding the demands that the former leader of the opposition submitted on

ROW OVER CTG PORT GANTRY CRANES

Container yard kept besieged for a week

The dockworkers loyal to Chittagong City Mayor Mohiuddin Chowdhury have kept the vital container yard of the Chittagong Port besieged for over a week demanding cancellation of the agreement signed with a private company on the gantry crane operations.

On the other hand, the private company -- Saif Powertec Limited vesterday served a notice against the port authority demanding Tk 10 lakh compensation per day for not allowing them to operate, sources said.

Although the port resumed operation after postponement of political agitation on Wednesday, the dock workers have halted the operation of the four vital cranes at

the container terminal. Consequently, the operation at the premier port is yet to start in full

All of the three berths and four gantry cranes at the Chittagong Container Terminal (CCT) have remained idle since November 12,

Besides, two large vessels anchored at the terminal are incurring loss of \$15,000 each per day due to non-operation of the cranes.

Saif Powertec Limited that had been awarded the task of operating the gantry cranes served a notice against the Chittagong Port Authority (CPA) yesterday demanding compensation of Tk 10 lakh per day for losses due to suspension of operation of the vital

equipment Giving 24 hours time to restore operation of the cranes, the company threatened of legal actions against the CPA.
