### MICROCREDIT 'UN to endorse Halifax **Declaration** BSS, Dhaka

Bangladesh will strive to ensure that the goals of the Microcredit Summit to reach out to 175 million of the world's poorest find a place in the UN General Assembly resolution on microcredit. said Dr Iftekhar Ahmed Chowdhury, ambassador and permanent representative of Bangladesh to the UN.

He was speaking at the plenary of the Microcredit Summit on Friday in Halifax, Canada, according to information received here on Saturday.

The UN General Assembly adopts a resolution on microcredit every year, of which the Bangladesh delegation is a key sponsor. This year the draft will be suitably amended to incorporate the Summit goals, the Ambassador said

Dr Iftekhar praised the work of Nobel laureate Prof Muhammad Yunus for speaking the message of microcredit, not just in Bangladesh, but across the globe.

He said that a nation can only develop when it relies on its own intellectual resources, and the idea of microcredit is such a resource, Bangladesh will actively be involved in the ongoing UN reforms so that "development is placed in the centre-stage of UN activities," he added


A mobile court in separate antiadulteration drives vesterday fined two oil refinery firms over Tk 1 lakh for loading and transporting edible oil in

## LDP showdown in Ctg today

Leaders, activists and supporters of Liberal Democratic Party (LDP) in Chittagong, especially the southern part of the district, are caught in a festive and enthusiastic mood centering the newly formed party's first showdown at Chandanaish upazila this afternoon.

Party insiders and political circles here, however, believe that more wonders are waiting for all in Chittagong and many more aggrieved rank and filers of different units of BNP and its partners of the four-party alliance may formally join LDP at the first public meeting scheduled to be held at 2.00pm today at Gachhbaria College ground.

LDP Executive President Col (retd) Oli Ahmed will address the public rally as the chief guest in front of the people of his own constituency, Chandanaish (Chittagong-13). "Former lawmaker Mahi B

Chowdhury, organising secretary of LDP, and former lawmaker Abdul Karim Abbasi along with other central and local leaders will also join the rally to make it a grand success and showdown as well," said Shahadat Hossain Selim, a central leader and party's Chittagong divisional coordinator, yesterday afternoon. Apreparatory meeting in this regard

was held at its city office yesterday where the leaders, activists and supporters of LDP were instructed to make the rally successful. "We've taken all necessary preparations for the rally," Selim further said.

District police said they will also deploy sufficient forces in and around the rally premises to maintain law and order during the LDP gathering. Sources said LDP would also organise two more showdowns in the following two days. A rally will be held tomorrow at Pativa upazila and another one in the city on Wednesday.

Meanwhile, Chittagong South District unit of BNP has dropped its plan to hold a counter rally at Chandanaish today. Instead they would hold rallies at Patiya and Lohagara upazilas, party sources said.

"We are not holding any public meeting tomorrow at Chandanaish where LDP is scheduled to hold a rally because we decided to avert any unpleasant incident," Ahmad Khalil Khan, unit BNP president, told this correspondent yesterday evening.

## LAUNCH CAPSIZE Three more bodies recovered

Three more bodies have been recovered bringing the total number of death to nine in a launch capsize in Barisal on Wednesday last.

The victims were identified as Fatema Begum, 31, Obaidul Huq, 2, and Maleka Begum, 60, wife, son and mother-in-law of Nurul Islam Khan of Jangalia under Mehendigani upazila.

Earlier, the body of another son of this family Suman, 5, was recovered

Besides, the bodies of other five were identified as Shamsunnahar Begum, 35, wife of Motaleb Gazi, Sima Begum, 20, daughter of Ismail Gazi, Shamsunnahar Pakhi, 30, wife of Malek Farazi of Jangalia, Lily Begum, 45, wife of Latif Sardar of Mehendiganj and Rizia Begum, 35, wife of Abdul Kader of Tungibari.

BIWTA official Saiful Islam and leaders of Barisal Launch Owners Association Sheikh Abdur Rahim and Azizul Hug Akkas handed over Tk 4000 to family members of each victim for transportation and burial of the dead.

The ill-fated launch ML Mehdi-1 with more than 60 passengers on board capsized near Saheber hut Channel of Kirtonkhola River when it was hit by two dredgers Kadam Rasul-3 and Al Kaed at about 3:30pm just after a few minutes of departure from Barisal river port.

At least 10 passengers went missing while others were rescued by launches and speedboats.

The BIWTA vessel Hamza salvaged the launch with six bodies inside the launch on Thursday noon. Police detained the dredgers, but failed to arrest anyone in this con-
