Row Over Ticket from Netrakona-1 Constituency

Seven BNP leaders threaten to join LDP

Seven BNP aspirants for ticket from in Netrakona-1 constituency have united in opposing newcomer Golam Rabbani and threatened to join Liberal Democratic Party (LDP) if he is nominated in the coming

Former Jatiya Party (Ershad) lawmaker Golam Rabbani, who was elected from the constituency (Kalmakanda and Durgapur upazilas) in 1988, joined BNP on November 7 at a function held on

Netrakona Shahid Miner premises. He said he joined BNP with assurance from party high-ups that he would be nominated from Netrakona-

1 in the coming election. His joining triggered protest and resentment by local BNP leaders and dashed hopes of seven party men who vied for four-party alliance

The seven are Durgapur upazila BNP president Hamidur Rahaman Rashed and its former president MA Jinnah, former Kalmakanda upazila BNP president of Muslemuddin Ahmed and its former convenor advocate Abdul Wahab, former Netrakona JCD president Jahangir Alam Masud, Durgapur upazila Juba Dal president Salim Raza and former central JCD leader barrister

They, along with their supporters, brought out a procession at Kalmakanda upazila headquarter Sunday evening against Golam Rabbani and vowed to resist him.

They also asked all BNP leaders and activists in Kalmakanda and Durgapur upazilas not to invite Golam Rabbani to any party activity.

This correspondent talked to all the seven nomination seekers. They said the party high command should evaluate contribution and dedication of party men in giving nomination. They sharply reacted to the reported statement of Rabbani that he joined BNP after assurance of alliance nomination.

Two of the BNP leaders seeking anonymity claimed that all the seven would join LDP if Golam Rabbani gets nomination from Netrakona-1

constituency. They said they have urged BNP chairperson Khaleda Zia to nominate a 'dedicated' party leader from

among them. Earlier, Netrakona BNP president MA Karim Abbasi joined LDP, that triggered mudslinging among BNP leaders in the district.

Talking to this correspondent, Durgapur upazila BNP president Hamidur Rahaman Rashad claimed that failing to get support of BNP

Rabbani joined BNP as a member of its district unit. The district leaders took Rabbani in the party without consulting leaders in the constituency. This proves his ill motive, Rashed alleged.

The seven nomination seekers are now united under the leadership of Kayser Kamal to oppose Rabbani, party sources said.

Abul Khair, former convenor of Kalmakanda upazila BNP, said Golam Rabbani was elected in a farcical election in 1988, which was boycotted by both BNP and Awami

The 4-party alliance will lose the seat if he is nominated, he claimed. Wazed Ali Chashi, former presi-

dent of Kalmakanda upazila BNP, alleged that Golam Rabbani is an illtempered and corrupt man. People will not vote him, he claimed. When contact, Golam Rabbani

refuted the allegation of corruption against him and said, "I joined BNP with blessings of party chairperson Khaleda Zia and secretary general Abdul Mannan Buiyan. They assured me of nomination".

But Kayser Kamal said, "We hope BNP high command will not nominate Rabbani because he is a corrupt unpopular person".

Former Rangpur JP lawmaker faces corruption allegation

False propaganda by rivals for ticket, says Solaiman

Former Jatiya Party (Ershad) lawmaker from Rangpur-5 (Mithapukur upazila) Shah Solaiman Alam faces allegation of involvement in corruption and misappropriation of government project money and food grains.

Allegations have it that his cronies and party men, under his protection, misappropriated about 200 tonnes of rice under Test Relief (TR) and Food for Work Programme in the name of rural infrastructure maintenance in the current fiscal year. They drew project rice by producing fake documents without virtually doing any work, different sources in Mithapukur

alleged.
President and secretary of Noya Para Moktab Moyazzem Hossain and Abdul High alleged that the former MP's men drew one tonne rice to repair the institution's

furniture under TR programme but they came to know it later. The rice was misappropriated by producing fake documents, they claimed. When they came to know it, the former lawmaker through a messenger sent Tk.2200 to them but they refused it.

President and secretary of Rani

Pukur Truck Stand Wazed Ali and Nuruzzaman alleged that the lawmaker's men draw one tonne rice in the name of maintenance of the stand without their knowledge.

They submitted a memorandum to Mithapukur Upzila Nirbahi officer to investigate the matter and take action against the culprits.

The UNO, Nurul Islam, when asked admitted that he received the memorandum. The next UNO would investigate it as he was transferred,

he told this correspondent. Defending himself and the former lawmaker, the UNO said, the administration issued DO letter on October 22 and 23 and project committees might complete works by June 2007.

Joint convener of JP in Mithapukur upazila Saifur Rahman Saleem said, the former MP's men misappropriated money and food grains allotted under TR and Food for Work Programme.

When contacted, Shah Solaiman denied his involvement in the irregularities. "My rivals in the party made this propaganda to tarnish my image", he claimed. A number of JP leaders want party ticket to participate in the coming parliament from the area. He claimed that as the immediate past lawmaker. he would get the party ticket for the coming election.

"They are hatching conspiracy against me", he said.
