### Farmer killed, 2 more abducted for toll

Extortionists killed a farmer and abducted two others in two incidents in Kushtia Tuesday night. The incidents took place at

adjoining Majdiar and Katdah villages in Mirpur upazila. According to police, a gang slaughtered Anwar Hossain, son of Murshid Ali of Majdiar village Tuesday night when he went to see

his paddy field at night. Anwar's elder brother told journalists that the gang had demanded Tk 50,000 from him several days ago. They threatened to damage Anwar's paddy field as

he declined to pay the illegal toll. After the threat, Anwar used to

Police recovered the body and sent it to Kushtia General Hospital. In the other incident, criminals

of the same gang abducted two farmers from Katdah village as they declined to pay Tk 50,000 toll each. The abducted farmers are Jahangir, 30, son of Israt Ali and

Khaksarul 36, son of Mohammad

Family sources of the two abducted farmers said the gang had threatened them with dire consequences several days ago for

not paying toll. On Tuesday night, the gangs attacked their houses and picked up Jahangir and Khaksar, asking

their families to pay the demanded toll within two days to get them

Illegal toll collection by criminals including outlawed party cadres increased in different villages in the district in recent days. The criminals target rich farmers during the current paddy harvest season. Sources in the area said toll realisation in the area during harvest season is not uncommon.

When contacted over cellphone, Mirpur police said they have recorded two cases in connection with the incidents. Police said the farmers did not inform police or record case when criminals demand toll from them.

MURDER OF 8 YEAR-OLD ARNAB

Names of two local BNP leaders, earlier dropped from the charge sheet in child Arnab murder case at home ministry's instruction during BNP-Jamaat government, have been included again.

A trial court in Satkhira on Tuesday asked police to frame charges against all the eight accused including the two BNP leaders--Abdus Sattar and his son Khalilur Rahman of Godara village in Assassuni upazila

The two BNP men also appeared before the court during Tuesday's hearing, court sources

Their names were dropped from the charge sheet following a home ministry order on April 3 this The six other chargesheeted

accused are Mukul, former Champaphool Union Parishad chairman Matiur Rahman, Golam Farooque, Rafiqul Islam, Raihan Ali and Shushil Chowkidar. Eight year-old Arnab Kumar

Das, son of Bimal Krishna Das of Saihati village in Kaligonj upazila was abducted by a group of miscre-ants at about 5-30 pm on June 18, 2000. Villagers recovered the trisected body of Arban from a ditch near his house on June 21. Bimal Kumar Das filed a case

with Kaligonj police station the same day without mentioning name of any accused. The brutal murder sparked violent protests and demonstra-

tions by local people who brought demanding arrest and punishment of the killers.

### 8 cops among 80 hurt as villagers clash

At least 80 people including eight policemen were injured in clashes between rival groups from Majidbari, Fazalganj and Bakai villages in bordering Gournadi and Madaripor districts Tuesday night over a trifle.

Law enforcers from Kalkini police station in Madaripur and Gournadi police station fired at least 11 rubber bullets and used clubs to disperse the clashing groups who torched a shop and looted five others at Fazalganj Bazar and Bakai Bazar.

Among the injured, Gournadi police station Officer-in-Charge Mannan Sarkar and sub-inspectors Yusuf Hossain and Madhusudan along with 20 villagers were admitted to Barisal Sher-e-Bangla Medical College Hospital and Gournadi and Kalkini upazila health complexes. The rest took treatment at local clinics, police

Police and witnesses said a five-

day traditional village fair marking annual nabanno (beginning o paddy harvest) started on Saturday at Bakai village under Khanjapur union in Gournadi, bordering Kalkini upazila in Madaripur dis-

The clashes ensued at the fair from an altercation between two local leaders -- Sohel Sardar of Majid Bari and Sohag Sardar of

The clashes spread to nearby villages when their supporters came to the spot and clashed with lethal weapons, police said.

Gournadi police station OC Mannan Sarkar ran to the spot with a police team. Failing to control the violence, he called police from Kalkini police station in Madariour.

Police from the two police stations controlled the violence in about three hours, police said.

The rival groups were preparing to lodge cases with their concerned police stations, police said yesterday evening.
