# **COLLEGE OF LEATHER TECHNOLOGY Teachers not paid for** 17 months

Academic activities of Bangladesh College of Leather Technology (BCLT), the country's lone institution producing technologists for the leather sector, virtually came to a halt as most of its teachers and staffs are observing work abstention demanding payment of salary arrears

The teachers and staffs started an indefinite work abstention on November 7 as they have not been

paid for the last 17 months Sources said most teachers and staffs were recruited under BCLT Modernisation and Reconstitution Project launched in July 1997, Atotal of 28 teachers are now teaching the core subjects -- leather technology, footwear technology and leather products technology. And the number of staffs appointed under the project is 60.

Nine of the teachers have already left the institution and went abroad

The 28 teachers and 60 staffs are deprived of their salary as they were not brought under the revenue sector after the tenure of the project ended in July 2005.

According to a Statutory Regulatory Order issued by the aovernment in 2005, the employees working under the projects launched after June 30, 1997 would not be automatically shifted to the revenue sector.

Considering the importance of the contribution of such institutions to the booming leather industry, which had a growth rate of 23 percent in 2004-05 fiscal, the government decided to set up leather technology departments in four public universities but did not give proper attention to the BCLT issue.



From the very first day in office. Justice Mahfuz had openly sided with CEC Aziz and termed the HC directive "unlawful" and "beyond its iurisdiction"

"It is not a High Court directive. It is its certain observations. It is absolutely [self-] contradictory and beyond its jurisdiction," Mahfuz had told the press.

"If the High Court had issued a rule and if that rule became absolute, then it could be called a directive," he argued, adding that only then it would become mandatory for the EC to comply with it. "Since the judgment is not lawful, the question of compliance does not arise," he







### Justice Mahfuz makes himself acting CEC

meeting at 11:00am to authorise himself as the acting CEC.

Sources said no EC Secretariat officials, except the EC secretary knew anything about the meeting presided over by Mahfuz. The meeting was not convened

officially following the procedure, they said.

Election Commissioner SM Zakaria proposed the name of Justice Mahfuz being the senior most in the EC to act as the CEC while Election Commissioner Mahmud Hasan Mansur seconded the proposal, meeting sources said.

Upon receiving the information from the media yesterday afternoon, a number of advisers to the caretaker government expressed their surprise as they did not know anything about the development.

Talking to The Daily Star, former CEC Abu Hena said the CEC, being the chairman of the EC, is authorised to convene EC meetings. But in a normal situation, election commissioners can convene a meeting in absence of the CEC to carry out EC activities. but the prevailing situation is not normal. he said.

"In such an extraordinary situation, the president will decide who will act as the CEC or the president may ask the commissioners to sit in a meeting to decide who will discharge as the acting CEC," Abu Hena said, describing the present situation as very complicated.

Asked to comment on the present situation following Aziz's going

on leave without authorising any member to act as the CEC, former CEC Justice Abdur Rouf referred to article 118(5) of the constitution.

"Subject to the provision of any law made by Parliament, the conditions of service of Election Commissioners shall be such as the President may, by order, determine," says the constitution.

Referring to the High Court (HC) udgment on voter list on January 4 this year, a senior official of the EC Secretariat said the court also referred to the jurisdiction of the CEC to convene the meeting of the

EC. The HC said the EC is a composite body and it must function institutionally and not individually. The CEC should immediately call a meeting of the commission and the was correct. At that time, CEC Aziz, who had been absent from the office for 11 days since the delivery of the judgment, did not convene any meeting for the next 15 days to implement the HC judgment to update the voter

The then two election commissioners M Munsef Ali and AK Mohammad Ali repeatedly tried to communicate with Aziz for holding a meeting, but they could not hold any EC meeting despite being the maiority in the EC.

Zakaria and Mahmud Hasan Mansur--on Wednesday claimed that they did not know why the CEC was absent from the office that day.


