Parties challenge in court president's becoming CA

Two more writ petitions filed on CA's executive power exercise, move to declare poll schedule before finalising voter list

Besides their street agitations over the issues of chief adviser's appointment and authority and the Election Commission (EC), a number of political parties yesterday joined the Awami League (AL) led 14-party alliance in a legal battle against the caretaker government chief and the EC.

Eleven leaders of the 14-party alliance, Jatiya Party (JP), Liberal Democratic Party (LDP), Zacar Party--a faction of Islami Oikya Jote (IOJ), and Islamic Front jointly filed three writ petitions in the High Court against the president's assumption of the post of chief adviser, his manner of exercising executive power, and the EC move to declare election schedule before

finalising the voter list.

The High Court is likely to hear the petitions today.

In a late-night development, President/Chief Adviser Iajuddin Ahmed called Attorney General AJ Mohammad Ali to the Bangabhaban to brief him (president) on the implications of the petitions

Coming out of the Bangabhaban at around 11:40pm, the attorney general declined to speak to the journalists waiting outside.

In one petition, the petitioners asked for court direction to Chief Adviser lajuddin Ahmed to hand over the office of the chief adviser to a person who is competent, qualified, eligible, available and entitled to claim the valid legal title to such public office."

CG should take collective decision

Says Adviser Akbar

Finance Adviser Akbar Ali Khan yesterday said the caretaker government should take collective decisions to keep the president's office above all controversies.

The adviser said the president is the highest post of the state. "So we (the advisers) want to keep him (the president) above all disputes, Akbar said during his first meet with reporters after he, along with four other advisers, refrained from attending their offices on Thursday -- allegedly protesting the chief adviser's unilateral decision on different issues.

He said the president would be above controversies if the caretaker government took collective decisions on different issues and, only then, the caretaker government would face all the criticism.

Akbar said they (the advisers) came to power only for three months and that is why they are not afraid of being disputed, but the SEE PAGE 15 COL 5

Before and after the announcement of the election schedule people applying for being registered as voters will have to submit receipts of municipal tax payment or house rent or payment to local guards, and affidavits of age or attested copies of SSC certificates with their applications on prescribed forms.

Regarding deletion of names from the voter list, people will also have to apply on prescribed forms to district or upazila election officers.

To update the existing voter list in last July, the EC failed to get response from the people as it did not send its staff to door to door visits for getting the job done. In the face of severe criticism, the EC finally sent its staff to door to door visits, but in absence of a procedure for checking the authenticity

14-party asks Iajuddin

A 14-party delegation met President and Chief Adviser (CA) of the caretaker government (CG) lajuddin Ahmed yesterday and told him that announcement of schedules for next general election would not be acceptable before reconstitution of Election Commission (EC) and correction of the updated

Removal of acting Chief Election Commissioner (CEC) Justice Mahfuzur Rahman and Election Commissioner SM Zakaria must be done before reconstitution of the EC, the delegation told the CA

The three-member delegation

comprising Abdul Jalil, barrister Rokanuddin Mahmud and M Mokammel Haque also asked the CA to meet their 11-point demand before announcing the schedules.

"We have told the chief adviser that there are several rules before announcement of polls schedules. The primary voter list will have to be made open for people. It will have to be corrected if there is any bjection. Then it should go for printing and be published before announcement of the schedules, 14-party coordinator Abdul Jalil told a press briefing at AL's Dhanmondi office in the capital.

Jalil told Iajuddin that the announcement of schedules would

Reconstitute EC, then Bangabhaban sit-in today

declare polls schedule Demand for voter list correction, neutral admin, EC reconstitution

The 14-party alliance, its likeminded political parties and alliances will stage a sit-in around the Bangabhaban today demanding depoliticisation of the administration, "meaningful" reconstitution of the Election Commission (EC) and corrections of the updated voter list.

They also demand resignation of Chief Adviser (CA) to the Caretaker Government (CG) Prof lajuddin Ahmed from the post as he "failed to play a neutral role."

The 14-party alliance vesterday fixed 10 spots in the capital from which they would start for the sit-in programme around Bangabhaban.

Meanwhile, Dhaka Metropolitan Police (DMP) under its Ordinance

"to ensure security and protect government and public property" imposed a ban on staging sit-ins around Bangabhaban and laying siege to it from midnight today.

Jatiya Oikya Front, Jatiya Party (Ershad) and a number of Islamic political parties will hold simultaneous programmes with the Awami League-led 14-party alliance's programme to press home their common demands.

The alliance and other political parties would also stage similar sitin programmes around the EC Secretariat tomorrow demanding the same.

Postponing the non-stop blockade on November 23, the Awami League (AL) President Sheikh Hasina had declared the sit-in

demonstration from 10:00am to 2:00pm in order to realise their 11

Hasina said the CA failed to perform his duties neutrally, adding, "He should step down from the post of CA and appoint a nonpartisan person as the CA as per the constitution to hold a free and fair

After the chief election commissioner (CEC) went on a threemonth leave on Wednesday, the AL now focuses on their demands for removal of the two other controver sial election commissioners Mahfuzur Rahman and SM Zakaria

Blasting her political opponents, the former prime minister said, 'Awami League (AL) has not only failed to lead the country, but also mastered the art of destroying it."

"They could not have had enforced programmes like the blockade if they loved the country," she said adding that AL destroyed the country while they were in power and even now, they plan to destroy the nation's future generations by creating anarchy in the education sector.

Advisers find post of acting CEC unconstitutional two more election commissioners

With the controversy over assumption of the post of acting chief election commissioner (CEC) by Justice Mahfuzur Rahman mounting, President lajuddin Ahmed has yet to appoint the two new election commissioners that he earlier

decided to do on November 22. The Election Commission (EC) led by Justice Mahfuzur Rahman, who authorised himself as the acting CEC on last Thursday by convening a commission meeting, is now planning to announce the election schedule this week, triggering a fresh spell of controversy even in absence of rather infamous CECMA Aziz. Secretary to the EC Secretariat

Abdur Rashid Sarkar last night called on President/Chief Adviser Iajuddin Ahmed at the Bangabhaban.

The president wanted to know from him the EC's preparations for the upcoming election. The EC secretary told Iajuddin that immediate appointment of two more commissioners will help the commission gear up better for the polls, said Bangabhaban sources.

The president on November 18 first disclosed his desire to appoint

and again on November 22, following Aziz's announcement of taking a leave of absence, he informed the nation through a speech that he had decided to appoint two more election commissioners. But no new election commissioner has been appointed yet

since his address to the nation and questions are being raised even in the EC Secretariat about the delay. It has been a mystery why the president is delaying the appointment of two more election
