Saarc agriculture ministers' meet 12

Bss, Dhaka

Saarc ministerial meeting on agriculture and food will be held in Islamabad on December 14.

Senior officials meeting on December 12 and 13 will be followed by ministerial meeting, official sources said. CM Shafi Sami, Adviser,

Ministry of Agriculture, will represent Bangladesh at the ministerial

The agendas of the meeting include review of activities of the Saarc technical committee on agriculture and rural development, review of activities of Saarc Agriculture Information Centre (SAIC) and its expansion taking into consideration the changing nature and scope of agriculture and the emerging challenges in South Asian agriculture, sources said.

Saarc Food Security Reserve, launched in 1987 in the third Saarc Summit to maintain storage of food grains for meeting emergency in member states, will also be discussed at the Islamabad meeting, the sources said. Since the inception of Saarc Food Security Reserve, it experienced nindrances which made it almost non-attractive to member states, sources added.

The 13th Saarc Summit in Dhaka gave new guidelines to revamp this mechanism. The Saarc secretariat has revised a concept paper for establishment of food bank instead of food reserve.

The Islamabad meeting is expected to give practical solutions to some of the difficulties. the sources said, adding that once the solutions get the nod, an inter-governmental expert body will finalise agreement on operation of the food bank.

2 brothers get life for killing boy in Ctg

A court in Chittagong yesterday sentenced two brothers to life imprisonment for killing a teenage boy in the city in 2001.

Third Additional Metropolitan Sessions Judge Md Ekramul Haq also fined the convicts -- Korban Ali 23, and Rehan Ali, 21, -- Tk 50,000

The court, however, acquitted Lal Mia, father of the convicts, sources said.

According to the prosecution, Korban and Rehan had a quarrel with Md Imran, 17, of their locality over a trifle matter at Roufabad under Bayezid Police Station on December 11, 2001, At night, the two brothers called Imran out of his house, beat him up and then strangled him

The charge sheet of the case was submitted on May 21 in 2002 and charges were framed against the two brothers and their father on August 2, 2003.

The court handed down the verdict after examining 12 witnesses, the sources added.
