"If a new government (Palestinian) comes about and commits to the principles of the quartet, which will make the roadmap work, which will release Gilad Shalit, I propose ar immediate meeting with Abu Mazer to engage in open, sincere and

serious dialogue," said Olmert. "In that framework and in keeping with the roadmap you could create an independent and viable Palestinian state with territory in Judea and Samaria (the West Bank), a state with total sovereignty with defined

borders," he said.

The premier reiterated that Israel was prepared to release a considerable number of Palestinian prisoners in exchange for Shalit, and unblock funds that were frozen after the radical Hamas won a landslide election in January.

"In exchange for Gilad Shalit, Israel is ready to release many Palestinian prisoners, including some who have been sentenced heavily," he said.

"We will also unblock the funds that we have frozen," said the premier, referring to customs duties collected on behalf of the Palestinian Authority that the World Bank has estimated at 65 million dollars per month in 2005.

The Hamas-led Palestinian government has been boycotted by Israel and the West because of its refusal to recognise the Jewish state's right to exist, formally renounce violence and abide by past

peace agreements As a result Palestinians are battling with the worst economic and political crisis since the Palestinian Authority was established in 1994.



India tests its first missile interception device

Two nuclear-capable ballistic missiles collided in mid-air off India's eastern coast vesterday in a successful test of an interception programme, a top scientist said.

The test saw a surface-to-surface Prithvi-II (earth) missile shot down over the Bay of Bengal by a similar missile fired seconds later. The collision of the two Prithvi-II

missiles occurred over the Bay of Bengal on Monday.

The weapons were fired from the country's Chandipur-on-Sea and Wheeler Islands testing sites respectively, about 45 nautical miles (83 kilometres) apart, an officer with the Defence Research and Development Organisation, which conducted the test, said on condition of anonymity. "The two missiles had a flight

duration of six minutes before they blew up into a ball of fire over the sea after hitting each other," the defence scientist, who did not want to be identified, told Reuters by phone. "It was successful. The test was done to observe the

accuracy and operational effectiveness of short-range Prithvi missiles in providing an air-shield to Indian cities from neighbours Pakistan and China, both of which have arsenals of ballistic

The Prithvi-II missile, which is capable of carrying conventional or nuclear warheads, was last tested on November 19. It has a range of up to 250 kilometers (156 miles). Prior to the test, local authorities

Of the 480 UNOs, 100 have been appointed by the caretaker government while the remainder have been serving since the time of the BNP government.

The jobs of the ROs and AROs are placed under the EC with effect from yesterday, and from now on, the interim government will not be able to transfer them without approval of the commission.

The Russian-built Ilvushin plane was carrying 284 elite Revolutionary Guards and 18 crew on a flight from the southeastern town of Zahedan when it came down near the southern city of Kerman.

Iran's civil and military fleet is made up of ancient aircraft in terrible condition due to their age and lack of maintenance. The Iranian regime is barred by sanctions from buying American Boeing planes or European Airbus craft when they include a significant number of US parts.
