The District Sessions Judge here vesterday showcaused four investigation officers (IO) of five cases in connection with countrywide series of bomb attacks on August 17 last year for dillydallying and taking excessive time in submitting the charge sheets

The IOs are Himangshu Kumar Dipak Chandra Majumder Mohammad Abdur Rahim and Ratan Kumar Nath

Judge AKM Anwar Hossain asked the four IOs to appear in person before the court on December 8 to respond why legal actions would not be taken against them for dillydallying and killing time in completing the investigations of the cases and submitting the charge sheets.


He also ordered the four cops for submitting the charge sheets within one month

Court sources said the four IOs took time for eight times in a year to finish the investigations. On October 27 this year, they took another one-month time from the court to submit the charge sheets.

# President's action adds fuel to the fire

new election commissioners have disturbed us fundamentally. It boggles our mind as to how a responsible man could have acted so very irresponsibly. Just when with Aziz's departure from the scene, all thought that some sort of a solution could be hoped for, Prof. lajuddin literally poured water on it and has pushed the country towards a severe political conflict. Suddenly, he has transformed himself from a problem solver to a problem creator. When the members of his advisory

council suggested that they discuss the possible names for the two new EC members, the President reportedly replied: "Trust me. I will propose such names that both parties will happily accept them. I will definitely propose names that are unquestionably acceptable to both sides and to all of you"

After a week of his address to the nation, when he first revealed his intention to appoint two new EC members, he gave oath of office last Sunday to Mr. Modabbir Hossain Chowdhury, a former IGP, and Saiful Alam, a former judge of our lower judiciary and former director general of the now defunct Anti-corruption Bureau. Unfortunately, both these appointments have greatly disappointed the nation, not only because far more competent and acceptable (to both sides) people were available but also because they are both embroiled in controversies of very serious nature. It is shocking and shameful that the President/CA should pick a person who for the last one year has been working in his constituency for BNP nomination. He made numerous statements to the press (see our vesterday's story) in which he said on record to have been

working to get BNP nomination for the

serious allegations of collaboration against him during our Liberation War. The political link of the other appointee, Saiful Islam, is allegedly with Jamaat. More to the point, his reputation as the DG of the Anticorruption Bureau is neither immaculate nor above question. A simple investigation by any of the intelligence agencies will bring out the true picture. Neither of these appointments has added to the image of the EC as a body that the public can put their complete trust on to conduct a free and fair election

So why did the President go for such appointments when we are already mired in suspicion, conflict and uncertainty? Are they the best examples that the President could find of people who would be "happily accepted" by both sides. The President had asked his council of advisors to have trust in him, but he has not been lived up to it by any stretch of imagination.

While the gazette notification of the two appointments was already out in the morning, he still refused to share with his cabinet colleagues the news of the decision that he took the night before. This caused the spokesman for the council of advisers, Mahbubul Alam, to tell the media in the afternoon following the meeting that he or other advisers knew nothing about the appointments.

It is one thing to keep the advisers out of the decision making process, but it is quite another to deny them the courtesy of informing them when so many officials already knew it. What does it say about the prestige of the advisers, the level of confidence between the chief adviser and other advisers, and finally about the working method of the chief adviser? Well, his working method can at best be described as opaque and at worst as

We have never understood his attitude towards his advisers. From the very inception of this caretaker government the chief adviser has been far from forthcoming with the group that he himself invited to become his advisers. It can be said without fear of exaggeration that in no important election related decision were the cabinet colleagues taken into confidence. None of the transfers that took place were their work. Contrarily, the transfers that the advisers did suggest have not been

His last address to the nation, which was recorded and delivered again without informing the advisers. resulted in five of them suddenly falling "sick" and two others attending office only for a while. The President/CA is reported to have said "sorry" thrice to the advisers' group and then repeated the same to them individually. That was a good gesture and the advisers were right to put everything behind them. But with the declaration of the election schedule and the two appointments to the EC, both without informing the advisers, we are forced to conclude that the "sorry" really meant 'I will continue

In its place we now have a near complete uncertainty with politics becoming more and more confrontational and the people less secure of their immediate future. The damage to the economy, which we have highlighted several

times before, is about to intensify with the threat of renewed blockade. This 'cost to the economy' the country cannot bear much more of. Some solution will have to be found. As we mentioned above, one was probably at hand but the President blew it. But whv?

We are near the point when we will have to directly and unequivocally put the blames for the latest political crisis on the President's doorstep. We will have to then conclude that he will not provide us the solution that we need and deserve, that instead of being the problem solver he has become the problem creator. That will be a most tragic conclusion, as Prof. lajuddin remains the last symbol of our troubled democracy. But if he himself is on a self destructive course to destrov that symbol then what can we, the ordinary people or the media, do except to hope that he would wake up

to the consequences of his action. We had earlier asked the question: whether he will Serve the nation or his Benefactors?" It appears he is bent on the latter even if it destroys the former. How sad!
