International Notice Inviting Offer for Operation, Maintenance & Management of Cargo Complex (Import & Export) of Zia International Airport

Under the policy of the Government of Bangladesh (GOB) to bring in Private Sector Operator for Airport Cargo Terminal Operation, Civil Aviation Authority of Bangladesh (CAAB) has decided to contract out the operation, maintenance and management of Cargo Terminal Building of Zia International Airport initially on a 10 years lease term. All operational activities of Cargo Complex will be outsourced through a proposed Management Contract. Intending Airport Cargo Terminal Operators with reasonable experience in the relevant field may submit their Technical & Financial offer in a sealed envelope in the bidding process of international competitive bidding.

Airport Cargo Operators from all countries are invited to tender with the exception of all countries that are members of SAARC. In case of consortia/bid with local organisation, the experience of local agent/partner/associate in cargo related function including freight forwarding, rule & regulation of local taxes, VAT etc. shall have to be submitted along with the offer. Expatriates should be kept in minimum number (2-4).

The technical offer should contain organisational profile, past five years and current experience as an International Airport Cargo Terminal Operator of at least 3 international airport, audited balance sheet for at least past 3 (three) years, CV of key professionals/specialists currently in employment, an outline of methodology to be employed to perform the functions required by CAAB.

The Cargo Complex operation consists of Export and Import Cargo handling, Cargo Complex Building & overall security and up-keep of the cargo building and structures. Technical bids must include an earnest money of US\$ 25,000 (twenty-five thousand) or equivalent amount in Bangladesh Taka in the form of Pay Order or Bank Draft drawn in any scheduled bank operating in Bangladesh.

The tender documents are available in the office of the undersigned upto 14-01-07 at 12:00noon against US\$ 500 or equivalent amount in Bangladesh Taka in cash or in the form of a Pay Order or a Bank Draft (non-refundable) in favour of Civil Aviation Authority of Bangladesh for each set during office hours.

Tenders will be opened on 17-01-07 at 10:00am (in presence of tenderers or their authorised representative if any) in the Conference Room of CAAB.
